Also, Mayor Mironov stated a tax report was received from the Tax Collector, a letter from the Department of Transportation dated October 31, 2018, a letter dated August 30 on the local freight impact program for Milfred Road, a similar letter on Wyckoff Mills Road, and a September 6 letter from Mercer County regarding the Wastewater Management Plan.

Mayor Mironov requested that the Chief of Police follow-up with the July 23 letter that the Council sent to Department of Transportation on conditions at the One Mile Road access to Route 133. Mayor Mironov requested the status of the engineering work on the Old Cranbury Road and Oak Creek Road Projects. She further requested all information on the projects so the Township can go out to bid. She requested information on the Windsor Center Drive street lights and electric sign. She also requested specific information from the Manager's Office on Robbinsville regarding the Hankins/Route 130 project. Mayor Mironov provided photos of the Anker Park pathway on the Hickory Corner Road side to see what the options are to address issues there. The bridge behind the library is missing a few boards leading to the pathway and requested that be looked into. Mayor Mironov requested a timeline on the Energy Aggregation program information. Council Member Peter Yeager stated that East Windsor was just awarded Silver Level status for Sustainable New Jersey.

Mayor Mironov stated a letter was provided to state and county election officials regarding several disruptions to local voters during elections that the town was not even notified of, one of which was moving many voters living in the senior campus of Meadow Lakes from their current polling place at Meadow Lakes.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Municipal Roadway Projects

Mayor Mironov stated in Council folders is a letter stating the state grant application deadline has been extended to October 18, 2018. Mayor Mironov also provided additional information on Dutch Neck Road stating that part of the roadway on the east side of Route 130 is in Hightstown and the application to be submitted addresses that point, noting that the remainder will be done at a later time. She also stated she has the county looking into it as a possible cooperative project. Mayor Mironov stated there are two options, for the second application, the first being Oak Branch Road with a portion of Rocky Brook Road or all of Rocky Brook Road. The application has to be submitted to the state and satisfy their standards and has to be useful to the town.

Mayor Mironov requested that Council look at the municipal roads of Oak Branch, Cypress Drive, Exeter, Berkshire, Stanford and Charred Oak for consideration and vote at the next meeting.

2. Windsor Center Roadway Paving Project

Department of Public Works provided no information on this project in over a year. A report is required and needs to be listed on the next agenda.

3. FY 2020 Mercer County Planning Incentive Grant Application (Farmland Preservation Plan)

Council received a memo from the Assistant Manager in response to Mercer County's plan. Council is interested in moving forward with Mercer County's plan for the farmland preservation. Mayor Mironov requested that the properties from the previous meeting be reviewed for possible additions to the list. Council Members agreed.

4. Second Round of "Mercer at Play" Grant Program

Council received a memo from Mayor Mironov stating funds are available for municipal government. Under the program East Windsor would be allocated \$500,000 and Highstown would be allocated \$300,000 but if the towns collaborate the amount increases from \$800,000 to \$1,000,000 with the match reduced from 100% to 50% if the towns collaborate. The Township met with Highstown on two occasions and they are looking to collaborate. Possible project ideas include an expansion of the senior center, Anker Park tot lot and the duck pond or the rehabilitation of the pathway on the Hickory Corner side. Hightstown is looking to refurbish Dawes Park by adding a skate park and improved basketball court area. East Windsor would be the lead agency and provide the plan and application enhancing the two towns. Council Members expressed positive comments toward these projects. A resolution needs to be listed on the next agenda.

5. East Windsor Master Plan Reexamination Report

East Windsor is in need of their 10 year reexamination and is perfect timing since there are areas in need of review.
