**WHEREAS,** the County of Mercer OEM has oversight of the reverse 911 systems utilized within Mercer County; and

**WHEREAS,** the County of Mercer has entered into a contractual agreement with Swiftreach Networks, Inc. to provide "Swift911" reverse 911 communications systems for all entities within Mercer County; and

**WHEREAS,** the "Swift911" system is available to all residents within Mercer County seeking to receive reverse 911 messages on their cell phones by signing up on the Mercer County OEM website; and

**WHEREAS,** the County of Mercer offers an option for entities to participate into a shared services agreement, at no cost, to enable the transmission of authorized public service announcements and mass emergency notifications through the "SwiftReach" System; and

**WHEREAS,** the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq. authorizes any municipality to enter into a contract with any other municipality or county, for the joint provision of any service which either party is empowered to render within its own jurisdiction; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act authorizes the approval of Shared Service Agreements by Resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Mayor and Municipal Clerk are hereby authorized to execute the attached Shared Services Agreement entitled "Shared Services Agreement between County of Mercer and East Windsor Township; "Swiftreach" System" to provide public service announcements and emergency notifications for East Windsor residents, for a three (3) year term commencing January 1, 2019 through December 31, 2021, subject to the terms and conditions contained therein.

4. Interlocal Services Agreement for Animal Control Services with Robbinsville Township, Plainsboro Township and West Windsor Township

Mayor Mironov stated the two year agreements are expiring soon. Mayor and Council reviewed the recommendation memo that was provided by the Chief of Police with the monies outlined and agreements for the Interlocal Animal Control Services with Robbinsville, West Windsor and Plainsboro. The Chief of Police submitted letters of interest to the three municipalities. Robbinsville has responded and is interested in continuing with Interlocal animal control services. The Township is still waiting to hear back from Plainsboro and West Windsor with their interest.

5. East Windsor Township Economic Development Committee "Gateway to East Windsor" Art Installation Proposal

Materials from the Economic Development Committee were provided to Mayor and Council regarding the triangular two acre piece of property owned by the Township at the convergence of Route 130 and Route 33. The Economic Development Committee is looking to put a piece of art on this piece of land and they are looking for recommendations for donations or loans for an art exhibit. Council Member Denise Daniels suggested that the EDC reach out to Grounds for Sculpture regarding costs. Mayor Mironov stated she did speak with them but the cost was well above the budget. Council Member Daniels also suggested reaching out to the Mayor of West Windsor for further suggestions since he is involved with the Grounds for Sculpture. Mayor Mironov suggested that the EDC provide Council with a list of who they will be sending the proposal out to for donations and loans.

## 6. 2019 Independence Day Celebration

A memo was provided to Mayor and Council for the 2019 Independence Day Celebration suggested dates. Mayor and Council were unanimous with the July 6 date for the Independence Day celebration with a rain date of July 13, 2019.

## 7. JCP&L Dead Tree Program- Township Plan

Mayor Mironov stated there are a lot of dead and damaged/sick trees in the Township in the area of utility wires. A meeting was held with JCP&L and the Township Manager regarding a plan to remove the trees. JCP&L is going to reach out to their forestry department then provide East Windsor with the specific trees and dates for the removal of the trees. Mayor Mironov had suggested reaching out to the former Public Works Director for direction on handling dead trees

and stumps in the most cost effective way. Township Manager, Richard Brand spoke with the former Public Works Director and he recommended a few places the Township could temporarily dispose of the trees. The Township Manager will be providing a plan to Mayor and Council in the next few days with a plan for the removal of the trees, resident notification and JCP&L dates.

### 8. Open Space Acquisitions Proposed Projects

Mayor Mironov stated she was supposed to have information on this over a week ago from the Assistant Manager but has not received anything as of yet. Mayor Mironov stated the information needs to be provided by November 21 to Mayor and Council.
