#### **SECTION 3. LONGEVITY**

Employees hired on or after September 1, 2014 shall not be eligible for longevity benefit payments.

## **SECTION 4. GENERAL**

Employees shall be compensated according to the 40 – hour work week.

Except as otherwise provided, rates of compensation provided herein are in effect

retroactive to January 1, 2016.

#### **SECTION 7.**

Ordinance 2018-03 An Ordinance to Exceed the Municipal Budget Appropriation Limits to Establish a Cap Bank

ORDINANCE NO. 2018-03 TOWNSHIP OF EAST WINDSOR MERCER COUNTY, NEW JERSEY

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

**WHEREAS**, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

**WHEREAS**, the Township Council of the Township of East Windsor in the County of Mercer finds it advisable to permit an increase of its CY 2018 budget by up to 3.5%, if necessary, over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Council hereby determines that a an increase of up to 1.0 % increase in the budget for said year, amounting to \$188,038.98 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

**WHEREAS,** the Township Council hereby determines that any amount authorized herein that is not appropriated as part of the final CY 2018 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

Ι

1. In the CY 2018 budget year, the final appropriations of the Township of East Windsor shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$658,136.43 and that the CY 2018 municipal budget for the Township of East Windsor be approved and adopted in accordance with this ordinance; and,

- 2. Any amount authorized herein that is not appropriated as part of the final CY 2018 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.
- 3. A certified copy of this ordinance as introduced shall be filed with the Director of the Division of Local Government Services within 5 days of introduction.
- 4. A certified copy of this ordinance upon adoption, with the recorded vote included thereon, shall be filed with said Director within 5 days after such adoption.

#### II

#### REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

#### Ш

#### **SEVERABILITY**

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

#### IV

#### **EFFECTIVE DATE**

This ordinance shall take effect twenty (20) days after the final passage and publication as required by law.

### **Resolution R2018-055** Introduction of the 2018 Municipal Budget

It was MOVED by Lippman, SECONDED by Zoller to approve the Introduction of the 2018 Municipal Budget and set public hearing for May 8, 2018.

Mayor Mironov stated the 2018 Municipal Budget, for the sixth consecutive year, has no tax increase. The 2018 budget appropriations are \$22,455,510 and is just under 2% of the 2017 budget and the tax rate will remain at \$.43 per \$100 assessed valuation based on the 2018 valuation. The average residential property tax in East Windsor Township for the municipal portion will remain at \$1,121. Mayor Mironov stated the budget document is very conservative and responsible while providing high quality services for residents and maintaining no tax increase due to a number of factors. The staff and the elected officials take the responsibility of budgeting and spending very seriously and approach budgeting very conservatively, always thinking of the taxpayers and providing the necessary services. Those expenditures are monitored throughout the year. Mayor Mironov continued we work very hard in East Windsor and are very proactive with businesses in the community and a reflection of that is the 2018 tax base reflects an increase of almost \$54 million over 2017. Mayor Mironov also stated that the Township carefully spends every dollar in our budget and the 2018 budget is well under the tax levy cap. Mayor Mironov stated if the tax levy cap and the cap banks were utilized, we could increase the municipal tax rate by almost \$.08, although we are not. All this shows a great deal of discipline and sensitivity to our residents and how the budgeting responsibilities are handled. Mayor Mironov thanked all the Council Members for the work during the workshop sessions and the Finance Director Laurie Finger for doing a tremendous job in preparing the budget and supporting information throughout the year.

Mayor Mironov stated a \$6,600 grant was received for this program and she is in support of the campaign.

## 4. Operation Medicine Cabinet

Mayor Mironov and Council Members are in support of the event sponsored by the New Jersey Division of the U.S. Drug Enforcement Administration (DEA) set for April 28, from 10 am to 2 pm. Council Member Yeager stated this is a great way to get residents to the Township to drop off unwanted medicines and also make them aware of our permanent drop box that is available 24 hours a day, 7 days a week at the Police/Court building.

## 5. Police/Court Building Roof and Professional Report Updates and Status

Mayor Mironov stated she did not understand the cost of the repairs to the surveillance camera and how does the Township have a guarantee that they are taking care of the bill. Ray Wheaton, Director of Public Works, stated he received verbal authorization but will reach out tomorrow to get written authorization

## 6. Municipal Building HVAC Status and Professional Report Updates and Status

Mayor Mironov stated there is a lot of updated information provided in Council's folders regarding the work being done. Mayor Mironov stated that Envirocon was going to be on site this coming week and she would be looking for an update once complete. Also she is looking for written authorization on the warranty and the expiration date. Lastly, the report should be provided to Mayor and Council with all outstanding items at this point. Mayor asked the Director of Public Works about the controls and what is the functionality and how is the temperature being controlled. Ray Wheaton, Director of Public Works, stated the switchover will be done soon by the contractor. Richard Brand stated he would further explain that the controller is touch screen and the unit must be purchased separately due to issues between the provider and the contractor. The contractor must do training to have the air handler working properly and efficiently and provide the Township with a letter.
