An Ordinance Amending Chapter XX, Zoning, for Creation of a New Zoning District Titled AH-1 Affordable Housing District to Facilitate Development of an Inclusionary Affordable Housing Development at the Property Located at 641 North Main Street, (Block 11.01, Lot 5), of the Revised General Ordinances of the Township of East Windsor

Mayor Mironov stated Ordinance 2018-07 relates to the Blackpoint development which is part of the Affordable Housing plan. Mayor Mironov stated there were two meetings with them, at which the Mayor suggested they present a concept plan to the Planning Board. Blackpoint came before the board but did not have the information the town was requesting. Due to the court order, East Windsor created and introduced an Ordinance, Blackpoint did not like the Ordinance. Mayor Mironov stated that the court process suggested that the Township and Blackpoint and all professionals have a meeting to discuss what the plan is Blackpoint is seeking to provide. The meeting is scheduled for August 6, so the Ordinance is not able to be adopted until September or October. Mayor Mironov suggested carrying Ordinance 2018-07 since the new scheduling has not yet been received.

It was MOVED by Rosenberg, SECONDED by Lippman to carry Ordinance 2018-07 to the August 7, 2018 Council meeting.

AN ORDINANCE TO AUTHORIZE ACCEPTANCE OF DEEDS FOR DONATION OF BLOCK 47.12, LOT 4 AND BLOCK 47.12, LOT 21

FROM PULTE HOMES NJ, LIMITED PARTNERSHIP (AIRPORT ROAD)

WHEREAS, Pulte Homes of NJ, Limited Partnership is the owner of lands designated on the East Windsor Township Tax Maps as Block 47.12, Lot 4, consisting of approximately 3.05 acres and including the retention basin for the Windsor Cove residential subdivision, and Block 42.12, Lot 21, consisting of approximately 4.2 acres of open space within the Windsor Cove residential subdivision; and

WHEREAS, under the terms of the Developer's Agreement for Windsor Cove, these lands were to be conveyed to the Township upon completion of the subdivision; and

WHEREAS, The Township Council has determined that it is the best interest of the Township to accept the donation of Block 47.12, Lot 4 and Block 47.12, Lot 21 from Pulte Homes of NJ, Limited Partnership.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey as follows:

I

- 1. The Municipal Clerk, Township Manager and Township Attorney are hereby authorized and directed to take all necessary action to accept and record a deed from Pulte Homes of NJ, Limited Partnership, in the form attached hereto, for the land designated on the East Windsor Township Tax Maps as Block 47.12, Lot 4.
- **2.** The Municipal Clerk, Township Manager and Township Attorney are hereby authorized and directed to take all necessary action to accept and record a deed from Pulte Homes of NJ, Limited Partnership, in the form attached hereto, for the land designated on the East Windsor Township Tax Maps as Block 47.12, Lot 21.

II REPEAL

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

WHEREAS, the Township Engineer has inspected the site work for The Woods at East Windsor and filed a written report with the Township Council dated June 11, 2018, which is attached hereto and made a part of this Resolution; and

APPROVAL OF BILLS:

Mayor Mironov stated a 2018 Current Bill list, 2017 Current Bill list, Affordable Housing Bill List and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov requested clarification. Also, Deputy Mayor Zoller questioned on the Current 2018 bill list, page 17 if the organization is accurate.

Mayor Mironov questioned if on the Current 2018 bill list, page 7, if the clothing item is day to day items or if it should be charged to Operating, Capital or some other type account.

Mayor Mironov stated the August 7 Council meeting is also National Night Out and Mayor and Council agreed to move the meeting time to 8:00 p.m. A report was received from the Tax Collector for the period ending June 30, 2018. A memo was received from the Manager regarding the bills list questions from the June 10 Council meeting. Mayor Mironov also provided to Council the communication from Mr. O'Connor. A July 17 memo was received on asphalt purchases, which at this point the Mayor had no further objections. The next Child Safety Passenger event is on August 4. Mayor Mironov stated she is looking for information on Mercer at Play and she is looking to have the information for the next Council meeting. She is looking for information on the in-kind match. Mayor Mironov stated she is looking for a

timeline on when the Energy Aggregation information will be provided from the Assistant Manager. She is also looking for information from Public Works on the roadway paving work that was done by Aurobindo last fall 2017. Mayor Mironov is also looking for an update on Windsor Center lights from Public Works,

Council Member Parry Shapiro thanked the Mayor for forwarding the letter from the League of Municipalities on the municipal court study and the memo was very helpful.

1. 2017 Municipal Audit

Resolution R2018-138 Acknowledging the Receipt of Audit and Signing of Group Affidavit

RESOLUTION R2018-138 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year 2017 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34; and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by Resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments Recommendations

and,

WHEREAS, the members of the governing body have personally reviewed at a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General CommentsRecommendations

as evidenced by the group affidavit form of the governing body; and

WHEREAS, such Resolution of certification shall be adopted by the governing body no later than forty-five (45) days after the receipt of the Annual Audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with at least the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgation's of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000) or imprisoned for not more that one (1) year, or both, in addition shall forfeit his office."

NOW, THEREFORE, BE IT RESOLVED, that the Township Council of the Township of East Windsor, hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated

July 30, 1968, and does hereby submit a certified copy of this Resolution and the required affidavit to said Board to show evidence of said compliance.

I hereby certify the foregoing to be a true copy of a Resolution adopted by the East Windsor Township Council at a meeting held on July 24, 2018.

East Windsor Township Auditor, Nisivoccia and Company, LLP, reviewed the 2017 Audit and stated East Windsor Township is in great financial state and the Mayor and Council and officials have done a great job with preparing the budget and overseeing and managing expenditures and revenues.

Mayor Mironov stated staff needs to obtain the financial statement to the JIF.

It was MOVED by Lippman, SECONDED by Rosenberg to approve Resolution R2018-138.

There being six (6) ayes and no (0) nays, Resolution R2018-138 was approved.

2. 2018 Safe Routes to School Program (SRTS) Proposals

Mayor Mironov stated in Mayor and Council folders is a memo that was provided by Public Works late this afternoon thanks to the Municipal Clerk. Mayor Mironov expressed that this information was previously requested and Hightstown has not yet responded as to the plan for the Township and the Borough for the Safe Routes to School application. Mayor Mironov stated the previous Public Works memo was lacking alot of pertinent information and the second memo does provide more information as to the questions Council was asking. Mayor Mironov stated there is zero information on the proposed bikeway in the area of Wiltshire Drive and it would be impossible to provide this unless someone physically went out to look at everything. Mayor Mironov requested that more information be provided and followed up on this project. Deputy Mayor John Zoller requested regarding the Dutch Neck project he would like to see a very simple map showing the responsibilities of East Windsor and Hightstown. Mayor Mironov further stated she would like to look into 401 Morrison further and she did not agree with what was provided. She also stated it seems as though it would be easier to install sidewalks on the southern side, despite there being no map to have a better view of the actual proposed project. Council Member Daniels questioned how the sidewalks affect the children. Mayor and Council unanimously agreed to work in conjunction with Hightstown on the project. Mayor Mironov requested the following information be provided, a map with descriptions on where the sidewalks are to be located connecting East Windsor and Hightstown, determining with Hightstown if the towns would do a joint application or just cross reference, what are the amounts within the memo and are they correct. The item needs to be listed on the August 7 agenda. Council Member Lippman requested that Council be notified once the information is in their boxes.

3. 2018 Transportation Alternatives Set-Aside Program (TA Set-Aside) Proposals

Mayor Mironov stated this is also a New Jersey Department of Transportation program and public works provided a memo to Mayor and Council although it is lacking information. Mayor Mironov stated \$135,000 was received for the engineering services for the Union Transportation Trail as no other staff proposals, Mayor and Council would like to move ahead with the UTT trail for the transportation alternatives program. Mayor Mironov stated this need to be listed on the August 7 agenda with a resolution.

4. Route 130/Hankins Road/ Conover Road Realignment Improvement Project

Mayor Mironov stated the Assistant Manager should be more aggressive on this project and the Mayor is looking to move things along. Mayor Mironov also requested a report from the Assistant Manager by the end of the week as to the status. She further requested that this item be added to the August 7 Council meeting agenda.

5. Municipal Building HVAC Status and Professional Report Updates and Status

Mayor Mironov stated a memo was received on July 19 from the Public Works Director stating the project is complete and the remaining balance can be paid and closed out.

6. Police/Court Building Roof and Professional Report Updates and Status

Mayor Mironov stated a memo was received from Public Works dated July 19, 2018. Mayor Mironov questioned what is outstanding on the project, the status of the camera and the wire installation, what is not functioning, has the landscaping been completed, what is the contract balance and what are we holding and why and what is being done to complete the project.

Linda Caffery, 60 One Mile Road, East Windsor stated she is looking for the website to provide better information on the Boards and Committees minutes.
