An Ordinance to Approve Contract of Sale to Purchase the Property Located at 250 Windsor Center Drive (Block 87, Lot 28)

ORDINANCE NO. 2018-08 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AUTHORIZING THE PURCHASE OF PROPERTY, LOCATED AT 250 WINDSOR CENTER DRIVE (PORTION OF BLOCK 87, LOT 28), IN THE TOWNSHIP OF EAST WINDSOR, COUNTY OF MERCER, STATE OF NEW JERSEY

WHEREAS, the Township Council of the Township of East Windsor has determined that it is in the best interests of the Township to acquire property located at 250 Windsor Center Drive (portion of Block 87, Lot 28), in the Township of East Windsor, County of Mercer, State of New Jersey, of approximately 18 acres, from Aurobindo Pharma USA Inc., in connection with

implementation of the Township Housing Element and Fair Share Plan of the Township Master

WHEREAS, the Township and Aurobindo Pharma USA, Inc. have agreed on a purchase price of six hundred and fifty-five thousand dollars (\$655,000) for this property.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

SECTION 1. AUTHORIZATION.

- 1. The Mayor and Municipal Clerk are authorized and directed to execute an Agreement of Sale between the Township of East Windsor, as purchaser, and Aurobindo Pharma USA, Inc, as seller, at a purchase price of six hundred and fifty-five thousand dollars (\$655,000), for the property located at 250 Windsor Center Drive, (portion of Block 87, Lot 28) East Windsor Township.
- 2. The Mayor, Township Manager, Municipal Clerk, Finance Director, and Township Attorney are hereby authorized to take all necessary actions to carry out the Agreement to Sale. This authorization includes, but is not limited to, the payment of the contract purchase price, and acceptance and recording of a deed to the subject property.

SECTION 2. REPEAL. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. SEVERABILITY. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. EFFECTIVE DATE. This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated Ordinance 2018-08 is for the purchase of the property located at 250 Windsor Center Drive. The price has been determined and in order for the Township to purchase the property, the ordinance and contract must be approved by Mayor and Council.

AN ORDINANCE AUTHORIZING THE EXECUTION AND RECORDING OF EASEMENT AGREEMENTS IN CONNECTION WITH THE PURCHASE AND FUTURE DEVELOPMENT OF 300-C PRINCETON-HIGHTSTOWN ROAD, EAST WINDSOR, NEW JERSEY, BLOCK 5, LOT 2.02

WHEREAS, by Ordinance 2018-01, adopted on February 20, 2018, the Township Council authorized the purchase of vacant real property located at 300-C Princeton-Hightstown Road in East Windsor Township, which property is designated on the East Windsor Township Tax Maps as Block 5, Lot 2.02 ("the Property"); and

WHEREAS, the Township closed on the purchase of the Property on July 30, 2018; and

WHEREAS, in connection with the purchase of the Property and to facilitate the future development of the Property, the following easement agreements are required to be executed and recorded: (1) Second Easement Agreement Modification; (2) Sign Easement Agreement as to Block 5, Lot 27.04; (3) Sign Easement Agreement as to Block 5, Lot 2.01; and (4) Reciprocal Recreation Easement Agreement, all in the form attached hereto; and

WHEREAS, the Township has determined that it is the best interest of East Windsor Township that the attached easement agreements be executed and recorded:

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer, and State of New Jersey, as follows:

SECTION 1. AUTHORIZATION TO EXECUTE EASEMENT AGREEMENTS.

The Mayor and Municipal Clerk are hereby authorized and directed to execute and record the attached: (1) Second Easement Agreement Modification; (2) Sign Easement Agreement as to Block 5, Lot 27.04; (3) Sign Easement Agreement as to Block 5, Lot 2.01; and (4) Reciprocal Recreation Easement Agreement, all in the form attached hereto, in order to facilitate the future development of 300-C Princeton-Hightstown Road in East Windsor Township, which property is designated on the East Windsor Township Tax Maps as Block 5, Lot 2.02.

Approval of Environmentally Preferable Purchasing Policy (Green Purchasing Policy) for East Windsor Township

RESOLUTION 2018-139 EAST WINDSOR TOWNSHIP MERCER COUNTY

A RESOLUTION SUPPORTING GREEN PURCHASING

WHEREAS, the Township Council of the Township of East Windsor recognizes the need to strive to enhance standards of environmental stewardship and the environmental characteristics of our municipal operations; and

WHEREAS, the "Greening" of public purchasing is a tangible and practical step which local government can take by instituting more sustainable practices and improve environmental performance; and

WHEREAS, the Township Council wishes to incorporate "Green Purchasing" where feasible and fiscally prudent; and

WHEREAS, purchasing "Green" or environmentally preferable products sends a clear signal to the market that there is a preference for green, clean and safe products, resulting in the availability of an increasing number of environmentally preferable alternative products in the marketplace, which then also likely will become more available to our residents; and

WHEREAS, the Township of East Windsor, in furthering the use of Green products, will use as the definition and purpose of Environmentally Preferable Purchasing (EPP) or "Green Purchasing," the purchase of goods and services that

minimizes environmental impacts. It includes the purchase of products with postconsumer recycled content, that have a lesser or reduced effect on human health and the environment when compared with competing products that serve the same purpose; and

WHEREAS, the Township Council does hereby request that Township staff include environmental considerations in purchasing decisions by using the following criteria to encourage purchase of Green products, as available and practicable:

- distance of transport/ localness of production
- quality and performance standards of the product
- packaging or distribution method of the product
- price and performance of the product
- the raw materials, including energy and water and post-consumer recyclable content, used in the manufacture of the product; and

WHEREAS, the Township Council does set forth the goals and objectives of the Green Purchasing Program as follows:

- 1. to establish the Township's clear commitment to conducting its functions in an environmentally responsible manner
- to improve the Township's environmental performance and make it more sustainable
- 3. to raise awareness of environmental issues among the staff

NOW, THEREFORE BE IT RESOLVED, that the Township Council of the Township of East Windsor does support and encourage the purchasing of Green and Environmental Performance Products as a meaningful, long-term objective that has value both for the employees and for the community.

RESOLUTION R2018-140 EAST WINDSOR TOWNSHIP MERCER COUNTY WHEREAS, there is a need for private elevator on-site inspection and plan review services; and

WHEREAS, on August 8, 2017, Mayor and Council adopted Resolution R2017-142, approving EIC Inspection Agency Corp. for Elevator Inspection Services for a period of (1) one year, commencing September 1, 2017 2017 and ending August 31, 2018; and

WHEREAS, on April 12, 2018, the Township was notified by EIC Inspection Agency Corp. that they were going out of business effective May 31, 2018; and

WHEREAS, the Township solicited quotes from the New Jersey Department of Community Affairs certified vendors by a notice seeking requests for proposals which was posted and distributed on June 15, 2018, for private elevator on-site inspection and plan review services and one proposal was received by East Windsor Township by the required date of July 11, 2018; and

WHEREAS, the cost proposal was submitted by Municipal Inspection Corporation was responsive to the request of proposals at 95% of the New Jersey Department of Community Affairs fees; and

WHEREAS, the Township Council has reviewed the recommendations made by the Township Manager; and

WHEREAS, the Chief Financial Officer has determined sufficient funds are available in the Trust Fund Account No. T-13-56-854-802 entitled "Elevator Inspections", as evidenced by the Chief Financial Officer's Certification No. T2018-005.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, County of Mercer, in the State of New Jersey as follows:

- 1. The Contract for Private Elevator On-site Inspections and Plan Review is hereby awarded to Municipal Inspection Corporation, 183 West 4th Street, Bayonne, NJ 07002, for a period of (1) one year, commencing August 1, 2018 and ending July 31, 2019, at 95% of the New Jersey Department of Community Affairs fees, with the option to award (1) one additional one (1) year extension commencing August 1, 2019 to July 31, 2010, at the option of the Township, at the same rate.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the Contract for same.

Mayor Mironov stated the Economic Development Committee met on August 2 and discussed the Gateway Project involving an RFP to solicit art installation ideas for placement at the Route 33 and Route 130 intersection, the Princeton Chamber of Commerce fall event, a brochure and the National Night Out event that was held on August 2, 2018. Mayor Mironov also attended the senior art show on August 3 at Meadow Lakes and several winners were East Windsor residents. Mayor Mironov attended an Eagle Scout Court of Honor on Sunday August 5. Mayor Mironov, Council Member Marc Lippman, Council Member Perry Shapiro and Council Member Alan Rosenberg attended the East Windsor Volunteer Co 2 Fire Academy graduation.

Mayor Mironov stated fifteen young people graduated, many families attended and it was a great event.

APPROVAL OF BILLS:

Mayor Mironov stated a 2018 Current Bill list, 2017 Current Bill list, Affordable Housing Bill List and other miscellaneous bill lists and trust accounts were provided.

MATTERS BY COUNCIL:

Mayor Mironov asked if anyone from Council had any objections to cancelling the Tuesday August 23 Council meeting, Council Members did not object, so the next scheduled meeting will be September 4, 2018.

Mayor Mironov stated she reached out to the NJ Turnpike to see what work was done to the Route 33 maintenance yard and along Route 33, and received a phone call back from Shawn Taylor requesting to meet. Mayor Mironov requested he provide a report in writing prior to meeting setting forth all the work that was done.

Mayor Mironov stated a quarterly revenue report was provided by the Chief Financial Officer dated July 13, 2018. Mayor Mironov noted a letter from T&M Associates dated July 28, 2018 was received recommending the performance guarantees release for the McGraw Hill Solar Array Facility. Mayor Mironov was surprised how quickly it was done and it will be scheduled on a future agenda. Mayor Mironov stated a July 27, 2018 letter was received from RISE on a festival they are sponsoring on August 18, 2018, 1:00 p.m. to 6:00 p.m. at Rocky Brook Park in Hightstown. She stated she would like some kind of indication that the HVAC work at the Municipal Building has been completed. Mayor Mironov noted a letter was received on municipal aid applications from New Jersey Department of Transportation with a submission deadline of November 8, 2018. Mayor Mironov is looking for ideas from staff on projects and will list on the September 4 Council meeting agenda. Mayor Mironov is also looking for application preparation from staff for the Mercer at Play County grant program and will list on

the September 4 Council agenda. Mayor Mironov stated the tax bills are now out and are now due August 13, 2018. Mayor Mironov also stated there is one more child safety seat event on September 13.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. 2018 New Jersey Department of Transportation Safe Routes to School (SRTS) Grant Program

Resolution R2018-143

Approval of Filing of Application to New Jersey Department of Transportation for "Safe Routes to School" Program

Mayor Mironov stated the deadline date to file the application has been extended to September 18, 2018 and will list this on the September 4 agenda. Mayor Mironov stated that she reached out to the Hightstown Mayor who had reached out to her regarding interest in the project. Mayor Mironov then called back and also spoke to the Clerk/Administrator and expressed interest in the idea of a joint project but was looking for more information on what they were looking to do. Mayor Mironov asked Hightstown about the requirements and if one or two applications were needed to be filed. Mayor Mironov requested that the Director of Public Works reach out to the Hightstown Clerk/Administrator and New Jersey Department of Transportation regarding the application and how many applications were required. The Hightstown Clerk/Administrator stated two applications were needed and the information will be provided to us with their project details. As time passed and no information was provided, Mayor Mironov reached out to Hightstown again to follow-up regarding project details and received no response. Mayor Mironov stated she has spent a lot of her own time on this small application process and due to Hightstown's non response she would like to look at the bikeway project. She stated the bikeway project was not looked into due to questions about parking but the Director of Public Works stated that on street parking would not be affected. Mayor Mironov stated Wiltshire is a great area to have a bikeway and there are a lot of schools and parks in that area. Mayor Mironov stated she is tired of making calls with no response, and does not quite understand the non response but would like to look into this area as well so we do not lose out on a project. Council Member Lippman stated the East Windsor-Hightstown project would be great but if Hightstown is not willing to do a joint project it really does not make sense for East Windsor to continue. Mayor Mironov expressed that the other project is a good project as well, so she would like staff to prepare applications and make a decision at the next Council meeting. She further stated there are other grant opportunities that are coming to light and we would be able to possibly utilize the application for a future application. Mayor Mironov stated to get the letters of support from Greater TMA and the school district, and inquire with them and New Jersey Department of Transportation if there are others we should reach out to for greater support. Council Member Daniels expressed that she would not want to lose the opportunity to apply for a project due to Hightstown's non response and both projects are great projects. Deputy Mayor Zoller and Council Member Rosenberg also expressed interest in reviewing both projects to make a better decision.

2. 2018 New Jersey Department of Transportation Transportation Alternatives Set-Aside (TA Set-Aside) Grant Program

Mayor Mironov stated this application date was not extended and questioned if the Department of Public Works was prepared to submit the application, although that due to the timeline there is no choice but to file and submit the current application.
