Ordinance No. 2018-08 An Ordinance to Approve Contract of Sale to Purchase the Property Located at 250 Windsor Center Drive (Block 87, Lot 28)

ORDINANCE NO. 2018-08 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AUTHORIZING THE PURCHASE OF PROPERTY, LOCATED AT 250 WINDSOR CENTER DRIVE (PORTION OF BLOCK 87, LOT 28), IN THE TOWNSHIP OF EAST WINDSOR, COUNTY OF MERCER, STATE OF NEW JERSEY

WHEREAS, the Township Council of the Township of East Windsor has determined that it is in the best interests of the Township to acquire property located at 250 Windsor Center Drive (portion of Block 87, Lot 28), in the Township of East Windsor, County of Mercer, State of New Jersey, of approximately 18 acres, from Aurobindo Pharma USA Inc., in connection with implementation of the Township Housing Element and Fair Share Plan of the Township Master Plan.

WHEREAS, the Township and Aurobindo Pharma USA, Inc. have agreed on a purchase price of six hundred and fifty-five thousand dollars (\$655,000) for this property.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

SECTION 1. AUTHORIZATION.

- 1. The Mayor and Municipal Clerk are authorized and directed to execute an Agreement of Sale between the Township of East Windsor, as purchaser, and Aurobindo Pharma USA, Inc, as seller, at a purchase price of six hundred and fifty-five thousand dollars (\$655,000), for the property located at 250 Windsor Center Drive, (portion of Block 87, Lot 28) East Windsor Township.
- 2. The Mayor, Township Manager, Municipal Clerk, Finance Director, and Township Attorney are hereby authorized to take all necessary actions to carry out the Agreement to Sale. This authorization includes, but is not limited to, the payment of the contract purchase price, and acceptance and recording of a deed to the subject property.

SECTION 2. REPEAL. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. SEVERABILITY. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. EFFECTIVE DATE. This Ordinance shall take effect 20 days after final passage and publication according to law.

WHEREAS, the maximum amount of the purchase is \$10,958.00 and funds are available in the Capital Fund Account No. C-04-55-970-916-870 entitled Ordinance 2015-02 "Parks and Playground Equipment" for a total not to exceed \$10,958.00, as evidenced by the Chief Finance Officer's Certification No. C2018-012.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to Culligan Matrix Solutions, 18 Northfield Avenue, West Orange, NJ 07052, for the purchase and installation of a replacement water treatment system to provide water at Etra Lake Park in an amount not to exceed \$10,958.00.

Mayor Mironov stated she attended a County event for the Municipal Alliance of the Prevention of Substance Abuse and it was a great turnout.

Mayor Mironov stated correspondence will be done during Matters by Council.

APPOINTMENTS: None

APPROVAL OF BILLS:

Mayor Mironov stated a 2018 Current Bill list, 2017 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Council Member Zoller asked if the purchase of the benches on page 16 of the Current bill list is on the correct bill list. Mayor Mironov stated the benches were due to a mistake that was previously done by Department of Public Works and the account that this charge is coming out of is correct.

Mayor Mironov held the bill on page 3 of the Escrow Bill list and would like further information on what project this is for.

MATTERS BY COUNCIL:

Deputy Mayor Zoller thanked the Township Manager for the striping of the municipal building parking lot.

Mayor Mironov stated Lee Turkey Farm is celebrating 150 years and the Mayor is looking to hold an event. She also had created a sign which will be displayed on the Township roadways promoting Lee Turkey Farm 150th Anniversary. Council Member Lippman requested adding the Township emblem to the sign as well. Mayor Mironov stated the 9-11 benches have been installed. Mayor Mironov also noted a letter was received from Mercer County regarding work that was supposed to be done on Route 571, although an additional letter was received on August 31 stating the work will not be conducted. Mayor Mironov stated although she is pleased to see that the Director of Public Works filed the Transportation Alternatives Program application, it was done last minute and in the future this needs to be submitted prior to the day and hour that it is due. She further stated it is not acceptable to submit any application that late due to unforeseen circumstances that could possibly occur. Mayor Mironov also noted a tax receipt report from the Tax Collector ending July 31, 2018 was received. Mayor Mironov stated a memo regarding the HVAC municipal building project was received from the Department of Public Works stating the project is now complete, while a memo was received, dated August 28, 2018, from the Department of Public Works stating the PD/Court roof project is not complete. She stated an updated memo is required stating everything that is outstanding on the roof project. Mayor Mironov stated a memo, dated August 8, 2018, was received from Director of Public Work's regarding the No Net Loss. Mayor Mironov further stated she did not send the letter to the County Executive. His office reached out to the Township to see how the issues can be rectified.

Mayor Mironov stated Magnolia Ridge is working at a very slow pace and she would like follow-up on this due to the amount of complaints from residents. She is looking to see how this project can be completed and what needs to be done. Mayor Mironov stated there have been several complaints regarding the trees from the storm and she would like a full report from the Township Manager and JCP&L on how these trees are being handled. She is also looking for a report from the Assistant Manager on the Energy Aggregation and she is looking for thoughts on whether the Township should be considering this program or not. Mayor Mironov stated the Windsor Center Drive with Aurobindo is still outstanding and information is requested again from the Public Works Director. The Windsor Center Dive subject needs to be listed on the September 25 Council agenda for updates and how to close out the project. Windsor Center Drive lights are also an issue and she would like to see what is being done to

satisfy the issue. Deputy Mayor Zoller stated there is old signage that also needs to come down on that same property. Mayor Mironov stated the 2018 business awards announcements to solicit nominations are out. Mayor Mironov stated the September 11 ceremony will be held on September 11 at 5:30 p.m. at the Township memorial. Mayor Mironov stated the last child seat safety program event is on Thursday September 13 at the East Windsor Police/Court building. Council Member Shapiro also mentioned that Mayor Mironov received an award for Women in Municipal Government from the New Jersey League of Municipalities.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

Mayor Mironov stated that she had asked the Director of Public Works to attend tonight's meeting to discuss several issues that have occurred but due to personal obligations he was unable to attend. Mayor Mironov expressed her embarrassment due to the statements that were previously made at the last Council meeting by her on the "Safe Routes to School" application with Hightstown. She further stated specific information was provided to the Director of Public Works on the possible project on July 31, 2018 and Hightstown's recommendations on what they would like to do in conjunction with East Windsor on this project. The Director of Public Works also received follow-up via phone call and email on August 1, 2018 ensuring the material was received. Then additional material was provided to DPW on August 14, 2018. Mayor Mironov stated that the initial information was provided prior to the August 7 Council meeting, but Mayor and Council were not made aware or provided any information. Mayor Mironov further stated if the information was provided, the application could have been acted on at the August 7, 2018 Council meeting. A Hightstown Council member called to touch base on the project and was concerned by the Mayor's phone call which is how it came to her attention. Mayor Mironov requested that the Township Manager and the Director of Public Works have a conversation on what and why this occurred and ensure that this will never happen again. Mayor Mironov further stated she would like to do the project with Hightstown and they provided East Windsor with more than enough time and information on the project. She is looking to move forward with the application on Dutch Neck and Morrison Roads which will provide students with safe walkways to and from school. She stated the Resolution needs to be more specific in the second paragraph and in the now therefore number 1 more information as to the specifics on the project area. Also "Grant" needs to be capitalized in the resolution and the Mayor's signature needs to be incorporated into the final paragraph. Mayor Mironov stated in the instructions for the application she saw that it required the school board approval by Resolution. That information is lacking along with the letters of recommendation, and page 15 needs accurate details on the project. The entire application needs to be cleaned up.

- 2. New Jersey Department of Transportation FY2019 Grant Programs Proposed Projects
 - a. Municipal Roadway Proposed Projects

Mayor Mironov requested information back in July regarding ideas and details on projects. She further stated that the deadline for the application is October 9, 2018. The subject matter needs to be on the next Council agenda and the application needs to be submitted before October 8. Dutch Neck Road between Route 130 and Hightstown is a project that she is in support of doing. Mayor Mironov stated the project was brought up last year and the road is in terrible shape. The rest of Dutch Neck Road also needs to be looked at to see what has and has not been recently done. Also the area of Dutch Neck Road from Hickory Corner Road to the West Windsor border is also in need. She also stated #3 on the memo is not a project in need. Mayor Mironov also said she would consider Airport Road or possibly Town Center, but they need to be looked at more seriously by Public Works. She stated Airport Road would have to be looked at and divided if that was one of the options. Mayor Mironov suggested that the Director of Public Works should look at all roadways that can possibly be used for municipal aid and be more on top of things. Two resolutions need to be listed on the next Council agenda and information needs to be submitted to Mayor and Council by Friday September 7. Deputy Mayor Zoller is requesting a list of all the roads in priority. Mayor Mironov also requested a list of all the roadways that have previously been done.

b. Bikeway Proposed Projects

Mayor Mironov stated a memo dated August 30 was provided by the Director of Public Works regarding what the criteria is for the project. She stated the memo is identical to last years memo with the same recommendations and provides no criteria for the application. In previous years East Windsor has not been very successful. Mayor Mironov recommended reaching out to Greater TMA and discuss what is lacking and how the Township can correct this for the future. She was surprised that Wiltshire Drive was not included as a recommendation. Council Member Yeager stated he would like connector paths to be looked at as well to see if this may give the Township a higher chance of receiving the grant.

3. Route 130/Hankins Road/ Conover Road Realignment Improvement Project

Mayor Mironov stated a memo, dated September 4, was provided to Mayor and Council with updated information on the project. She stated information was received in early August and Mayor and Council did not receive updated information until recently asked. Robbinsville needs further follow-up with information provided to Mayor and Council. Mayor Mironov stated the project details such as contractor details, bid and specs and the itemized timeline is all lacking from the memo and the information needs to be provided to Mayor and Council by tomorrow. Council Member Lippman also requested the reason why Robbinsville is not responding.

4. Open Space Acquisitions Proposed Projects

Mayor Mironov stated a letter was provided in Mayor and Council folders tonight. Council Member Shapiro asked for properties to be better clarified and evaluated and how does the county recommendation play a part. Mayor Mironov stated the County plays a big part for farmland preservation in the County as well as the State. Mayor Mironov stated information on these properties are lacking and more needs to be provided such as previous interest, cost, value and funding. The information needs to be provided well before the meeting and listed on the next Council agenda.

MATTERS BY PUBLIC:

Debbie Hepler, West Windsor, NJ, informed the Mayor and Council of an animal control matter regarding a sick Great Egret bird that had the West Nile virus. She stated she risked her safety due to the Deputy Animal Control Officer's diligence to responding to the event and taking any further action. She was bringing this to the attention of Mayor and Council.
