Mayor Mironov circulated a promotional piece from the EDC for the Council to review.

APPOINTMENTS: None

APPROVAL OF BILLS:

Mayor Mironov stated a 2018 Current Bill list, 2017 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov questioned and held three bills on the various bill lists.

MATTERS BY COUNCIL:

Mayor Mironov stated a memo was received from the Finance Director providing a report on the award of the sale of Bond Anticipation Notes. She also noted a tax collector's report for a period ending December 31, 2018 was distributed to Mayor and Council. Mayor Mironov stated a report for disbursement, dated November 30, 2018, and a tax sale report for 2018 was provided to Mayor and Council from the Tax Collector. She also stated a letter was received from Mercer County Planning Department, dated September 6, 2018, regarding the October 2019 expiration of the Township Wastewater Management Plan. Mayor Mironov stated that staff needs to follow-up on the plan to see what action needs to take place. She further noted a letter, dated December 10, 2018 that was received addressing the same Wastewater Management Plan expiration topic. Mayor Mironov stated a letter, dated November 6, 2018, was received from Comcast regarding the franchise process and she is looking for staff to provide information on the process and what is required. She stated the food drive is continuing though the month of January. Mayor Mironov noted that the Township received the Architectural Services RFP's for the senior center expansion and a committee will be appointed. She further stated that any Council Members that are interested in participating need to let her know.

Mayor Mironov stated draft letters with the agreements were provided by Public Works and the overall numbers were provided by the Finance Director. Mayor Mironov noted on Westfield that the order needs to be in the corrected. She requested that the letters be sent out to the private communities and associations for signature and upon return will be on an upcoming agenda. Mayor Mironov noted that the Kelly Bills have always been on the first regular meeting of the year in order to get their reimbursement early.

4. 2018/2019 Capital Program

Mayor Mironov stated a memo was provided by the Township Manager as a first phase capital program, but later in the year, Mayor and Council will be considering additional purchases. Mayor questioned the Police Depart recommendation stating she did not see the Wiltshire Tower or the computer back-up listed and information needs to be provided. Township Manager Richard Brand stated the tower was destroyed a year ago due to a storm and needs to be replaced. Mayor Mironov also stated the Oak Creek Road and Old Cranbury Road grants need to be included in the ordinance. Mayor Mironov requested information and turn-out gear life for both of the Fire Companies to ensure the gear is getting replaced properly. Mayor Mironov stated an ordinance needs to be drafted and will be on an upcoming agenda.

5. 2019 Watershed Stream Clean-up

Mayor Mironov and Council agreed that Saturday April 13 from 9:00 a.m. to 1:00 p.m. would be a good time for the 2019 Watershed Stream Clean-up event.

6. JCP&L Dead Tree Program – Township Plan

Mayor Mironov stated current information was included in Council folders tonight with an update on the program. Township Manager Richard Brand stated 103 trees have been removed by JCP&L and they will be removing the additional 50+ in the upcoming weeks.

7. Windsor Center Roadway Paving Project

Mayor Mironov stated Council is still awaiting information from the Director of Public Works.
