REPORTS BY COUNCIL AND STAFF:

Council Member Rosenberg stated the Clean Communities Commission had a wonderful time at the end of the year Adopt a Spot event which had a lot of attendees. He also stated the Commission on Aging met that same night and Sydelle Norris was nominated as Chairperson, Ina Heiman is Vice-Chairperson and Gloria Goldberg as Recording Secretary for 2019. Council Member Yeager stated the Recreation Commission met on January 9 and discussed ongoing school age children events, 2019 Summer Camp, 2019 Egg Hunt, the Independence Day Celebration and the concert series for 2019. Council Member Zoller stated the Environmental Commission met on January 16 and annual voting took place for chairperson and vice-

chairperson for 2019. Mayor Mironov stated the Planning Board met on January 28 and dedicated the evening to discussing the Master Plan Re-Examination. She stated several workshop sessions will be held prior to public hearing and the document being prepared. On January 23, Mayor Mironov attended the Mercer County Municipal Alliance for Substance Abuse event at which the Township received an award. Assistant Township Manager Jay Delaney stated two meetings will be held regarding the relocation of the utility lines for the Route 130/Hankins/Conover Road Project. The first meeting will be on Thursday, January 30 with PSEG, JCP&L and the MUA and the second meeting follows on February 7 with the Department of Transportation. He further stated the contractor expects to start work on this project on April 1 and once the schedule has been finalized he will distribute to Mayor and Council.

CORRESPONDENCE:

Mayor Mironov stated a January 17 update was received from the principal engineering aide on a filed permit and she objected to the permit pending clarification. Mayor Mironov noted that a memo was provided by the Township Manager on bill list questions from the January 15, 2019 Council meeting. Mayor Mironov noted that number 3 on the Township Manager's memo is referencing the wrong bill and needs to be revisited and information be provided and she noted a receipt of a memo from Larry Iverson, Foreman of Department of Public Works, regarding the water treatment system at Etra Lake Park. Mayor Mironov requested that a letter be submitted to the Department of Transportation prohibiting large truck left hand and U-turns and at the intersection of Route 130 North bound and Old Cranbury Road for vehicles over 4 tons. Mayor Mironov stated that the Recreation Director brought to her attention to notify Council that the stream clean-up and the egg hunt are on the same day.

Mayor Mironov stated she hereby is appointing the 2019 local Emergency Management Planning Committee pursuant to her January 16 memo. Mayor Mironov also stated, as per Council Member Daniels recommendation, that she is appointing Scott Lunan as an Auxiliary Member to the Health Advisory Board.

WHEREAS, on March 6, 2018, by Resolution R2018-048, East Windsor approved the option for one (1), one (1) year renewal term, May 16, 2018 through May 15, 2019, in an amount not to exceed \$734,000.00; and

WHEREAS, the Township Council has reviewed the recommendation of the Chief of Police for year four (4) renewal; and

WHEREAS, the maximum annual amount of the contract for year four (4) is \$734,000.00 (\$61,166.67 per month) and the Chief Financial Officer has determined that sufficient funds are available in the Current Account No. 9-01-25-250-308-254 entitled "Communications Contracts," pending adoption of the 2019 budget, as evidenced by the Chief Financial Officer's Certification No. B2019-009.
