AN ORDINANCE TO AUTHORIZE ACQUISITION FOR OPEN SPACE OF AN APPROXIMATELY 11.32 ACRE SITE, LOCATED AT 641 ETRA ROAD, AND DESIGNATED ON THE EAST WINDSOR TOWNSHIP TAX MAP AS PART OF BLOCK 32, LOT 13.01

WHEREAS, the Township Council of the Township of East Windsor has determined that it is in the best interests of the Township to acquire an approximately 11.32 acre parcel of land located at 641 Etra Road, and designated on the East Windsor Township Tax Map as part of Block 32, Lot 13.01 (the "Property"), for use as open space; and

WHEREAS, the Property is presently owned by Orrin Paul Bennett and May K. Bennett. (the "Owners"), residing at 164-B Kalmia Place, Monroe Township, New Jersey 08831; and

WHEREAS, an Agreement of Sale, between East Windsor Township and the Owners, has been negotiated with a purchase price of \$220,000.00 for the Property; and **WHEREAS**, the Township has been awarded New Jersey Green Acres Program grants and Mercer County Open Space grants to fund the purchase of the 11.32 acre Property.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey, as follows:

I

The Mayor, Municipal Clerk, Township Manager, Township Engineer and Township Attorney be and are hereby authorized to take all necessary actions to acquire an approximately 11.32 acre parcel of land located at 641 Etra Road and designated on the East Windsor Township Tax Map as part of Block 32, Lot 13.01, for use as open space, pursuant to the Agreement of Sale between the Owners and the Township of East Windsor. This authorization includes, but is not limited to, the execution of an Agreement of Sale with a purchase price of \$220,000.00, payment of the contract purchase price, and the acceptance and recording of a Deed to the Property.

II REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

REPORTS BY COUNCIL AND STAFF:

Council Member Rosenberg stated the Clean Communities Committee met on September 26 and discussed upcoming recycling events, the Illusion Makers event and the potential for a sustainable suggestion box for East Windsor Regional School District Hightstown High School students.

Council Member Daniels stated the Commission on Aging met on September 26 and discussed new programs and events at the senior center.

Mayor Mironov announced Mercer County will be at the senior center once a month starting in October, by appointment only, assisting the seniors in various subjects.

Council Member Zoller stated the Economic Development Committee met on October 3rd and discussed local businesses, Gateway to East Windsor art installation RFP for the entrance at Route 33/130 and Young Entrepreneurship Day at East Windsor Regional School District Hightstown High School.

Mayor Mironov she attended the East Windsor Regional School District Hightstown High School Athletic Hall of Fame on September 4 and the State of the Township was held today, October 15.

CORRESPONDENCE:

Mayor Mironov noted receipt of: a memo, dated October 1, from the Township Manager regarding the request for 2020 municipal budget submissions, a report was provided by the Tax Collector for the period ending September 30, 2019, a quarterly revenue report that was provided by the Finance Director, a letter, dated September 24, was provided by the Mercer County Surrogates office regarding the proposed 2020 schedule dates, a letter was received from the New Jersey Food Council regarding single use disposal bag regulations, a memo was received from the Chief of Police, dated September 27, regarding fire arms purchases, a memo was received from the Assistant Township Manager, dated October 1, regarding the Millstone Road restriping, a memo was received from the Assistant Township Manager, dated September 20, regarding payments to the architect for the senior center expansion and a memo was received from the Township Manager, dated September 20, regarding responses to bill list questions.

APPROVAL OF BILLS:

Mayor Mironov stated a 2019 Current Bill list dated October 8, 2019, 2018 Current Bill list dated October 8, 2019, a Capital Bill List dated October 8, 2019, a one page affordable housing bill list dated October 8, 2019 and other miscellaneous bill lists and trust accounts were provided. Council Member Zoller requested that the large bill at the bottom of the page be held with more information. He further questioned if the bills are being paid through the squad or to the vendors. Mayor Mironov requested clarification on the 2019 current, page 8 on the first item under training and tuition and would like to hold. Mayor Mironov requested clarification on the affordable housing bills and to hold.

MATTERS BY COUNCIL:

Council Member Zoller stated there are concerns regarding the senior center lighting outside and staff needs to look into correcting it.

Mayor Mironov announced the food clinic on October 24.

Mayor Mironov announced the free rabies clinic will be on November 2 and November 9 at the East Windsor Township Fire Departments.

Mayor Mironov inquired on the status of the filing of the small cities application for funding for the senior center. Mayor Mironov requested a status on The Shoppes at East Windsor outstanding items. The Township Manager stated ten out of the thirteen items on T&M Associates punch list were completed. He further stated the remaining outstanding items are the basin, which will be completed by October 28, the gates will be completed October 28 and the trees and shrubs which will be planted once the other outstanding items are completed.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Operation Medicine Cabinet (Saturday, October 26)

Mayor Mironov stated that a memo from the Chief of Police was received on the subject. Mayor and Council were unanimous to move forward with the event.

3. Sustainable Jersey Grant for Etra Park Arboretum

Mayor Mironov requested that staff review the request for proposals and then provide to the Landscape Architect to submit a proposal.

4. Public Works Township Garbage Collection Trucks

Mayor Mironov stated that a memo, dated October 8, from the Township Manager was received regarding replacement and maintenance needed on garbage trucks S-2, S-4, S-5 and S-7. The Township Manager stated garbage truck S-2 is still being worked on, garbage truck S-4 is now back in service, garbage truck S-5 is in-house repair and garbage truck S-7 is still being worked on. Mayor Mironov requested a follow up regarding status of the trucks and where the bills get paid from with the details. Mayor Mironov requested to reschedule the garbage trucks on the next regularly scheduled meeting.

5. NJ Local Government Services 2019 Best Practices

Mayor Mironov stated that the Finance Director provided information on the Best Practices requirements and a memo was distributed from the Township Manager's office. Mayor Mironov stated a memo, dated October 7, was also provided by the Municipal Utility Authority that will be attached to the Township Manager's memo for review. Mayor Mironov stated the overall inventory review provided the Township with a score of 99%.

6. Police/Court Building New Roof, Two Year Maintenance Guarantee: Status and Actions Report by Township Manager

Mayor Mironov stated a report was provided to Council, as well as a letter dated October 9, 2019, transmitting the report and the findings of that report to the contractor and the bonding company. The Township Manager requested giving them another week then providing a letter and if there is still no response then the Township needs to reach out to the bond company. Township Attorney stated the bonding company must acknowledge the claim. Mayor requested information on the Police/Court Building Roof leaks.

7. Brooktree Road Restoration by PSE&G: Status Report by Township Manager

Township Manager stated a notice was received from PSE&G regarding the roadwork will be completed on Friday, October 18 starting at 7:00 a.m. and ending by noon. Mayor and Council discussed the plan and confirmed the notice with the Township Manager.

8. East Windsor No Net Loss Program, Phase III, Status

Mayor Mironov stated a report was received from the Township Manager's office and Mark Liss regarding the payment for the planting of trees on Old York Road. Mayor and Council requested additional information pertaining to the amount of the award and how much has been paid out.

MATTERS BY PUBLIC:

No one from the public spoke.

There being no further business Mayor Mironov declared the meeting adjourned at 9:43 p.m.
