**AN ORDINANCE TO AUTHORIZE ACQUISITION FOR OPEN SPACE OF AN
APPROXIMATELY 15.7 ACRE SITE, LOCATED AT 949 WINDSOR
PERRINEVILLE ROAD, AND DESIGNATED ON THE EAST WINDSOR
TOWNSHIP TAX MAP AS BLOCK 31, LOT 21**

WHEREAS, the Township Council of the Township of East Windsor has determined that it is in the best interests of the Township to acquire an approximately 15.7 acre parcel of land located at 949 Windsor Perrineville Road, and designated on the East Windsor Township Tax Map as Block 31, Lot 21 (the "Property"), for use as open space; and

WHEREAS, the Property is presently owned by Ronald J. Riggenschach and Judy C. Riggenschach (the "Owners"), residing at 86 Coffey Hill Road, Ware, Massachusetts 01082; and

WHEREAS, an Agreement of Sale, between East Windsor Township and the Owners, has been negotiated with a purchase price of \$225,000.00 for the Property; and

WHEREAS, the Township has been awarded New Jersey Green Acres Program grants and Mercer County Open Space grants to fund the purchase of the 15.7 acre Property.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey, as follows:

I

The Mayor, Municipal Clerk, Township Manager, Township Engineer and Township Attorney be and are hereby authorized to take all necessary actions to acquire an approximately 15.7 acre parcel of land located at 949 Windsor Perrineville Road, and designated on the East Windsor Township Tax Map as Block 31, Lot 21, for use as open space, pursuant to the Agreement of Sale between the Owners and the Township of East Windsor. This authorization includes, but is not limited to, the execution of an Agreement of Sale with a purchase price of \$225,000.00, payment of the contract purchase price, and the acceptance and recording of a Deed to the Property.

**II
REPEAL**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated there is a small typo in the second whereas. She also stated the public hearing will be held on December 17, 2019. Mayor Mironov stated Ordinance 2019-08 is to approve the purchase of the open space parcel and approve Township signing of contracts. Mayor Mironov requested the Township Manager get the assessment report on the property and once the report is received a notice to proceed for the survey services needs to be sent out.

Council Member Rosenberg stated the Clean Communities Committee sponsored a recycling puppet show event that was held at Walter C. Black School on November 19. Mayor Mironov requested that staff reach out to Walter C. Black School and get feedback regarding the show. Council Member Yeager stated the East Windsor Municipal Alliance for the Prevention of Substance Abuse met on November 14 and discussed the new grant requirements and future alliance events. He further stated, the Recreation Commission also met on November 14 and discussed the schedule of events for 2020 and 2020 summer camp. Council Member Rosenberg stated the Commission on Aging met on November 14 and discussed the online senior center directory. Mayor Mironov stated the subcommittee met with the architect on the expansion of the senior center and provided the information to the civil engineer to examine the site and the feasibility of the proposed expansion areas. She further stated there appears to be no issues with the project and once the subcommittee receives feedback, then they will decide what the next steps will be moving forward and when a presentation to the public will take place. Mayor Mironov stated the Economic Development Committee met on November 7 and discussed the gateway signs, the revamping of the art installation proposal, the recommendations of the master plan reexamination and a business event that will be held in 2020. She further stated she attended an Eagle Scout Court of Honor for Cameron Watkins on November 23. Council Member Daniels reported that the Health Advisory Board met on November 14 and discussed the closing of the community garden and 2020 events.

Council Member Daniels stated that Conover Road appears to be open. Mayor Mironov stated Conover Road is open. Mayor Mironov stated Passport Service Day is on December 5, 2019. She reported the following correspondence was received: a Tax Collector's report, dated October 31, a memo, dated November 4, from the Director of Public Works regarding the work boots invoice, a memo from the Manager, dated November 12, regarding the police training costs, a memo, dated October 31, from the Director of Public Works on the No Net Loss tree planting payments, a memo, dated November 7, from the Director of Public Works on the follow-up and condition of Brooktree Road, a memo, dated November 4, from the Director of Public Works regarding the Etra Lake bathrooms winterization, a memo, dated November 19, from ACT engineers regarding the Old Cranbury Road/Rocky Brook Road project, and a memo, dated November 26, from the Assistant Township Manager regarding Hankins Road/Conover Road/ Route 130 project payments to Maser Consulting. Mayor Mironov requested that the Township Manager and Director of Public Works review the Maser project and information for accuracy. Mayor Mironov requested an update on the Mercer at Play Anker Park project and a plan to move forward. Mayor Mironov requested a report regarding the electric bills and reason why the cost has increased with the new system and what staff is willing to do to correct the issue. She stated she will not be paying the bills until she receives that report. Mayor Mironov stated she left information for the Township Manager tonight regarding the Educational Coop Program. She stated she is looking for information on the topic and requested that it is listed on the next regularly scheduled agenda. Mayor Mironov stated the Township Attorney is handling the status for Magnolia Ridge and she requested an updated report from ACT on the work that has been done and what is remaining. Mayor Mironov requested an update regarding the Shoppes of East Windsor. Mayor Mironov stated the Township will be receiving a municipal aid grant award in the amount of \$600,361.00 for Exeter Road area roadways. Mayor Mironov asked if anyone reaches out to the farms annually to see if they would like to be preserved. The Assistant Township Manager stated the county does go out routinely and they check with the listed farmers to inquire on their interest. Mayor Mironov further requested for the county to leave her a message on that question. She

further requested that staff draft a letter to the county and include the question in the drafted letter.

2. Union Transportation Trail Extension Project: Status Report by Township Manager

Mayor Mironov stated the project needs to move forward with Hopewell Valley Engineering and an action plan needs to be in effect.

3. Dutch Neck Road/ Morrison Road Resurfacing Improvement Project: Status Report by Township Manager

Mayor Mironov requested a copy of an updated memo and the highway occupancy permit on the project. She further stated a memo, dated November 18, from T&M Associates was provided to Mayor and Council with the cost to prepare the highway occupancy permit within a week. Mayor Mironov stated she is looking to move forward and thought the Township should move forward with T & M Associate's proposal.

It was MOVED by Yeager, SECONDED by Rosenberg to approve the request for T & M Associates to prepare the highway occupancy permit for the Dutch Neck Road/Morrison Road project and list a Resolution on the next regularly scheduled agenda.
