Mayor Mironov stated she has a problem with the amount requested for the electric. She stated with the Municipal Building having a brand new system and the Police Department having solar, there should be no reason for the extreme increase in electric costs. She also requested further clarification regarding the two buildings and the reasons for the increase and how to minimize these costs with the new systems. She also requested that the subject is relisted on the next regularly scheduled agenda. All Council Members unanimously agreed that they would like to know what the plan is and why after a new system it is not what the original expectations were.

### APPROVAL OF BILLS:

Mayor Mironov stated a 2019 Current Bill list, 2018 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

### **MATTERS BY COUNCIL:**

Mayor Mironov stated a memo was received from the Recreation Director, dated October 18, regarding the annual egg hunt. Mayor Mironov stated a memo from the Public Works Director, dated October 29, regarding the October 28 Council meeting bill list questions were provided to Mayor and Council. Mayor Mironov stated a memo, dated October 29, was provided to Mayor and Council on the status of the No Net Loss Program. Mayor Mironov stated a letter, dated October 25, 2019, from Act Engineers on the status of the Old Cranbury Road project was provided to staff. She further requested that the Old Cranbury Road information needs to be provided directly to who the letter was addressed too, which was the Mayor. She noted another letter, dated October 25, from ACT Engineers was received on the status of the Oak Creek Road resurfacing project.

Mayor Mironov questioned if the Brooktree Road restoration project has been inspected and closed out or if there is a period of time that a re-inspection needs to take place. She further stated typically a maintenance bond or some kind assurance takes place after the road is completed to ensure that the road has been done properly. The Township Manager stated the Township will be monitoring the road for the next few months to ensure that they are being maintained properly. He further stated that he was waiting on a letter from PSE&G regarding a three year warrantee for the roadway project. Mayor Mironov questioned the Dutch Neck Morrison Road project and when the project will be received. She stated the bid documents need to go out and is looking for information on when it will be completed. The Township Manager stated he and staff are meeting tomorrow to gather information to resubmit the plans to NJDOT for final approval. Mayor Mironov requested to list the topic on the next regularly scheduled agenda. Mayor Mironov expressed her concern with getting the project done prior to the end of the year. Mayor Mironov stated that the Assistant Township Manager provided information on the Union Transportation Trail although the information provided was not the requested information and further requested additional information to move the project forward. Mayor Mironov stated the topic needs to be listed on the next regularly scheduled agenda and a report needs to be done regarding the scheduling and status on the meetings. Mayor Mironov stated that the Township Attorney sent a letter out regarding Magnolia Ridge. Mayor Mironov stated that Hankins Route 130 project seems out of control and she requested a status report on the timeline of when the project will be completed. Council Member Zoller stated the bridge work on Old Trenton Road and One Mile Road is near completion. Mayor Mironov stated the bridgework would be an additional two weeks and should be completed by the middle of the month.

**WHEREAS**, the Township solicited and received three (3) quotes for Site Investigation Testing Activities, including investigating and assessing the subsurface conditions in the area of concern; and

WHEREAS, the overall lowest most responsive proposal was received from Air, Land & Sea Environmental Management Services, Inc.; and

WHEREAS, since the purchase is under \$17,500.00, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500.00; and

WHEREAS, the Township Council has reviewed the Assistant Township Manager's recommendation; and
