An Ordinance to Authorize Acquisition for Open Space of an Approximately 8.2 Acre Site, Located At 949 Windsor-Perrineville Road, and Designated on the East Windsor Township Tax Map As Block 31, Lot 21

TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER ORDINANCE NO. 2019-08

AN ORDINANCE TO AUTHORIZE ACQUISITION FOR OPEN SPACE OF AN APPROXIMATELY 15.7 ACRE SITE, LOCATED AT 949 WINDSOR PERRINEVILLE ROAD, AND DESIGNATED ON THE EAST WINDSOR TOWNSHIP TAX MAP AS BLOCK 31, LOT 21

WHEREAS, the Township Council of the Township of East Windsor has determined that it is in the best interests of the Township to acquire an approximately 15.7 acre parcel of land located at 949 Windsor Perrineville Road, and designated on the East Windsor Township Tax Map as Block 31, Lot 21 (the "Property"), for use as open space; and

WHEREAS, the Property is presently owned by Ronald J. Riggenbach and Judy C. Riggenbach (the "Owners"), residing at 86 Coffey Hill Road, Ware, Massachusetts 01082; and

WHEREAS, an Agreement of Sale, between East Windsor Township and the Owners, has been negotiated with a purchase price of \$225,000.00 for the Property; and

WHEREAS, the Township has been awarded New Jersey Green Acres Program grants and Mercer County Open Space grants to fund the purchase of the 15.7 acre Property.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey, as follows:

Ι

The Mayor, Municipal Clerk, Township Manager, Township Engineer and Township Attorney be and are hereby authorized to take all necessary actions to acquire an approximately 15.7 acre parcel of land located at 949 Windsor Perrineville Road, and designated on the East Windsor Township Tax Map as Block 31, Lot 21, for use as open space, pursuant to the Agreement of Sale between the Owners and the Township of East Windsor. This authorization includes, but is not limited to, the execution of an Agreement of Sale with a purchase price of \$225,000.00, payment of the contract purchase price, and the acceptance and recording of a Deed to the Property.

II REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated the Ordinance was introduced at the November 26 meeting and the Public Hearing was set for tonight. Mayor Mironov declared the public hearing open on Ordinance 2019-08. With no comment from the public being made, Mayor Mironov declared the public hearing closed.

It was MOVED by Lippman, SECONDED by Yeager to adopt Ordinance 2019-08 and authorize publication as required by law.

Mr. Zoller stated he has an issue with the Ordinance. He stated the Ordinance's title as listed on the meeting agenda indicates that the property is 8.2 acres, but his copy of the Ordinance indicates the property is 15.7 acres. Mayor Mironov stated the Ordinance is the same Ordinance as introduced on November 26 but with the correction of a comma. She stated the document is correct and the property is 15.7 acres. The agenda has a typographical error but the Ordinance is correct and is the same document that was introduced on November 26.

Resolution R2019-156

Action on Request for Release of Performance Guarantee by Asset Management Consultants for Riviera Offsite

RESOLUTION R2019-156 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, pursuant to N.J.S.A. 40:55D-53 of the Municipal Land Use Law, Asset Management Consultants requested by letter dated June 5, 2019, a release of the cash guarantees being held by the Township for Riviera at East Windsor, Off-Site Improvements; and

WHEREAS, on April 15, 2003, Performance Bond #10458241 was issued by Travelers Casualty Surety Company of America, in the amount of \$94,477.32, which represented ninety percent (90%) of the entire performance guarantee amount. In addition, a cash guarantee was posted in the amount of \$10,497.48, which represented ten percent (10%) of the entire performance guarantee amount; and

WHEREAS, on June 15, 2004, by Resolution R2004-132, the Township Council reduced Performance Bond No. 104058241 issued by Travelers Casualty Surety Company of America from \$94,477.32 to \$28,343.20 and the cash guarantee from \$5,114.94 to \$1,534.48; and

WHEREAS, by Resolution R2004-132, T & M Associates incorrectly recommended the cash guarantee release of \$10,497.48 to \$5,114.94 causing the Township to retain an additional \$5,382.54 of the original cash guarantee amount; and

WHEREAS, on April 10, 2010, by Resolution R2010-13, the Township Council approved the applicant's request to release Performance Bond #10458241 in the amount of \$28,348.20 and the Cash Guarantee in the amount of \$1,534.48 contingent to the posting a Maintenance Bond in the amount of \$15,746.22 and escrow in the amount of \$1,000.00 for Maintenance Bond Release. The applicant never posted the Maintenance Bond and inspection escrow. Performance Bond # 104058241 in the amount of \$28,343.20 and Cash Guarantee in the amount of \$1,534.48 continued to be retained by the Township; and

WHEREAS, on May 7, 2013, by Resolution R2013-72, the Township Council denied the applicant's request to release Performance Bond#10405241 in the amount of \$28,348.20 and the Cash Guarantee in the mount of \$1,534.48. In the time elapsed between April 6, 2010 and May 7, 2013, several repairs had been made to One Mile Road. The Township continued to retain thirty percent (30%) of the original performance Guarantee posted in the Municipal Land Use Law; and

WHEREAS, on December 23, 2014, by Resolution R2014-110, the Township Council approved the applicant's request to release Performance Bond#10405241 in the amount of \$28,348.20 and the Cash Guarantee in the mount of \$1,534.48; and

WHEREAS, due to the T & M incorrectly recommending the release of cash guarantee in 2014, \$5,382.54 is still being retained by the Township; and

WHEREAS, the Township Council has reviewed the report and recommendation of the Township Engineer.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The Township Council approves the request made by Asset Management Consultants for release of the cash guarantee in the amount of \$5,382.54.
- 2. The Municipal Clerk is authorized and directed to forward a certified copy of this Resolution and a copy of the Township Engineer's report to Asset Management Consultants.

Mayor Mironov stated this Resolution was held at the October 15 Council meeting with a question as to why there was an inconsistency in the amount that was to be released. She stated that a memo from the Clerk's Office was received on this matter explaining the internal

processes for releases. She stated this error predates the current Finance Director and Clerk and they have confidence that under the current systems everything is being handled well. Mayor Mironov stated that Council had initiated the current system and release checklist regarding payments and other conditions generated by Council to ensure that all conditions were being met by developers. She stated that she feels prepared to move ahead on this matter.

It was MOVED by Lippman, SECONDED by Rosenberg to approve Resolution R2019-156.

Resolution R2019-185Authorizing Purchase of Two Replacement Lawn Mowers from
Turf Equipment and Supply Company for Department of Public
Works

EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, there is a need to purchase two (2) replacement lawn mowers for the Public Works Department; and

WHEREAS, three (3) written quotes were obtained to provide this equipment; and

WHEREAS, East Windsor Township is a member of the Educational Services Commission of New Jersey (E.S.C.N.J.) Cooperative Pricing System and, in accordance with N.J.S.A. 40A:11-10 and N.J.A.C. 5:34-7.11, the Township can purchase goods and services through an approved cooperative pricing system recognized by the State of New Jersey without public bidding when the vendor is an approved state contractor or part of an approved cooperative; and

WHEREAS, the Educational Services Commission of New Jersey (E.S.C.N.J.) publically bid and awarded contract "Grounds Equipment Bid #ESCNJ 18/19-25" to Turf Equipment and Supply Company for Ground Maintenance Equipment; and

WHEREAS, Turf Equipment and Supply Company is the lowest and only local vendor authorized to sell Toro Groundsmaster lawn mowing equipment, which includes one (1) Toro Groundsmaster 5910, model 31699 large swath mower and one (1) Toro Groundsmaster 3280-D six foot cut lawn mower, through the "Grounds Equipment Bid #ESCNJ 18/19-25" contract; and

WHEREAS, this equipment can and will be purchased through the Educational Services Commission of New Jersey (E.S.C.N.J.) contract, "Grounds Equipment Bid #ESCNJ 18/19-25," which is valid through February 21, 2021; and

WHEREAS, the Township Council has reviewed the Director of Department of Public Work's recommendations on this purchase; and

WHEREAS, the maximum amount of the purchase is \$141,878.73 and funds are available in the Capital Fund Account No. C-04-55-980-923-620 entitled Ordinance 2019-01 "DPW Lawn Mower Acquisition", as evidenced by the Chief Financial Officer's Certification No. C2019-020.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to Turf Equipment and Supply Company, 16 Hagerty Blvd, West Chester, Pa., for the purchase of one (1) Toro Groundsmaster 5910, model 31699 large swath mower in the amount of \$115,882.75, and for the purchase of one (1) Toro Groundsmaster 3280-D six foot cut lawn mower in the amount of \$25,995.98, for a total amount not to exceed \$141,878.73 in accordance with the attached quote.

I hereby certify the foregoing to be a true copy of a Resolution adopted by the East Windsor Township Council at a meeting held on December 17, 2019.

Mayor Mironov stated the Resolution was held at the last Council meeting pending a detailed memo from Public Works. She stated that a memo from the Director of Public Works dated November 27 was received providing additional information and quotes.

Mayor Mironov stated she had a few comments on the Resolution. She stated the first paragraph should be revised to read *there is a need to purchase two (2) replacement lawn mowers for the Public Works Department*. She stated a paragraph should be added between the first and second paragraphs indicating that three quotes were obtained, although she does conceded that information was not available when the resolution was drafted. She also requested a paragraph be added indicating that bidding is not required. A paragraph should also be added indicating that this equipment can and will be purchased through the Educational Services Commission of New Jersey (E.S.C.N.J.) contract.

It was MOVED by Zoller, SECONDED by Daniels to approve Resolution R2019-185 with the revisions.

Resolution R2019-191

Authorizing Purchase of Replacement Playground Equipment for Tot Lot at Wiltshire Park from MCR for Department of Public Works

Mayor Mironov stated Council received a recommendation memo, dated November 12, from the Director of Public Works. She stated she reached out to the Director prior to the meeting with two questions. She stated that the memo indicates that shipping is \$1,500 but that does not match the quote. The Director indicated that was an estimate, but she stated estimates are not usable. Mayor Mironov confirmed the shipping amount in the quote and the Resolution is correct. She stated the more significant question was that she did not fully understand what equipment is being replaced and why the rock wall is the only viable option as a replacement for the dragon. She asked the Director to provide colorized pictures to share with Council, but she was not provided pictures of the existing playground equipment, only of the proposed replacement equipment. Mayor Mironov shared the photos with Council members. Mayor Mironov stated she is not persuaded at the moment that this is the best solution, as the Public Works Director indicated that the rock wall is the only option that would fit but he did not provide any other options. She asked if there were more options for replacement equipment they could consider. She stated she would not support this matter at this time.

Mr. Yeager stated he understands the slide replacement, but he agreed with Mayor Mironov and does not understand the other equipment replacement options. Mayor Mironov stated the dragon itself had been discontinued and while there may be some truth to the fact that a rock wall is the only option that will fit as a replacement, further information is requested. Mr. Lippman agreed, stating that he did not believe there is only one option available as a replacement. He stated that the presentation provided by the Director of Public Works leaves a lot to be desired. Mayor Mironov agreed and added that the replacement rock wall did not look well. Mr. Lippman stated that because this is not an urgent matter, he would suggest going back to the Director and request additional information including the footprint of what currently exists, how it is being replaced, what exactly is being replaced, and is there room for additional equipment to be added. Mr. Lippman stated that there is a lot of flexibility as to what can be done with a playground and Council enjoys taking time and care with these matters. Mayor Mironov indicated that Council wants to be economical but if they contemplated replacing more equipment that may provide more options in terms of the replacement equipment. Mayor Mironov requested more information on that topic as well. Mr. Yeager stated if the equipment is being shipped from Spring Lake, he would like to know if it would be an option to pick up the equipment rather than pay for shipping.

The Township Council agreed to hold the Resolution until the next Council meeting pending additional information from the Director of Public Works.

Resolution R2019-194 Approval of Agreement for Animal Care and Sheltering Services with SAVE, A Friend to Homeless Animals

RESOLUTION R2019-194 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, there is a need for Animal Care and Sheltering Services for the Township Animal Control Unit; and

WHEREAS, pursuant to N.J.S.A. 4:19-15.16, East Windsor's Animal Control Officer authorizes the handling and suitable shelter of stray animals within the Township; and

WHEREAS, "SAVE, A Friend to Homeless Animals" (SAVE), a non-profit corporation of the State of New Jersey will provide 24/7 animal care, shelter and adoption services for stray animals on a per-animal daily fee of \$25.00; and

WHEREAS, the Township Council has reviewed the Chief of Police's recommendation; and

WHEREAS, the maximum amount of the contract is \$10,000 per year and funds will be available in the Dog License Trust Account No. D-12-56-852-852 entitled "Dog Fund Expenses," as evidenced by the Chief Financial Officer's Certification No. T2019-019.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey as follows:

1. The Mayor is hereby authorized and directed to execute the attached three (3) year agreement, commencing January 1, 2020 through December 31, 2022, with "SAVE, A Friend to Homeless Animals", 1010 Route 601, Skillman, NJ 08558, to provide 24/7 animal care, shelter and adoption services for stray animals on a per-animal daily fee of \$25.00, in an amount not to exceed \$10,000 per year.

I hereby certify the foregoing to be a true copy of a Resolution adopted by the East Windsor Township Council at a meeting held on December 17, 2019.

Mayor Mironov stated Council received a recommendation on this matter from the Chief of Police. The Resolution is for a three year agreement.

Mayor Mironov stated paragraph five indicates the maximum amount of the contract is \$10,000 in any given year. She requested the language be clarified to reflect that. Mayor Mironov stated the Township has three animal control officer shared service agreements with other municipalities and asked if the Township was paying for the entire cost of the contract with SAVE or if the Township was getting reimbursed through the existing shared services agreements. Mr. Lippman also asked if the Township gets reimbursed sheltering costs if an animal's owner comes in and claims them. Mayor Mironov asked Mr. Brand to look into both questions and provide answers to Council.

Resolution R2019-195 Action on Award of Contract for Appraisal Services for the Green Acres Funded Property located at 104 Disbrow Hill Road (Block 32, Lot 5)

RESOLUTION R2019-195 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, East Windsor Township is considering acquisition of approximately 3.6 acres of land at 104 Disbrow Hill Road, (Block 32, Lot 5) to preserve as open space; and

WHEREAS, the Township solicited proposals on November 12, 2019 and received three (3) proposals for appraisal services for Block 32, Lot 5 by the receipt date of November 27, 2019; and

WHEREAS, the cost proposal received from Martin Appraisal Associates, Inc. was most responsive based on the expertise, knowledge and history of appraisal services previously provided to East Windsor Township; and

WHEREAS, a contract for this purchase may be awarded without public advertising for bids, pursuant to N.J.S.A. 40A:11-3, as the purchase does not exceed \$17,500 in the aggregate for the contract year, and as the purchase is for "Professional Services" which are further excluded from the requirements of the public advertising for bids, pursuant to N.J.S.A. 40A:11-5(1)(a)(i); and

WHEREAS, this contract is awarded in accordance with the Fair and Open Process as defined in N.J.S.A. 19:44A-20.5et seq.; and

Resolution R2019-206 Approval to Execute Agreement with Middlesex County Municipal Joint Insurance Fund for Workers Compensation and Employees Liability, General Liability Coverage, Motor Vehicle and Equipment Liability Coverage, Property Damage Coverage and Environmental Liability

RESOLUTION R2019-206 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, the Township of East Windsor has participated as a member of the Middlesex County Municipal Joint Insurance Fund (hereinafter the "Fund") existing pursuant to Chapter 372, Laws of 1983 (N.J.S.A. 40A:10-36 et seq.) and is desirous of continuing said membership with the term expiring December 31, 2022; and

WHEREAS, the Township Council of the Township of East Windsor has determined that continued membership in the Fund is the best interest of the Township.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer and State of New Jersey, as follows:

SECTION 1. The Township of East Windsor hereby agrees to continue as a member of the Fund for a period of three (3) years commencing January 1, 2020 and terminating on December 31, 2022 for the purpose of securing the following types of insurance coverage:

- (a) Workers Compensation and Employers Liability
- (b) General Liability Coverage (including Public Official, Police Professional)
- (c) Motor Vehicle and Equipment Liability Coverage
- (d) Property Damage Coverage (including Building & Contents,

Automobile, Physical Damage, Contractors Equipment, and Boiler and Machinery and Public Employee Blanket Bonds)

After the expiration of the said three (3) year period membership, participation may be cancelled or extended in accordance with the By-Laws of the Fund.

SECTION 2. For the purposes of contribution of sums into the Fund to be designated for administrative costs and claims, the Township of East Windsor hereby agrees to obtain the types of coverage from the Fund as set forth in Section 1 of this Resolution and the Indemnity and Trust Agreement to be signed by it.

<u>SECTION 3.</u> The Bylaws of the Middlesex County Municipal Joint Insurance Fund, attached hereto, are hereby adopted and accepted.

SECTION 4. The Governing Body is hereby authorized and directed to execute an Indemnity and Trust Agreement signifying continued membership.

Mayor Mironov stated this Resolution had been carried from the last meeting and Council had now received a memorandum dated December 11 with additional information on the matter addressing the premium amount. She stated previous information indicating that there was no increase in the premium was not true, and the premium had in fact increased. She stated the memo includes a chart showing the increases in different coverages.

Mayor Mironov stated she had several questions. She asked Mr. Brand if there were any changes in the documents Council should be aware of. Mr. Brand said there was not. Mayor Mironov asked if the documents were identical to the documents reviewed by Council three

years ago and Mr. Brand stated that they were. Mayor Mironov stated she wanted it noted this is a three year agreement and a reminder should be calendared in the spring prior to the expiration so the Township can determine if there are other options to explore, such as co-ops or private insurance. She stated the Township did not have any options in this instance because the renewal was not calendared and was brought to Council's attention after the sixty day notification to cancel requirement had already lapsed. Mayor Mironov asked whether there are any other benefits or training they can provide to the Township. Mr. Brand stated they do provide training on site as long as thirty people attend, or the Township can send people to other locations to attend training sessions. Mayor Mironov asked if the Township takes advantage of training, because she did note an increase for worker's compensation. Mr. Brand stated the Township has not been taking full advantage of those benefits. Mayor Mironov stated the Township should be exploring those opportunities in regards to better training, and someone should be cataloguing incidents to see if there are ways the Township can mitigate those issues and reduce incidents. She stated sometimes attending training can also lead to discounts, so this is something the Township should take a much closer look at those opportunities. Mayor Mironov asked who is the current Township representative and Mr. Brand stated he is currently acting as the representative. Mayor Mironov stated she wants to know who the Township representative and alternate representative is and requested that information be given to Council. Mr. Zoller asked why the automobile liability premium had gone down, and asked if the Township had fewer cars to cover. Mr. Brand stated the company goes through the reinsurance market on a national basis in order to find a good price. He stated some prices have come down, but the biggest increase was in property and equipment coverage at 11.24%, due to the new fire truck the Township purchased.

The memorandum of understanding was done at the Township's request so there was a clear understanding as to the limits of the nutrition program in terms of use of space and programming prerogatives. Mayor Mironov stated the program takes place in the East Windsor Senior Center but is open to non-residents by law. She stated now that she has a copy of the memorandum, she would like the chance to revisit it, and would ask the Township Manager to look at it as well and to have a conversation with Senior Center staff to see if there are any issues that have arisen in the last couple of years with the nutrition program's use of space, programming, or any other aspect. Mayor Mironov stated she wanted to further circumscribe the memorandum in terms of their use of the Township's Senior Center as she was aware of some recent issues with participants in the nutrition program trying to utilize other programs in the Senior Center although they are not residents. She stated she thinks the nutrition program is a fine thing to do, but because she has received complaints, they should look to see if there had been any other issues and the memorandum of understanding should be circumscribed more. She asked that this be listed on a future agenda with more information.

Mayor Mironov stated a memorandum from the Finance Director was received regarding the transfer for the Tax Assessor and a memorandum from the Township Manager was received regarding the electric costs. She stated the question regarding the electric costs came up at the beginning of the year, as they have been experiencing high electric costs in both the Municipal Building and the Police/Court building. She stated the information received was helpful and she wanted to make sure everyone had reviewed the materials and if there were any questions. Mayor Mironov stated that she wanted to be clear that when Council considers the budget for next year, she is not going to budget what was spent this year in electric costs and she wanted to warn everyone that was her point of view on the matter. She stated she did not want to add the cost to the budget when the Township put in a new system to be cost effective and to have more control over the heating and cooling systems in both buildings, so it does not make sense that there is a hike in the electrical bills. She stated the memo included some good ideas to gain better control over the electrical costs that need to be instituted and monitored as she, for one, will not support increasing the budget costs to cover higher electrical costs. She stated that she has no trouble with the request for transfer regarding the Tax Assessor's office tonight, and while

she assumes Council will have to do a transfer on the electrical costs at a future meeting, she wanted to be clear as to her feelings on the matter.

She stated this Resolution and agreement is for 949 Windsor Perrineville Road, which the Ordinance regarding

the property acquisition was approved tonight. Mayor Mironov stated she did not want to hold this up, so while the full agreement is not attached, she would ask for a motion and vote subject to attaching the full agreement, so anyone looking for the Resolution in the future will see the full document. She stated that this is good news, the Township negotiated a really good deal for the property and this grant award will more than cover the cost of the acquisition.

Mr. Yeager stated that the Municipal Alliance for the Prevention of Substance Abuse met on December 11 and discussed the grant application they are currently working on. He added Mercer County is sponsoring a dinner on January 8, and members gave updates on what they are working on. He stated on the same day, the Recreation Commission met and discussed after school projects, winter bus trips, 2020 Summer Camp and other special events.

CORRESPONDENCE:

APPOINTMENTS:

Mayor Mironov appointed the following East Windsor Regional School District Highstown High School students to the following Boards and Committees: Akul Solanki as a student member of the Environmental Commission; Maanasi Balasubramanian as a student member of the Clean Communities Committee; Ameya Keertikar as a student member of the Environmental Commission; Hayden Bandel as a student member of the Recreation Commission; Alisha Greenstein as a student member of the Commission on Aging; Shruti Nagpal as a student member of the Health Advisory Board, and Jerry Ford IV as a student member of the Clean Communities Committee.

APPROVAL OF BILLS:

Mayor Mironov stated a 2019 Current Bill list, 2018 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mr. Zoller asked about the status of a bill on the 2019 Current Bill List, on page 18, the third bill listed. Mayor Mironov asked if a report had been received on that matter. Ms. Daniels stated she did not think so. Mr. Zoller stated Council had bene requesting that report for three months. Mayor Mironov agreed with Mr. Zoller and asked again the report be provided.

Mayor Mironov stated on page three of the 2019 Current Bill List is an invoice for the Primary Election printing for \$12,555. She asked that the bill be held and requested to know exactly what printing the Township is paying for and what was budgeted in the prior year.

Mayor Mironov stated regarding the different agencies, she assumes that the Manager and Finance Director are on top of everything and if any item is being listed on the Council agenda that it has been reviewed in accordance with the Township's policies and Council is able to take action.

It was MOVED by Lippman, SECONDED by Rosenberg to approve the Bill Lists with the clarifications and holds.

There being seven (7) ayes, and no (0) nays, the various presented Bill Lists were approved with the clarifications and holds.

MATTERS BY COUNCIL:

Mayor Mironov noted receipt of the following correspondence: a report of receipts from the Tax Collector for the period ending November 30; a copy of a letter she sent to the Executive Director of the Municipal Utilities Authority regarding noticing residents on hydrant flushing as discussed at a prior Council meeting; a memorandum, dated December 11, from the Finance Director with a report on the award of sale of bond anticipation notes, which Mayor Mironov noted that with the premium the Township received, the net interest cost was 1.26925, which is really excellent and reflects the Township's good work and high rating. She added that the Finance Director was advised that the purchaser of the note wanted to get them rated, and they were rated SP-1 by Standard and Poor's, which is the highest rating. She continued that Standard and Poor's affirmed the Township's bond rating and made lots of positive comments on the financial condition of the Township and their fiscal policies, planning, and robust revenue generation.

Mayor Mironov continued and noted receipt of the following correspondence: a letter dated November 21 from NJDOT awarding the Township \$600,361 for Exeter Road and the surrounding area; a letter from RISE regarding solicitation and thanking the Township for their support; a memorandum from the Assistant Township Manager regarding the intersection improvements for Route 130 and Hankins Road and Payment #3, which was listed on tonight's

Bills List; a memorandum from the Director of Public Works dated November 23 following up on the Police/Court Building roof; a memorandum from the Director of Public Works dated November 27 addressing questions raised by Council at the last meeting, including questions on the Mercer Spring invoices, as well as an explanation to the Manager's Office regarding the electric bills. Mayor Mironov stated she wanted to remind members that when a response is provided to Council from a department, unless there is an objection and the response is satisfying to Council, the bill is free to be listed or paid. Mr. Lippman asked if the Township has a maintenance contract for the air conditioning system at the Police/Court Building, as the system is only three years old and is already in horrible shape. Mr. Brand stated that the Township does, but just for emergency maintenance, not preventative maintenance. Mr. Lippman stated that he believes Council should consider looking into that for next year's budget. Mayor Mironov asked for further feedback as to who is supposed to be overseeing the air conditioning system and what, if anything, needs to be done to make sure it is properly maintained. Mr. Lippman stated that he was sure the system was under warranty for the first year so it was being maintained at that point, meaning it went downhill over the last two years, so this really does need to be examined. Mayor Mironov asked for more details as to exactly what the issues are, how serious they are, and what the condition of the system really is, in addition to all of the other questions Council has asked.

Mayor Mironov stated a memorandum dated December 9 from the Chief of Police regarding the battery bills was also received.

Mayor Mironov stated she has not heard anything in months regarding Anker Park and the Mercer at Play grant. She stated she is unaware who is handling the project and what they are doing. She asked for an update as to when Council will get that information, including who is handling the project, and a full proposal for Anker Park, the grant match, and the use of the grant. She stated Council would like to have this done for the spring.

Mayor Mironov stated that Council members received a copy of the proposal dated December 9 from Dan Dobromilsky for the Arboretum at Etra Lake Park. She asked the matter be listed on the next Council agenda. She added that her sense from the proposal is that a meeting with Council and the Environmental Commission should be held sometime next month, minimally to discuss how the Township will move forward on this project. Mayor Mironov stated that Council will see she had a discussion with Mr. Dobromilsky and she asked him to include various options in the proposal, including a restart on the project, and she thought it was important that Council and the Environmental Commission review the proposal and the options. She stated she also asked staff to put together an interim report, which is due to Sustainable Jersey by January 31.

Mayor Mironov stated that she received notification on December 3 that the Township has been awarded a grant under the New Jersey USCF Stewardship Program for \$30,000 for the Township's tree program. She asked that the application be pulled and staff follow up on what needs to be done and how the grant should be utilized. She added that the grant could potentially be intermixed with the Arboretum project.

Mayor Mironov stated a memorandum dated December 17 from the Director of Public Works was received regarding two matters that requires Council's attention. One matter is Woods Road Park and the other is Westfield Road Park. DPW is recommending the removal of one of the three gazebos at Woods Road Park, as it is not in good condition. Mayor Mironov stated she personally supports that, as long as Council has no issues. The second matter is regarding the Public Works Director's recommendation to remove the handball wall at Westfield Road Park. Mayor Mironov stated she does not support that at this time, as she thinks there is no basis provided for that recommendation. She stated that the Director is recommending the removal of the wall rather than making a few repairs, as it is his opinion no one uses it. She stated that it is her personal opinion to not be so quick to remove it without a real basis for the removal, and the matter could always be discussed again in the future.

Mayor Mironov stated a report dated December 2 from ACT Engineers was received regarding Magnolia Ridge. She asked when Magnolia Ridge would be finished, as now it appears it will not be finished by the end of this year. Mayor Mironov asked Mr. Orron if there was anything more the Township needed to do on this. Mr. Orron stated the work on the paving was deferred until the spring. The detention basin improvements were supposed to be completed by December 16 but he had not heard from Jeff Richter at ACT Engineers. Mr. Orron stated that he will follow up to get an update on the paving and the landscaping work. Mayor Mironov stated that a lot of major work is still outstanding, and while it is obvious the paving cannot be completed at this point, the point of all of this was to get the project completed but six months have passed with major work still outstanding. Mayor Mironov asked for an update on the project and recommendations as to if there is any further action the Township needs to take.

Mayor Mironov stated emails were received by the Manager's Office in mid-October regarding the ESCNJ Energy Aggregation Programs. She had previously asked staff to look into these programs and advise Council as to what the Township needs to do.

Mayor Mironov asked for an update on The Shops at East Windsor. Mr. Brand stated a notice of violation was sent to the owner the other day with all of their violations, so they have fifteen days to comply. Mayor Mironov asked if anyone was following up on that and Mr. Brand stated he was.

Mayor Mironov stated there was another disruption on Brooktree Road by PSE&G. She wants to make sure that staff looks at that and if there is anything PSE&G needs to be required to do. She would like the matter noted and followed up on.

Mayor Mironov stated she would like to discuss at some point having an auction, as it has been about three years since the last auction. She also announced the Township will be kicking off the New Year's Food Drive on January 1, and donations will also be accepted at the Reorganization Meeting.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Route 130 Connection Bus: Proposed New Bus Stop on Lanning Boulevard

Mayor Mironov stated that she was initially contacted by New Jersey Transit on this matter, due to a letter that was received from Greater Mercer Transportation Management Association recommending the addition of a bus stop on Lanning Boulevard for the Route 130 Connection bus. She stated that she requested the item be listed on tonight's agenda to get Council thoughts on the topic and for Chief Geary to look into the matter and determine if the proposed bus stop sign location makes sense. Mayor Mironov stated if Council agrees to the bus stop signage it would require an Ordinance change. She stated adding the stop would better service East Windsor residents. She requested a memo from the Chief of Police with a recommendation regarding the bus stop and an Ordinance added on the next meeting agenda. Council agreed the bus stop is a great idea.

2. 2020 Summer Concerts and Events

Mayor Mironov stated this is the first discussion regarding the 2020 Summer Concerts and Events series, and they would have more discussions in the future. She asked that the matter be listed on tonight's agenda so everyone could weigh in with their questions and interests so they could get specific information regarding pricing and recommendations. Mr. Rosenberg suggested an Eagles tribute, as they are touring this year and there has not been an Eagles tribute in East Windsor since 2016. Mayor Mironov asked for additional information on the Eagle tribute bands. She reiterated that no decisions are being made tonight, they are just determining what acts they want to look into further. Mr. Rosenberg stated he was curious if The Bronx Wanders would be available. Mayor Mironov stated that they performed in East Windsor in 2015 and 2016 and asked for their availability. Mr. Yeager stated that they tried to get New Power Soul last year but they were booked. Mayor Mironov asked if anyone had any other groups they wanted to look at. Ms. Daniels suggested Radio Nashville to appeal to county fans. Mr. Lippman agreed. Ms. Daniels added that she noticed that a lot of past acts have been Neil Diamond tributes, so she would suggest country as something new. Mayor Mironov stated that tonight's discussion is just to get everyone's thoughts and that nothing would be debated or eliminated tonight. Ms. Daniels suggested Tusk, a Fleetwood Mac tribute band, as she saw them perform a couple of years ago and thought they were fantastic. Mayor Mironov stated that they performed in East Windsor in 2017 and asked for more information on them as well. She asked that the matter be listed on the next agenda for further discussion.

3. Dutch Neck Road/ Morrison Road Resurfacing Improvement Project: Status Report by Township Manager

Mayor Mironov stated that a memorandum from Public Works was received requesting Council authorize the payment of a road opening permit fee of \$525 in conjunction with the project, to be charged to Capital Ordinance 2017-15. She stated this would need to be listed on a future agenda but in the interest of keeping the project moving, she asked for a motion to approve the

payment for the road opening permit and to list a resolution of approval on the next Council agenda.

It was MOVED by Zoller, SECONDED by Rosenberg to approve the payment of the road opening permit fee.

ROLL CALL: Ayes – Daniels, Lippman, Rosenberg, Shapiro, Yeager, Zoller, Mironov Nays – None

There being seven (7) ayes, and no (0) nays, the payment of the road opening permit fee was approved.

Mayor Mironov asked that a resolution on the matter be listed on the next Council agenda for the record.

Mayor Mironov asked if this was the last item that needed to be signed off on for the project once the road opening fee is paid and the plan is provided to NJDOT. Mr. Brand stated that there are two items outstanding, one is the occupancy permit that will go to the NJDOT Operations Department, and at the same time they will be submitting the plans and specifications to NJDOT for their review. Mayor Mironov asked if the plans had not yet been approved. Mr. Brand stated that they have not been approved. Mayor Mironov stated the memo provided to Council is false. She asked if the Chief of Police had received the detour plans yet. Mr. Brand stated that he had reviewed and approved the detour plan. Mayor Mironov stated that she had not seen or heard that. Mayor Mironov stated that the Township went out to bid on the project on August 1 and the plans have still not been approved. She asked if NJDOT will have everything once the permit is filed. Mr. Brand stated that they will be sending the plans and specifications to NJDOT on Thursday. Mayor Mironov requested a copy of the transmittal and a weekly report on the project, as it has been sitting almost all year.

4. Union Transportation Trail Extension Project: Status Report by Township Manager

Mayor Mironov stated that she had not received any further information over the last several weeks on this project. She asked Mr. Brand if he had any information on this. Mr. Brand stated the only information he has is that Mike Espinoza of JCP&L would be sending a letter to the Township on the project. Mayor Mironov asked who spoke to Mr. Espinoza and Mr. Brand stated that Assistant Township Manager Jay Delany spoke with him. Mayor Mironov asked when Mr. Delany spoke with him, because she has had that information for three weeks. Mr. Brand stated he believes they spoke yesterday. Mayor Mironov stated that she had that information from three weeks ago, and any information from JCP&L should be going to Hopewell Valley Engineering, so she did not understand why they were sending anything to the Township. She stated she wants a report on the project tomorrow as to what Hopewell Valley Engineering has produced in the last sixty days on this project, as her notes indicate that nothing has been received on the project since August. She stated that when the Township met with Hopewell Valley Engineering in August, their transmittal to JCP&L had been sitting for over

sixty days and they never informed the Township they transmitted it and they never followed up on the matter when they did not received a response. Mayor Mironov stated she personally made a phone call the next day to get a response from JCP&L and have them review and approval the easements. She stated the Township should have a preliminary plan and should be trying to get construction approvals at this point, they have not received any information on the Meir's Farm, and they have not had a public information session for residents on the project yet. She stated it is extremely frustrating that the project is not moving forward. She asked Mr. Brand to share her comments with Mr. Delaney.
