AN ORDINANCE AUTHORIZING THE EXECUTION AND DELIVERY OF DEEDS TO THE STATE OF NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR PART OF LOT 40 IN BLOCK 51 AND PART OF LOT 1 IN BLOCK 46, IN CONNECTION WITH REALIGNMENT OF THE ROUTE 130/HANKINS ROAD/CONOVER ROAD INTERSECTION **WHEREAS**, the Township is undertaking a construction project to realign the Route 130/Hankins Road/Conover Road intersection along the boundary line between East Windsor Township and Robbinsville Township ("the Project"); and

WHEREAS, the Project is being partially funded through a grant from the State of New Jersey Department of Transportation ("NJDOT"); and

WHEREAS, a portion of Lot 1 in Block 46 in East Windsor Township will include a storm water retention basin to be maintained by the NJDOT and a portion of Lot 40 in Block 51 will be within the new right-of-way for Route 130; and

WHEREAS, it is a requirement of the NJDOT grant that the two properties described herein be conveyed by deeds to the NJDOT; and

WHEREAS, the Township has determined that it is the best interest of East Windsor Township that the attached deeds be executed and delivered to the NJDOT.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer, and State of New Jersey, as follows:

Section 1. Authorization to Execute and Deliver Deeds. The Mayor and Municipal Clerk are hereby authorized and directed to execute and deliver to the NJDOT the attached: (1) Deed to the State of New Jersey Department of Transportation for part of Lot 40 in Block 51, as described therein; and (2) Deed to the State of New Jersey Department of Transportation for part of Lot 1 in Block 46, both in connection with the Project and as required by the terms of the NJDOT grant for the Project.

Section 2. Severability. If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

Section 3. Effective Date. This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated that the title name needs to be corrected and few minor typos throughout the document need to be incorporated, but does not affect the Ordinance overall. She further stated that this Ordinance is in accordance with the Route 130/Hankins/Conover Road realignment project.

WHEREAS, pursuant to N.J.A.C. 5:30-7.3(f) the governing body of any municipality that qualifies for local examination may by resolution choose to have

its budget examined by the Director and not participate in the local examination process.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of East Windsor, County of Mercer, State of New Jersey, that the Township Council waives its rights to local examination of its budget and further requests that the Director of the Division of Local Government Services conduct the municipal budget examination for 2019.

Resolution R2019-044 Introduction of the 2019 Municipal Budget

[NOTE: East Windsor 2019 Municipal Budget and Garbage District Budget are located on the Township website and due to the size of the document are not included in the minutes.]

Mayor Mironov stated the introduction of the 2019 budget has come from several budget hearings, memos and corrections from various departments. The Manager's office provided a memo with a rundown of the budget as well as expenditures for the 2019 budget year. The 2019 Municipal Budget, for the seventh consecutive year, has no tax increase. She stated the tax rate will remain at \$.43 per \$100 assessed valuation based on the 2019 valuation. The average residential property tax in East Windsor Township for the municipal portion will remain at \$1,121. The East Windsor municipal component of the total local property tax bill remains at less than 15%. The East Windsor municipal tax component is among the lowest amounts in the entire region and well below the statewide average. Mayor Mironov stated the budget is a fiscally conservative document which serves well to the community and retains all existing service levels. East Windsor has worked hard to keep the spending levels tight and continually seek out additional efficiencies, cooperative purchasing avenues and service sharing opportunities, in addition to maintaining a very low debt level. The positive outcome results from the pro-active efforts of the Township to carefully plan and to closely monitor expenditures and revenues throughout the year. Mayor Mironov also noted that the Township 2019 tax base has increased by \$5 million (to \$2,816,006,710 in 2019) and also resulted in generating significant new revenue.

It was MOVED by Daniels, SECONDED by Rosenberg to approve Resolution R2019-044 and set the date of the municipal budget public hearing to April 16, 2019.

Mayor Mironov stated Resolution R2019-040 was held at the March 5, 2019 Council meeting due to questions that were raised by Council. Mayor Mironov stated a memo was provided from the Director of Public Work's but she did not recall there being side stripping on the road. Council Member Zoller stated he appreciates Mercer County paving the roadway but there is perpendicular unevenness on the road and he would like Public Works to look into this prior to approving the stripping. Mayor Mironov held Resolution R2019-040 stating Public Works needs to look into the unevenness of the road then reach out to the County prior to East Windsor doing the stripping.

WHEREAS, the maximum amount of Phase III professional engineering services is \$40,800 and funds are available in the Account No. V-20-56-852-856, entitled "Reserve for Transportation Improvements" as evidenced by the Chief Financial Officer's Certification No.T2019-003.

WHEREAS, the Mayor and Council now desire to proceed with Phase III of the project for construction management services.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Mayor and Township Council hereby authorize Maser Consulting, P.A. to proceed with Phase III of the professional engineering services agreement for the Route 130/Hankins Road/Conover Road Intersection Improvement Project, for construction management services, in an amount not to exceed \$40,800.

Mayor Mironov stated she, the Township Manager and the Finance Director met and reviewed with the companies that submitted proposals for this service. She stated the Township has the opportunity to proceed with a refunding bond on an old issue and that will save the Township over \$300,000 so she requested to proceed with this as quickly as possible. She further stated Phoenix Advisors, LLC is the company that the Township would like to maintain a relationship with for any future bond issues that they undertake. Mayor Mironov also stated East Windsor Township has a very strong profile due to their credit rating. Council Member Zoller questioned if we have used the company previously. Mayor Mironov stated East Windsor has not used them in the past.

REPORTS BY COUNCIL AND STAFF:

Mayor Mironov reported the Economic Development Committee met on March 7 and discussed the Route 130/33 art installation project and they are looking to get a list together. She stated a sub-committee, which included Council Members Denise Daniels and Perry Shapiro, Assistant Township Manager Jay Delaney, Planning Board Chairperson Edward Kelley, Environmental Chairperson Ronald Balint and Planning Board Member Barry Clark, was appointed and met with Hopewell Valley Engineering and Mercer County regarding the Union Transportation Trail. Mayor Mironov also reported she and the Township Manager Richard Brand met with the Department of Transportation Commissioner today and discussed the Airport Road intersection, the Route 33 and Airport Road extension, and Truck Route alternatives. Mayor Mironov requested the Airport Road traffic signal be listed on the next regularly scheduled agenda with a Resolution to approve the traffic signal with the 25% share being paid out of money being held by DOT for a previous project. She also stated that DOT also asked the Township to submit a concept development plan for the extension of Route 130 that they will look at and consider funding for the development of. She further stated the Township and DOT will continue discussions on the truck route alternatives. Mayor Mironov stated the last item of discussion was the bridge replacement on Route 130 Northbound that will be taking place in the near future.

Mayor Mironov stated a map and additional information can be provided but she would like to move forward due to the timeline.

4. Route 130/Hankins Road/ Conover Road Realignment Improvement Status

Mayor Mironov requested Township Manager Richard Brand update Council with the status of the wetlands permit. Township Manager Richard Brand stated Department of Environmental Protection provided an email today stating they issued an emergency authorization to proceed with the project pending the wetland permit application which is conditional on the submission of the application within 90 days.

5. Interlocal Services Agreement for Senior Services/Senior Center Agreement with Borough of Hightstown

Mayor Mironov stated a proposal was submitted from the Township Manager but the offsets were not included in those proposed costs. Council made a unanimous decision to move forward and provide the letter and agreement to Highstown Borough to continue services.
