WHEREAS, this contract is awarded in accordance with the Fair and Open Process as defined in N.J.S.A. 19:44A-20.5, et seq.; and

WHEREAS, the Settembino Architects proposal for Professional Architectural Services for the Senior Center Expansion Project provides for a base fee of \$84,500, and Option 1 civil engineering in the amount of \$23,900, for a total amount not to exceed \$108,400. Alternately, in accordance with the "June 24, 2019 – Revised" correspondence, if required and with written authorization of the Township, civil engineering option of \$32,500, for a total amount not to exceed \$117,000; and

- 3. The Municipal Clerk shall cause to be printed once, in the Trenton Times, a brief notice stating the nature, duration, service and amount of this contract, and that the resolution and contract are on file and available for public inspection in the office of the Municipal Clerk.

Mayor Mironov stated that the Township Manager's office had provided a recommendation on this subject.

APPLICATIONS:

REPORTS BY COUNCIL AND STAFF:

Mr. Shapiro stated that the Planning Board met on May 6 and reviewed an application from the Americana Hospitality Group regarding improvements to the Americana Diner on Route 130. The application was approved and the owner expects that the project will be completed in the next few weeks.

Mr. Rosenberg stated that the Clean Communities Advisory Committee met on April 25 and discussed the Recycling Day event, which was a full team effort that all members were highly involved in. They also discussed the Adopt a Spot program and the annual Business Litter Free recognition. Mr. Rosenberg added that the Commission on Aging also met on April 25 and dedicated a large portion of their meeting to updating contact information in the Senior Resource Directory.

Mayor Mironov stated that she attended the East Windsor Regional School District Curriculum Expo on April 17 at the high school. She also reported that earlier on May 7, she and Ron Balint, Chair of the Green Team and Environmental Commission, attended a Sustainable Jersey grant award ceremony at the College of New Jersey. East Windsor Township was awarded a \$10,000 grant from Sustainable Jersey for the restoration and update of the arboretum at Etra Lake Park. Mayor Mironov also announced that information was distributed in meeting folders tonight, informing Council that S&P Global Rating has updated the Township's bond rating from AA to AA+, which is an excellent rating and a major upgrade. She stated that this has been a mission of hers and while the Township was interviewing financial advisors, they had made it clear this would be an important focus of their services. She added that this upgrade is reflective of the financial management and policies of the Township and the good work of the Finance Director. The bond rating upgrade will lead to a higher level of savings and funding the Township is eligible for. Mr. Shapiro praised Mayor Mironov's efforts on this, and said that this is a terrific thing for the Township. Mr. Rosenberg agreed.

There being five (5) ayes, and no (0) nays, Resolution R2019-088 was approved.

APPROVAL OF BILLS:

Mayor Mironov stated a 2019 Current Bill list, 2018 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov asked if the Township was up to date on payments to ACT Engineers. Mr. Brand confirmed that they are.

It was MOVED by Shapiro, SECONDED by Rosenberg to approve the Bill Lists.

ROLL CALL: Ayes – Daniels, Rosenberg, Shapiro, Yeager, Mironov Nays – None

There being five (5) ayes, and no (0) nays, the various presented Bill Lists were approved.

MATTERS BY COUNCIL:

Mr. Shapiro stated that the left hand lane on Route 130 North near the American Diner is in poor shape and needs repair. Mayor Mironov requested that someone take a look at the area and contact NJDOT, as it is their road.

Mr. Rosenberg stated that a resident approached him regarding the number of pennants and flags along the small strip mall across Old Cranbury Road from the former State Police Barracks, and he had suggested they take a picture of the site and provide it to Mayor and Council to see if this is something the Township needs to handle. Mayor Mironov stated that staff would take a look at the site and see if it requires some clean up.

Mayor Mironov stated that a report from the Tax Collector and an annual report were received. Mayor Mironov noted that Mr. Shapiro had received a letter regarding his voting district, as he had been previously moved to a different district. She stated that she had provided an election district map at a previous Council meeting, but it is her understanding Mercer County has sent out letters to all voters who were improperly moved in East Windsor Township and all voters have been restored to their original voting districts. Mayor Mironov stated that a letter was received from Hickory Corner Library dated April 23 thanking the Township for the donation of the Barnes and Noble gift cards, and they would be using them for their summer reading program. Mayor Mironov announced that the Township would be having another Passport Service Day with the Mercer County Clerk's Office on June 13 from 11 AM to 4 PM at the Municipal Building. The Township just had a Passport Service Day in April, but the event was so popular that all the slots were filled within a couple of weeks of advertising the event, so the Township has decided to have another event.

Mayor Mironov asked Council Members to consider moving the June 18 Council meeting to June 25 and asked that they check their availability that day. Mayor Mironov stated that she had wanted to discuss the Magnolia Ridge project tonight, but coincidentally got a phone call from ACT Engineers earlier today on the matter. Mayor and Council had requested that ACT Engineers send a letter to the developer K. Hovnanian but apparently that did not occur. ACT Engineers has advised Mayor Mironov that a letter will be sent in the next few days. She noted that this project needs to be finished. Mayor Mironov requested an update in the next 30 days

regarding the Township's vacant and foreclosed property registration ordinance, in terms of how staff is tracking properties and an update on revenue received to date. Mayor Mironov requested an update when available on Brooktree Road and restoration by PSE&G. Mayor Mironov noted that the Chief of Police would be providing information on the Child Safety Seat Inspection program to Mayor and Council, including a program schedule and other materials in the next couple of days.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Concept Development Study of Extending Airport Road to Route 130 Grant Application

Mayor Mironov stated that she had met with the NJDOT Commissioner on this, and the Commissioner had advised the Township to submit a grant application. The NJDOT's Municipal Aid program is not open at this point, so while there are no deadlines on this they were advised to submit this application at their earliest opportunity. The expectation is that NJDOT will fund a concept development study with respect to the extension of Airport Road. Mayor and Council have received in their meeting folders tonight a memorandum from the Manager's Office and a copy of the application. Mayor Mironov stated that because these materials were received tonight, there is no way Mayor and Council can comment on the contents of the application or the amount being requested this evening. She noted that there is no doubt Mayor and Council want to file an application, so while they may take action on the Resolution tonight, they will have to take a closer look at the application and provide any comments. She asked Mr. Brand how this application was structured and how the amount was determined, and if they had reached out to anyone at NJDOT. Mr. Brand stated that the Manager's Office spoke to T&M Associates to get a quote on the approximate cost of the job to include in the application, but they did not speak with anyone at NJDOT. Mayor Mironov asked if a concept development study incorporates the engineering of the actual roadway, as that appears to be incorporated in this application. She also asked Mr. Brand if the Township is supposed to be including the cost of all of the engineering work and all of the work in conjunction with the design and engineering of the roadway in the application to NJDOT. Mr. Brand stated that he believed so. Mayor Mironov asked Mr. Brand if he spoke to anyone at NJDOT that indicated that and Mr. Brand stated that he did not. Mayor Mironov stated that they had a meeting with the NJDOT Commissioner and they had asked the Township to submit a grant application to fund a concept development study, and her understanding of a concept development was to review the feasibility of the project and evaluating potential utility placement, environmental issues and the possible location for the actual roadway. She stated that if the engineer costs should be included in the application as they are now, they should confirm this with someone at the NJDOT. Mr. Brand stated that he would reach out and confirm. Mayor Mironov stated that this should have been done prior to preparing the application. She also

commented that the application seems sparse in information and has the incorrect contact information. She requested to discuss the application tomorrow with the Manager's Office because the application must be filed this week, but Mayor and Council can take action on the resolution tonight.

Mayor Mironov requested the following changes to the Resolution: The first paragraph should read Whereas, East Windsor Township believes the extension of Airport Road westward from NJ Route 33 to Route 130 will benefit the Township circulation by facilitating traffic flow and enhancing safety in that area; and. The second paragraph should read Whereas, to further examine the feasibility and appropriate alignment for this roadway project, East Windsor Township is seeking to perform a Concept Development Study to extend Airport Road to Route 130; and. The third paragraph should read Whereas, East Windsor Township desires to request funds to hire an engineer to prepare a Concept Development Study for the extension of Airport Road to Route 130. Mayor Mironov requested that the application number and title in the fifth paragraph be confirmed. She requested that these changes be made to the Resolution, and Council consider taking action tonight as it is important to get this moving, while the Manager's Office will reach out to NJDOT to confirm if this application is responsive to the Commissioner's comments or if it needs revisions.

1. The Mayor is hereby authorized and directed to submit an application on behalf of East Windsor Township, to the New Jersey Department of Transportation for the Concept Development Study of extending Airport Road to Route 130.

2. The Mayor is hereby authorized to sign the grant agreement, if required, on behalf of East Windsor Township and her signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.

It was MOVED by Shapiro, SECONDED by Rosenberg to approve Resolution R2019-089 with changes.

Mayor Mironov stated that a request for proposals for appraisal services was sent out, and that is probably the most important item that Mayor and Council need to get done on the open space acquisition project so the Township can evaluate the properties. She stated that the Assistant Township Manager prepared a recommendation as requested, but she noted when reviewing the actual proposals that there was a difference of \$25 dollars between two appraisers and a \$200 dollar difference with the third. She stated that she is not prepared to award this tonight in light of the fact that there is a de minimus difference among the three appraisers, and some of them the Township has prior experience with. She requested that this be held until the next Council meeting.

3. Route 130/Hankins Road/Conover Road Realignment - Project Status

Mayor Mironov stated that she requested the Township Manager provide Mayor and Council with an update on the project tonight. Mr. Brand stated that Earle Asphalt Company was out on the project site and started work two weeks ago. He stated they did some stripping of the soil and found some areas that were very soft, so they had to put down two to three inch size stone to make a better bedding. They also installed about 80% of the sub-base of the roadway. Mr. Brand stated that was a conflict with JCP&L and PSE&G. There is an electric pole right in the center of the area where Hankins Road will be extended that must be relocated, and there is a sixteen inch gas transmission main that is also in the way. JCP&L will be relocating the electric pole in the next couple of weeks. PSE&G has stated that they will relocate the gas main at their own cost, but the work will take about two to three months, as they need to go out to bid for the

project and the contractor will need two to three weeks to complete the relocation. Mr. Brand stated that this will not delay the project, as Earle Asphalt Company has begun to work on other parts of the project in order to keep it moving. He stated that yesterday and today electricians were on site directional drilling underneath the roadway to pull back the electrical conduits for the traffic signals. The East Windsor Municipal Utilities Authority is paying Earle Asphalt Company to relocate two fire hydrants that are in the way of the week, and that will be completed in the next couple of weeks. Foundation and concrete work will begin soon on the site and a new traffic signal will be installed. Once the new traffic signal is operational, the existing traffic signal will be removed from the center median. Mr. Brand stated that he spoke with the project manager and they are very comfortable they will meet the anticipated project completion date.

Mayor Mironov stated that she wanted to thank Mr. Brand for staying on top of this project and recognizing how important it is. She stated that he has played a critical role in keeping the project moving. She also added that one of the Mercer at Play grant projects is improvements at Anker Park, and Mr. Brand has already started work out there. She stated that both of these projects are big priorities for Mayor and Council and she wanted thank him for his work. She also noted that as part of the improvements at Anker Park, the Township is looking at the grading out there and they are considering changing the subsurface material under the Tot Lot to something more lasting and aesthetically pleasing.

MATTERS BY PUBLIC:

No one from the public spoke.

There being no further business Mayor Mironov declared the meeting adjourned at 8:58 p.m.
