# RESOLUTION R2019-040 EAST WINDSOR TOWNSHIP MERCER COUNTY

**WHEREAS,** in November/December 2018, Mercer County resurfaced Millstone Road, however, the pavement markings and line stripping were not included in the project; and

**WHEREAS**, there is a need for line striping on Millstone Road in East Windsor Township; and

**WHEREAS**, since the purchase is under \$17,500, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500; and

**WHEREAS**, the Township Council has reviewed the Director of Public Works recommendations on this purchase; and

**WHEREAS,** the maximum amount of the purchase is \$3,652.00 and funds are available in Capital Ordinance 2017-15, Line C 04-55-980-921-890 entitled "Annual Road Program", as evidenced by the Chief Financial Officer's Certification No. C2019-003.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Township Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to Zone Stripping, Inc., 718 Jacob Harris Lane, PO Box 568, Glassboro, NJ 08028, for the purchase of 8,300 4" linear feet of white traffic line stripping in the amount of \$1,826.00 and 8,300 4" linear feet of yellow line stripping in the amount of \$1,826.00, for a total amount not to exceed 16,600 linear feet in amount not to exceed \$3,652.00 for Millstone Road, all in accordance with the attached quote.

**WHEREAS**, the Township Council has reviewed the Township Manager's recommendations on this purchase; and

**WHEREAS**, the maximum amount of the purchase is \$13,671.35 and funds are available in Capital Account No. C-04-55-980-923-541 entitled Ordinance 2019-01 "FC #2 Turnout Gear", as evidenced by the Chief Financial Officer's Certification No. C2019-011.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

Mayor Mironov appointed Lesley Gross as an Auxiliary Member of the Economic Development Committee, Nilesh Patel as an Auxiliary Member of the Clean Communities Advisory Committee, Simran Bhathal as a student member of the Environmental Commission, and Laasya Uppuluri as a student member of the Recreation Commission.

## **APPROVAL OF BILLS:**

Mayor Mironov stated a 2019 Current Bill list, 2018 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov questioned who is monitoring the two payments for ACT engineers. The Township Manager stated he will look into and ask the Director of Public Works. She asked about the two trees on the current bill list and requested that they get pulled for payment.

It was MOVED by Lippman, SECONDED by Zoller to approve the Bill Lists with the holds and clarifications.

There being four (4) ayes, and no (0) nays, the various presented Bill Lists were approved with the holds and clarifications.

## **MATTERS BY COUNCIL:**

Mayor Mironov stated the next Council Meeting is moved from June 18 to June 25, 2019. Mayor Mironov stated Clean Communities met on May 23 and discussed the April 22 Recycling event, the litter free award, new ideas for the adopt a spot and the suggestion box for the high school. Mayor Mironov stated the Deputy Municipal Clerk, Allison Quigley passed her Registered Municipal Clerk exam and will be receiving her RMC certification. She stated a letter was sent on May 24 to New Jersey Department of Transportation regarding the Twin Rivers Community Trust. She also sent a letter, dated May 29, to the Commissioner of Department of Transportation regarding the extension of Airport Road and the Township is waiting for a response. Mayor Mironov stated a May 22 memo was received from the Township Manager regarding May 21 bill list questions. Mayor Mironov stated a May 28 memo was received from the Township Manager regarding April 16 bill list questions. She stated a letter was received from Congresswoman Bonnie Watson Coleman recognizing the \$10,000 Sustainable Jersey award. Mayor Mironov stated a memo, dated May 21, was received from the Director of Public Works regarding Route 130/Hankins Road/Conover Road, which she is looking for more information on. Mayor Mironov stated two memos were provided by the Director of Public Works, dated May 3 and May 30, regarding asphalt and she stated whatever would normally be done to go out to bid needs to be done. She stated a letter, dated March 24, from Department of Environmental Protection was received and she would like Marc Liss to follow-up on the funding and have it directly verified. Mayor Mironov stated the stewardship grant application that was filed by the Director of Public Works which was agreed upon at the

last meeting. Mayor Mironov questioned the totality of trees that were down in Mercer County from the JCP&L program. Mayor Mironov stated that the NNO program was discussed and a program was put together regarding street trees and she would like that document found. She also stated now that East Windsor has appropriate people to pick the trees she would like those people added to the form. Mayor Mironov stated that East Windsor has been awarded by the Clean Communities grant in the amount of \$53,739.84. Mayor Mironov reminded Council that a passport day will be held on June 14 from 11:00 a.m. to 4:00 p.m. at the Municipal Building. She also stated a car seat program, underwritten by a state grant, kicks off Saturday June 15 at the Target parking lot plus an additional schedule will be provided that will continue throughout the next month. Mayor Mironov requested an update on the Dutch Neck Morrison Road roadwork project. Mayor Mironov stated she received some suggestions from a resident regarding the Mercer at Play Anker Park play area improvements. She stated she would like to start looking into what improvements need to be done to Anker Park in regards to grading and the tot lot area.

  - b. Transit Village
  - c. Bikeway

Mayor Mironov stated a memo was provided from the Director of Public Works regarding municipal aid. She stated the areas she would like to discuss is on roadways and bikeways. Mayor Mironov stated she had looked at prior applications and would like to get the last couple applications that East Windsor filed and look at the language that was used. She also stated she would like to get a couple of applications from surrounding towns and compare with our application to see how to make ours stronger. Council Member Zoller stated many of the streets that are listed are in very bad condition but he is looking for Cornwall Drive to be added to the list. Mayor Mironov stated she did not agree with how the Director of Public Works rated the streets in order of work needed. Mayor Mironov stated One Mile Road does not make sense to do now due to projects that are currently taking place on those roadways. She stated in order for the application to be strong streets need to be piled two applications, one for Exeter Road Berkshire Road and Stanford Court and one for Oak Branch Road along with Rocky Brook Road and one of the connector roads. She stated this also needs to be listed on the next regularly scheduled meeting.

Mayor Mironov stated there was only one bikeway choice provided and she is looking for more options. She also questioned if the bikeway grant program is federally funded.
