WHEREAS, these computer and network maintenance services are of a specialized and qualitative nature because they are based on the specific expertise for East Windsor's computer and network maintenance services and as such have been determined by the Township Manager to be an extraordinary and unspecifiable service; and

WHEREAS, N.J.S.A. 40A:11-5(1)(a)(ii) of the Local Public Contracts Law exempts extraordinary unspecifiable services from competitive bidding; and

WHEREAS, the Township Council has reviewed the Township Manager's recommendations on this purchase; and

WHEREAS, the maximum amount of the contract is \$19,380.00 and funds are available in the Current Fund Account No. 9-01-20-140-140-245 entitled "Data Processing," as evidenced by the Chief Financial Officer's Certification No. B2019-030.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

Mayor Mironov reported that the Economic Development Committee met on September 5 and discussed several subjects including an entrepreneur type of event, sponsorships for the gateway signs for the town and promotional information that should be given out at National Night Out.

RESOLUTION R2019-150 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year 2018 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34; and

as evidenced by the group affidavit form of the governing body; and

WHEREAS, such Resolution of certification shall be adopted by the governing body no later than forty-five (45) days after the receipt of the Annual Audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with at least the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgation's of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000) or imprisoned for not more that one (1) year, or both, in addition shall forfeit his office."

NOW, THEREFORE, BE IT RESOLVED, that the Township Council of the Township of East Windsor, hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968, and does hereby submit a certified copy of this Resolution and the required affidavit to said Board to show evidence of said compliance.

East Windsor Township Auditor, Bud Jones from Nisivoccia and Company, LLP, reviewed the 2018 Audit and stated East Windsor Township is in great financial state and the Mayor and Council and officials have done a great job with preparing the budget and overseeing and managing expenditures and revenues.

Mayor Mironov stated staff needs to obtain the financial statement from the JIF.

*Matters by Council

Mayor Mironov stated a letter was received May 24, 2019 from DEP for the NNL program and she requested, from three prior meetings, a report on how it is being handled. The Director of Public Works stated he will be providing a report to Mayor and Council. She requested that the Township Manager get a schedule and update on Brooktree Road. Mayor Mironov stated that there has not been a Township auction in over three years and she would like a plan within the next ninety days. Mayor Mironov requested that the Director of Public Works get someone out to fix the safety issue with the north bound left turn lane going into the Town Center Shopping Center. Mayor Mironov requested that if it is not taken care of, she would like it listed on the October 15 Council meeting. She further requested information on Resolution R2019-139 for asphalt, which was on a previous agenda and information has still not been provided. The Director of Public Works stated he will have a recommendation memo to Mayor and Council by Friday, September 13. Mayor Mironov requested to list the Resolution on the October 15 Council agenda hopefully for action. Mayor Mironov stated on One Mile Road South past the police building there is a huge hole in the road that is a safety issue and needs to be taken care of immediately. Mayor Mironov stated staff needs to follow up on the Sustainable Jersey grant and double check the timelines to ensure we are on track.

2. Improvements to Route 133 and Route 571 Intersection Signalization

Mayor Mironov stated a host of letters were received from Earl Jacobs as well as New Jersey Department NJDOT and the Chief of Police has provided a letter on the subject to Mayor and Council. She requested that the Clerk prepare a draft letter to Mercer County regarding the safety issue.

3. New Jersey Department of Community Affairs Small Cities Public Facility Grant Program

Mayor Mironov stated an updated application was provided in Mayor and Council folders for tonight's meeting. The Assistant Manager stated that thanks to the Mayors effort, the application has been expanded to include the areas of concern and he believes the application is strong and addresses all criteria that is necessary to receive an award. Mayor Mironov stated the application deadline is Friday, September 13, so the Resolution needs to be approved but Council can further review the application for additional changes. Mayor Mironov further stated the Resolution needs to read more like the Township's normal format.

WHEREAS, on August 4, 2009, the Township Council approved by Resolution R2009-178, a professional services agreement with Maser Consulting, P.A. for engineering services for Phase I, II and III of the Route 130/Hankins Road/Conover Road Intersection Improvement Project expressly conditioned that Phase II and Phase III could proceed only upon further action and written authorization of the Township Council; and

WHEREAS, on August 4, 2009, the Township Council, as approved by Resolution R2009-178, authorized Maser Consulting, P.A. to proceed with Phase I only for preliminary engineering; and

WHEREAS, on April 3, 2012, the Township Council, as approved by Resolution R2012-070, authorized Maser Consulting, P.A. to proceed with Phase II only for final design, permits, and bidding process, in accordance with the professional services agreement; and

WHEREAS, on March 19, 2019, the Township Council as approved by Resolution R2019-050, authorized Maser Consulting, P.A. to proceed to Phase III for Construction Management Services; and

WHEREAS, the Township needs to amend the professional services agreement with Maser Consulting, P.A. for engineering services, due to the additional requirements by New Jersey Department of Transportation and the work required by Maser Consulting, Inc, to increase the current contract by \$97,920 from \$40,800, for a total amount not to exceed \$138,720, and in accordance with the Consultant's Proposal, dated August 30, 2019 attached as "Exhibit A"; and

WHEREAS, the amount of compensation authorized under this Amendment to the Agreement for professional services with Maser Consulting, P.A. is \$97,920, for a total amount not to exceed \$138,720 and sufficient funds are available in Budget Account No. V-20-56-852-856 entitled "Reserve for Transportation Improvements", as evidenced by the Chief Financial Officer's Certification No. T2019-013.

WHEREAS, the Township Council has reviewed the Director of Public Works recommendations on this purchase; and

WHEREAS, the maximum amount of the purchase is \$4,600 and funds are available in Capital Fund Account No. C-04-55-980-919-437 entitled, Capital Ordinance 2016-08 entitled "Police/Court Building Roof," as evidenced by the Chief Financial Officer's Certification No. C2019-014.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Township Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to Tectonic Engineering Consultants PC, 3951 Westerre Parkway, Suite 160, Henrico, Virginia 23233, for engineering consulting services for a visual roof inspection

and report and a thermal scan observation for the police/court building roof, for a total amount not to exceed \$4,600, all in accordance with the attached quote.

6. Anker Park Improvements (Mercer County at Play Grant Program)

Mayor Mironov stated a discussion took place at the July 23 Council meeting with several questions regarding the Anker Park improvements including pricing and some differences between the tot lot surfaces. She stated follow-up needs to be done with other municipalities with pictures and a memo outlining answers to the questions that were raised. The Director of Public Works stated pictures and follow-up are being done and a memo will be distributed to Mayor and Council once complete. Mayor Mironov stated she would also like some recommendations on how to use the money to make other park improvements and she would like information on how DPW is moving forward. The Director of Public Works stated he will have the memo with the details by next week.

7. New Jersey Department of Transportation Grant Award for Probasco Road Freight Bypass Project

Mayor Mironov stated this grant award was unexpectedly received from NJDOT and the Township now needs an idea on how to use the money. She further stated she would like to develop a list of local professionals and property owners to meet and brainstorm ideas and a plan and concept on how we would be able to utilize the funds. Council Member Yeager asked if there was a time that the grant must be used by. The Assistant Manager stated the project needs to be complete within three years. Mayor Mironov requested staff to provide a potential list of people that could possibly add ideas and input into a project.

8. Dutch Neck Road/ Morrison Road Resurfacing Improvement Project – Report by Township Manager

Mayor Mironov stated that the project went out to bid on August 1, but had not been submitted to the NJDOT for approval. The Assistant Manager stated it went to NJDOT afterwards for approval but they required several changes and the Township revised and resubmitted to NJDOT and are awaiting approval of revised plans and specifications. Mayor Mironov questioned why the plans were not sent to NJDOT prior to going out to bid. The Director of Public Works stated

the specifications did go to NJDOT prior to the bid notice. Mayor Mironov stated the specifications were sent the same day that the bid notice went out and she does not approve of the process that took place. The Assistant Manager stated the project is now on hold until approval is received from the NJDOT. Mayor Mironov stated that the purpose was to get the project done prior to the cold weather setting in. The Director of DPW stated the project will get done prior to the cold weather setting in. Mayor Mironov did not see how that would be possible considering the timeline. The Assistant Manager stated once approval is provided by NJDOT he will notify Mayor and Council of the steps to follow.

9. East Windsor Township Public Transportation Program and Funding – Report by Township Manager

The Assistant Manager stated historically the grant application paperwork is in place in late August. He further stated there are three components of the public transportation program and funding which consists of the Interlocal shared services agreement with Mercer County and Hightstown Borough and the grant agreement. He stated that everything has been completed by the Township and we are still waiting on the grant agreement approval from Mercer County. He further stated once the grant agreement is received, all three Resolutions can all be listed on an upcoming agenda.
