Human Trafficking Awareness Month - January 2020

Mayor Janice S. Mironov, joined by Womanspace Executive Director Patricia Hart and Chief of Police James Geary, issued a Mayoral Proclamation recognizing January as Human Trafficking Awareness Month. #### TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER ORDINANCE NO. 2020-01

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER X, "TRAFFIC," SECTION 10-8, "BUS STOPS," SCHEDULE X, "BUS STOPS," OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR, TO ADD A BUS STOP ON LANNING BOULEVARD

#### BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST

WINDSOR, as follows:

<u>SECTION 1.</u> Chapter X, "Traffic," Section 10-8, "Bus Stops," Schedule X, "Bus Stops," is hereby amended and supplemented by the addition of the following Bus Stop:

# 25. Along LANNING BOULEVARD, on the Northbound side, 75 feet South of the access road to the Municipal Building.

**SECTION 2.** All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

**SECTION 4.** This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated the Ordinance was introduced at the meeting of January 14, 2020 and the Public Hearing set for tonight. Mayor Mironov declared the public hearing open on Ordinance 2020-01. With no comment from the public being made, Mayor Mironov declared the public hearing closed.

Mayor Mironov suggested in Section 25 of the Ordinance that it read as "Access Road", which allows it to read better.

[NOTE: Revision is reflected in the above Ordinance.]

It was MOVED by Lippman, SECONDED by Daniels to adopt Ordinance 2020-01 and authorize publication as required by law with the minor grammatical change.

There being six (6) ayes, and no (0) nays, Ordinance 2020-01 was adopted and publication authorized as required by law.

Mayor Mironov moved up item #7, "Union Transportation Trail Extension Project: Status Report," under Discussion Items to this part of the meeting since East Windsor resident John Lucs wanted to speak on the Union Transportation Trail.

Mayor Mironov stated a grant was received from the Delaware Valley Planning Commission in the amount of \$135,000 for preliminary design and engineering for the Union Transportation Trail Project. She further stated that the Township went out for RFP and Hopewell Valley Engineering was hired for the preliminary design and engineering for the project. Mayor Mironov stated a working committee has met several times with Hopewell Valley Engineering the last time was August of 2019. She stated at that time Hopewell Valley Engineering was working with JCP&L to get the access easements approved for the railroad right of way with the surrounding homeowners to confirm they had to access to the right of way for the Union Transportation Trail. She state at the moment the Township is awaiting to hear back regarding those issues and how to move forward. She stated she is very eager to get the project moving and get this portion completed. Mayor Mironov stated Township Officials, Mercer County Planning Department and Hopewell Valley Engineering will be speaking via teleconference this week to identify what the remaining tasks are and where they are in the planning to complete the project. Mayor Mironov stated, in the interim, the New Jersey Department of Transportation Commissioner was in East Windsor on January 22 and held a press conference announcing East Windsor was being awarded a \$450,000 grant from the New Jersey Department of Transportation bicycle program towards the construction for the Union Transportation Trail extension. Mayor Mironov stated the Commissioner was very supportive of the project and she expressed she would ensure that the project would be completed. Mayor Mironov stated Mayor and Council is energized because the funding seems to be available to move the project forward to finish the preliminary engineering and design to get the project completed. Mayor Mironov stated once the easement agreements and sign-offs are completed a public meeting will be held to share the preliminary design with the community to get feedback. She stated once all the preliminary details have been figured out then the Township will go out to bid for engineering and construction. Mayor Mironov stated in the course of the preliminary engineering there may be a few property acquisitions outside of the JCP&L property and the process will be provided on how to proceed with those properties.

John Lucs asked how the property located at 111 Old York Road will be affected and if they are looking at an alternative on how that will cut through the property to Working Dog Winery. Mayor Mironov stated that subject will be discussed during one of the upcoming meetings and someone from the Township will get back to him on that once they determine. Mayor Mironov stated she has taken a more active role on the project and all of the steps will be identified within the upcoming weeks.

Council Member Rosenberg reported the Clean Communities Committee met on January 23 for the Adopt a Spot event at the Senior Center, which was a great event. Mayor Mironov stated six student volunteers were at the event and the Director of Public Works expressed how educated the students were and how they truly help benefit the Township by volunteering. Council Member Rosenberg further reported that the Commission on Aging also met on January 23 and discussed the senior center members are currently at 1700 and growing, the budget, the resource directory and the new student member. Council Member Zoller stated on January 15 the Environmental Commission met and discussed the Urban Renewal Forestry Program accomplishment, which, he noted, needs to be filed by the end of the week. Mayor Mironov requested further information on the filing. Mayor Mironov stated on Saturday the East Windsor Volunteer Fire Co. #2 held their installation dinner, which most of Council attended. Mayor Mironov noted that it was a great event as always and that Chief Batista will continue on in his role and Ben Thornton stepped back and was replaced by new President Gino Esposito. It was further noted that Ben Thornton will remain involved with East Windsor Fire Co. # 2. Mayor Mironov reported that she attended the Mercer County Municipal Alliance dinner event.

# **CORRESPONDENCE:**

Mayor Mironov reminded everyone that the East Windsor food drive continues through the end of January to benefit Rise and St. Anthony's. Mayor Mironov stated East Windsor Township and the New Jersey State League of Municipalities have teamed up to provide a statewide competition for high school Junior and Senior students to submit an essay centering on the theme "*What My Municipal Government Does Best*" and seeking to advance the virtues of elected and volunteer members of the community, while raising awareness of municipal government in general. Essays will be accepted through March 11, 2020. Mayor Mironov stated a memo, dated January 17, from the Township Manager was provided to Mayor and Council regarding the status Hankins/Route 130/Conover Road project. Mayor Mironov stated a memo, dated January 22, from the Township Manager was provided to Mayor and Council, regarding payment number 4 on the Hankins/Route 130/Conover Road project. She stated a memo, dated January 7, was provided to Mayor and Council from the Director of Public Works providing information on the prior Township road project involving Brooktree Road and Wiltshire Drive and she is anticipating that another memo will be provided regarding this because action is required. A memo to Mayor and Council, dated January 7, from the Director of Public Works was provided on the Township roadway project for

Cypress and Woodland Drive and she is anticipating another memo will be provided regarding this because action is required by Finance Department. Mayor Mironov stated a memo, dated January 7, from the Assistant Township Manager regarding payment 3 and 4 from Settembrino Architects. Mayor Mironov stated a letter, dated January 14, from New Jersey Department of Transportation was provided regarding roadway striping and the installation of a traffic signal at the intersection of Airport Road and Route 33. Mayor requested that the Chief of Police look into the letter and request. Mayor Mironov stated a letter, dated January 21, was received from NJFEC regarding the plastic bag bill that is being discussed by the State.

Mayor Mironov stated a memo, dated January 22, was provided regarding her appointments for the 2020 Local Emergency Management Planning Committee. Mayor and Council had no comments regarding for the appointments.

# **APPROVAL OF BILLS:**

Mayor Mironov stated a 2019 Current Bill list, 2020 Current Bill list, a Capital Bill List, a TIP bill list, all dated January 23, 2020, and other miscellaneous bill lists and trust accounts were provided.

Council Member Zoller was looking for clarification on Current 2019, page 12, the unusually large bill under motor vehicle supplies; almost \$4,000.

Mayor Mironov held the two bills payable to Earle Asphalt regarding Hankins/Route130/Conover Road Project; one was on the capital bills list and the 2<sup>nd</sup> was on the TIP bill list. Clarification requested on why two bills and is amount correct? In addition, Mayor Mironov questioned why is \$191,000 plus charged to Capital? Mayor further stated that it should be charged to grant or developers account; and asked it get applied accordingly. She further held the bill on the 2019 current bills list regarding the master plan and requested confirmation of amount and also that there were no other bills paid on that project.

# MATTERS BY COUNCIL:

> Mayor Mironov stated two issues need to be raised from the previous Council meeting. She stated Resolution R2019-191 awaiting follow-up from the Director of Public Works on the repairs to the tot lot at Wiltshire Park. She also stated she is looking for a status on the Anker Park Mercer at Play, the Shoppes at East Windsor project, Magnolia Ridge and the \$30,000 Urban Forestry grant action plan. Mayor Mironov stated in Council folder for tonight's meeting is Resolution R2020-15 for the purchase of the garbage trucks. She stated at the previous meeting the source of the state contract was questioned and after the Clerk and the Director of Public Works clarified the source the Resolution and contract needed to be corrected. Mayor and Council agreed to approve revised Resolution R2020-15. Mayor Mironov stated Ed Kelly, Chairperson of the Planning Board questioned if the Township has an Ordinance for recycling in multifamily complexes. She requested staff to look into this and confirm that the Township does have an Ordinance in place. She further requested staff to look into the striping on Ward Road due to complaints regarding safety from Meadow Lakes residents. Mayor Mironov stated that a reminder came up on the Clerk's calendar regarding the Patel Subdivision and the potential for a sidewalk. She stated it was brought up at a previous Council meeting to look into and she is looking for a status on that or re-calendar for a later date. Mayor Mironov requested that the open space acquisitions including 104 Disbrow Hill Road, 641 Etra Road, 949 Windsor Perrineville Road and 820 Windsor Perrineville Road need to be listed on the next Council meeting agenda to get them moving forward.

# DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. East Windsor Senior Center Expansion – Concept Proposals

Mayor Mironov stated in Council folders tonight is a copy of the presentation that was held at the senior center and information from the architect from the last Council meeting. Mayor Mironov put up the exhibits of the proposed plan and elevations for comments. Comments were solicited from Council Members who all unanimously spoke about the potential flexibility of use and maximizing of space. It was noted also that there is much enthusiasm from the senior center members and they are very pleased to be involved in the process and also with the concepts presented. Mayor Mironov also mentioned that the Township will be receiving additional funding for the senior center project from Department of Community Affairs Small Cities grant in the amount of \$400,000.

# RESOLUTION R2020-028 EAST WINDSOR TOWNSHIP MERCER COUNTY

**WHEREAS**, there is a desire to award a contract for the Independence Day fireworks display scheduled on Thursday, July 2, 2020 with a rain date scheduled for July 11, 2020, to be held at Etra Lake Park in the Township of East Windsor; and

**WHEREAS**, five (5) quotes were solicited and two (2) written quotes were obtained to provide this service; and

WHEREAS, the responsive cost proposal was submitted by D & M Fireworks; and

**WHEREAS,** since the purchase is under \$17,500, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500; and

**WHEREAS**, the Township Council has reviewed the Township Recreation Director's recommendation on this service; and

**WHEREAS**, the maximum amount of the contract is \$13,000.00 and funds are available in the Recreation Trust Account No. R-14-20-370-800-000 entitled "Recreation Events", pending adoption of the 2020 budget, as evidenced by the Chief Financial Officer's Certification No. T2020-001.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to: D & M Fireworks, LLC, P.O. Box 503, Bally, Pa. 19503, for the Independence Day fireworks display scheduled for Thursday, July 2, 2020, with a rain date scheduled for July 11, 2020, in an amount not to exceed \$13,000.00.
- 2. The Fire Official is authorized subject to compliance with all applicable regulations to issue said permit pursuant to section 5:18-2.7(a) 5.iii. of the Uniform Fire Code of the State of New Jersey, and to enforce the time limit on discharge of fireworks.

Council Member Zoller requested information on "Radio Nashville" and Council Member Yeager suggested an "Elton John" Tribute Band for consideration.

4. Township Gun Lock Safety Program

Mayor and Council agree to move forward with the Gun Lock Safety Program in March.

5. Township Auction

Mayor Mironov stated that the Community Development Coordinator, Robert Goodman provided a memo with information regarding both Govdeals and Municibid for discussion. Mayor Mironov noted that the Township had used Govdeals in the past and asked if there is there any difference between the two options. Robert Goodman commented that the difference is in the compensation structure and the Govdeals uses a tiered compensation system based on number of lots at auction and generally has higher rates. Municibid relies on buyer premium and there is zero out of pocket from Township. Council Member Yeager questioned if the Township reserves the right to accept or reject the highest bids. Robert Goodman commented that yes the Township can reject the highest bid. Mayor Mironov has requested that language with clarification regarding this concern be submitted in a follow-up memo.

The recommendation was by Robert Goodman and Township Manager, James Brady to try both versions of auctions; smaller items on-line and larger items at a live auction with auctioneer was agreed by Mayor and Council and will be moved to an action item for an upcoming meeting agenda when clarifications, resolution, contracts etc. are ready next meeting agenda.

6. Dutch Neck Road/ Morrison Road Resurfacing Improvement Project: Status Report by Township Manager

Township Manager, James Brady, noted that there was no new information from Department of Transportation and he will follow up with them as requested by Mayor Mironov.

7. Union Transportation Trail Extension Project: Status Report

Discussion was held in the beginning of the meeting.

Marc Platisky requested that the Township research and consider a "Broadway" Themed Summer Concert.
