CALL TO ORDER:

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 5:30 p.m. on Tuesday, December 8, 2020.

VERIFICATION:

Municipal Clerk Kelly Lettera certified that the meeting was noticed on January 10, 2020 in the annual meeting notice and on December 4, 2020, notices were sent to the Trenton Times, filed in the office of the Municipal Clerk and posted in the East Windsor Municipal Building. All requirements of the open public meeting act have been satisfied.

FLAG SALUTE: Led virtually by Council member Alan Rosenberg.

Present were Council Members Denise Daniels, Marc Lippman, Alan Rosenberg, Perry Shapiro, Peter Yeager, John Zoller and Mayor Janice Mironov. Also present were Township Attorney David Orron, Township Manager James Brady and Municipal Clerk Kelly Lettera.

PUBLIC FORUM:

John Ahern of 20 Wyndmoor Drive asked who is responsible for maintaining the streetlights along Windsor Center Drive, as some of the lights are out. Mayor Mironov stated she received his voicemail on the matter and shared it with the Manager and asked Mr. Brady for an update. Mr. Brady stated that the streetlights are supposed to be maintained by the property owners, but the property recently changed ownership and he is working to clarify that with the new owners by going through the original developer's agreement and Planning Board documents. Mayor Mironov stated that used to be acknowledged as the property owner's responsibility and that they were working on resolving the issue and they would follow up with Mr. Ahern on that.

Mark Platizky of 783 Twin Rivers Drive asked for an update on a letter sent by Twin Rivers Trust regarding yellow curb lines. WHEREAS, as part of the normal annual winter activation process, SG Heating and Air Conditioning tested the air quality and determined high levels of carbon monoxide were being produced by the furnace at the Municipal Building; and

WHEREAS, a diagnosis determined the Municipal Building furnace was malfunctioning and in need of repair including parts replacement; and

WHEREAS, since the purchase is under \$17,500, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500; and

WHEREAS, the Township Council has reviewed the Township Manager and Director of Public Work's recommendation on this purchase; and

WHEREAS, the maximum amount of the purchase is \$8,225.00 and funds are available in the Capital Fund Account No. C-04-55-970-918-424 entitled Capital Ordinance 2015-09, "HVAC Building Improvements", as evidenced by the Chief Financial Officer's Certification No. C2020-038R.

WHEREAS, the highest bid submitted was by Carmine Infante for \$4,620.00 who decided to withdraw his bid; and

WHEREAS, the second highest bid submitted was by Kevin and Sharon Kyle for \$3,900.00 for calendar year 2015 and for each successive calendar year for a term ending December 31, 2020; and

WHEREAS, Resolution R2015-079, adopted April 21, 2015, Mayor and Council approved the award to Kevin Kyle for 60 acres of the approximate 100 acres of Township owned land on Old York Road, designated as Block 29, Lot 6 for \$3,900.00 per year for three years, commencing January 1, 2015 through December 31, 2017; and

WHEREAS, Resolution R2015-079, adopted April 21, 2015, the tenant name and the farm lease ending term date of December 31, 2017 was incorrect and the Resolution should have reflected the tenant name as Kevin and Sharon Kyle and the lease term ending date as December 31, 2020, as stated in the page one of the April 21, 2015 attached lease; and

WHEREAS, the Township Council has reviewed the updated recommendation made by the Township Manager.

NOW THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The lease for farming of Township-owned land, specifically 60 acres of approximately 100 acres designated as Block 29, Lot 6, is hereby awarded to Kevin and Sharon Kyle, 230 Cedarville Road, East Windsor, New Jersey 08520, on his bid of \$3,900.00 per year, for a term ending December 31, 2020.

She stated her suggestion on the cleanest way to handle this was to do a Resolution correcting the prior award with the accurate lease term of five years rather than three years. The term of the lease actually expires December 31, 2021. She stated Council will eventually do a Resolution renewing the lease for another period of five years. She asked that the last paragraph be removed, as it is not necessary to send a copy of the Resolution to the tenants, as this is just to correct the Township's records.

APPLICATIONS:

REPORTS BY COUNCIL AND STAFF:

Mr. Shapiro stated the Planning Board met last night and approved an application by Custom Homes of New Jersey for a new single family home on a piece of property remaining after a previous Board approval for seven other homes. Mayor Mironov indicated the new house will mirror the existing houses on the street.

Mr. Zoller stated the Economic Development Committee met on December 3 and discussed the Township Gateway Signs and local business interest in the program, a proposal for a sculpture at the Route 130 and Route 33 intersection, and possible recognitions for the Annual Business Awards.

Mayor Mironov stated the Township participated in the Womanspace Communities of Light event on December 7. She stated due to the difficult circumstances there was very limited attendance but it was a good program and she wanted to thank everyone who came and supported the event.

CORRESPONDENCE:

Mayor Mironov noted the receipt of the following correspondence: a tax collector report for the period ending November 30; a tax collector report for the 2020 tax sale; communication from the Zoning Officer regarding the Shoppes at East Windsor, and Mayor Mironov asked that Council be kept up on the matter; a memo from the Director of Public Works regarding core tests conducted as required by NJDOT for the Route 130/Hankins/Conover Road Realignment project, and she stated that Council will be looking to see what comes next in terms of the grant

money and escrow; a memo from the Director of Public Works regarding uniforms; Mayor Mironov noted she is trying to keep everyone up to date on communications from the East Windsor Regional School District regarding the plans; a letter from NJDOT dated November 16 regarding a grant award for \$530,000 for the roadways in Cranbury Manor, and she asked that Council receive follow up on going out to bid for the engineering work; and communication was received from the Department of Community Affairs Local Government Services regarding the Township's application under the Local Government Emergency Fund indicating the Township is qualified for the grant amount that was allocated to the Township.

Mayor Mironov stated two letters were sent to the County Executive's office dated December 3 following up on previous letters regarding resident interests that had not received responses from the County Executive. The first letter was regarding pedestrian safety measures at the intersection of Princeton Hightstown Road and Lanning Boulevard, and the second letter was regarding signage to keep trucks from turning onto Old Cranbury Road from North Main Street. Follow up letters were sent kindly requesting the County Executive's response and both letters were copied to all of the members of the County Board of Freeholders.

Mr. Brady stated the Director indicated that the Township does not have sufficient equipment for the job, as it requires special materials other than paint due to the high traffic volumes on that road. Public Works is suggesting to contract the service out next time the Township has a roadway project. Mr. Zoller agreed it is a high traffic area and asked that it be prioritized when the opportunity arises.

Mayor Mironov stated she wants an update as to what is the plan for the Exeter Road Project, as she believes the project should have been done this year. She also stated she is looking for Public Works to provide an update on Shagbark Road. She also asked that the she would like the Clerk's Office and Finance to evaluate the process regarding vacant and abandoned properties,
