Support for the Celebration of the 100th Anniversary of Women's Suffrage

RESOLUTION R2020-029 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, on June 4, 1919 Congress passed the 19th Amendment guaranteeing all American women the right to vote; and

WHEREAS, the year 2020 marks the 100th anniversary of the ratification of the 19th Amendment to the United States Constitution, guaranteeing and protecting women's right to vote; and

WHEREAS, the introduction, passage, and ultimate ratification of the 19th Amendment was decades of work and struggle by advocates for the rights of women across the United States; and

WHEREAS, the 19th Amendment ensured that women were able to fully participate in our democracy and that fundamentally changed the role of women in the civic life of our Nation; and

WHEREAS, New Jersey has had a long, storied history in the suffrage movement with many New Jersey women playing a crucial role in pursuing the rights of women to vote by organizing the New Jersey Women Suffrage Association (NJWSA), holding open air suffrage rallies to collect signatures in support of the federal amendment guaranteeing and protecting women's constitutional rights to vote; and

WHEREAS, on February 9, 1920, New Jersey became the 29th state to ratify the 19th Amendment granting women the right to vote; and

WHEREAS, in 1921, Margaret Laird and Jennie Van Ness were the first two women elected to the New Jersey Assembly; and

WHEREAS, in 1925 Rebecca Estelle Bourgeois Winston of Estell Manor was elected as New Jersey's first woman Mayor; and

WHEREAS, the 19th Amendment represents a historical milestone changing the role of women in the civic life of our Nation.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey:

- 1. East Windsor Township honors the 100th Anniversary of the Ratification of the 19th Amendment and will light the Municipal Building in purple for the week of February 10 to celebrate this historic anniversary.

Support of Establishment of No Passing Zone on Route 33 in the Airport Road Intersection Area by the New Jersey Department of Transportation

WHEREAS, on April 2, 2019, the Township approved Resolution R2019-062, providing Municipal Consent to New Jersey Department of Transportation for Installation of a Traffic Signal to enhance safety and facilitate traffic flow at the intersection of New Jersey Route 33 and Airport Road; and

WHEREAS, the New Jersey Department of Transportation (NJDOT) has conducted an investigation of the area in connection with the installation of the traffic signal and recommended that the centerline pavement markings along NJ Route 33 between Hickory Corner Road in East Windsor Township and Summit Street in the Borough of Hightstown be revised to designate a "No Passing Zone"; and

WHEREAS, the NJDOT requires a Resolution of support from the Municipal Governing Body to revise the existing Passing Zone along NJ Route 33 between Hickory Corner Road in East Windsor Township and Summit Street in the Borough of Hightstown; and

WHEREAS, NJDOT will implement the "No Passing Zone" markings along NJ Route 33 between Hickory Corner Road in East Windsor Township and Summit Street in the Borough of Hightstown.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, that:

- The Township Council supports the establishment of a "No Passing Zone" along NJ Route 33 between Hickory Corner Road in East Windsor Township and Summit Street in the Borough of Hightstown as recommended by NJDOT, in connection with the installation of a traffic signal at the intersection of Route 33 and Airport Road.

Rescinding Resolution R2019-110 and Approving New Right of Way Use Agreement with Lockheed Martin Corporation for Access to Public Right of Way for Installation of Monitoring Wells on One Mile Road

RESOLUTION R2020-039 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, under the order of the New Jersey Department of Environmental Protection (NJDEP), Lockheed Martin Corporation is undertaking investigation and remediation of groundwater impacts at its former facility located at 50 Millstone Road, Block 5, Lot 11, in East Windsor Township; and

WHEREAS, to meet the requirements of the NJDEP, Lockheed Martin Corporation has requested the permission of the Township to install and maintain three groundwater monitoring wells in the public right-of-way along One Mile Road at the locations indicated in the attached Right-of-Way Use Agreement; and

WHEREAS, the Township Council has reviewed the January 21, 2020 recommendation of the Township Manager;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, County of Mercer, State of New Jersey, as follows:

- 1. Resolution R2019-110 is hereby rescinded.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Right-of-Way Use Agreement between the Township and Lockheed Martin Corporation, the terms of which are incorporated herein by reference.
- The Municipal Clerk is authorized and directed to forward a certified copy of this Resolution and the executed Right-of-Way Use Agreement to Lockheed Martin Corporation.

I hereby certify the foregoing to be a true copy of a Resolution adopted by the East Windsor Township Council at a meeting held on February 11, 2020.

The Mayor requested 2 minor edits to the Resolution; one in reference to formatting of numbers and the second was for number 1 to clearly indicate that Resolution R2019-110 is hereby rescinded.

Mayor Mironov stated that she had conversations with the Township Attorney prior to tonight's meeting and would like to share a few comments. She stated that the approved location had been identified and reviewed through an internal process, which involved significant time from staff,

but the locations were determined not viable because of utility presence. She continued stating additional staff time was then expended as new locations were identified; two of which encroach on East Windsor open space and if the agreement is accepted small monitoring marker caps would be on those grassy areas. Mayor Mironov recommended that it would be appropriate that there be some consideration incorporated in the exchange that recognizes the previous comments.

Township Attorney, David Orron, followed up by stating an update from prior conversations need to take place with Lockheed Martin confirming that they agree to pay a compensation in the amount of \$5,000 to install the equipment in the new location. He further recommended that there be one minor change in agreement and also one minor change that the Manager had previously pointed out in the resolution in reference to the curb and sidewalk and the original location. With respect to compensation, Mr. Orron recommended adding a new sentence stating "On execution of this agreement Lockheed Martin shall pay the sum of \$5,000 to the Township as the agreed compensation for license granted herein".

He further stated the sum of \$5,000 is still in escrow and it is still intact and it is suggested that Lockheed Martin submit a letter authorizing the Township to withdraw that escrow and apply it to the payment. Mayor Mironov stated that is fair and satisfactory in recognition of the above stated factors and changes and that the 20 year term on agreement coincides with the period of time that Lockheed Martin is required to conduct testing.

It was MOVED by Lippman, SECONDED by Shapiro to approve Resolution R2020-039 with the revisions.

Council Member Zoller reported that the Economic Development Committee met on February 6 and discussion topics included the Route 33/130 art installation project; a business card exchange; a breakfast or lunch with Princeton Chamber and also Young Entrepreneurship Day which the high school students are very anxious to plan and offer again. Mayor Mironov reported that she and a few council members attended the East Windsor Volunteer Fire Company No. 1 installation dinner on February 1. She also reported that she, along with Council Member Rosenberg and Council Member Daniels, attended the 5th Grade D.A.R.E graduation at the Rogers School earlier that day.

APPROVAL OF BILLS:

Mayor Mironov stated a 2020 Current Bill list dated February 6, 2019 Current Bill list dated February 6, a Capital Bill List also dated February 6 and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov requested clarification on items on page 7 of the 2019 current bills list related to vaccine costs totaling over \$5,000.

It was MOVED by Lippman, SECONDED by Rosenberg to approve the Bill Lists with the clarification.

There being seven (7) ayes, and no (0) nays, the various presented Bill Lists were approved with the clarification requested.

MATTERS BY COUNCIL:

Mayor Mironov indicated that in Council folders was complete information on the Sustainable Jersey Arboretum Project and a notice of a joint meeting that is being held on February 24 at 5:30 pm. She stated the Landscape Architect would be present and that invitations went out to all Council Members, Environmental Committee and Planning Board members. She also noted notices were provided to Mayor and Council for the budget review meetings set for February 19 at 5:30 P.M. and Tuesday, February 25 at 5:30 P.M. Mayor also noted the following was received: a letter, dated January 21, to Mayor and Council acknowledging the \$450,000 grant award for the Union Transportation Trail Extension; and an email, dated January 17, from the Lieutenant Governor, who is also the Commissioner of Department of Community Affairs,

awarding the Township \$400,000 toward the expansion of the Senior Center. The Mayor noted that after the last meeting there were many questions regarding the schedule for roadway improvements in the Exeter Road area. The Township Manager did clarify and confirm that the August date on the schedule marked the end of the project completion and did not refer to the end of completion of plans. Mayor Mironov reported the following correspondence was receieved: a memo, dated February 4, 2020, from the Recreation Department regarding summer concerts and events, she requested the subject be added to the next meeting agenda; a memo, dated January 30, from the Chief of Police regarding questions raised to Mayor from residents of Meadow Lakes regarding parking; a memo, dated January 30, from the Chief of Police in response to questions from Council Member Daniels regarding the marking and signage on Conover Road; and a letter, dated January 24, from the Department of Transportation to Twin Rivers Administrator regarding the underpass and their review; a memo from Township Manager, dated January 29, addressing questions on the bills list from the January 28 Council meeting. Mayor Mironov also shared with Council a copy of a letter from a Riviera resident and a letter from ANJEC regarding activity in Trenton about the banning of plastic bags. Mayor Mironov inquired if there were any updates on the status of the Shoppes at East Windsor. The Township Manager responded that he met with the Zoning Officer earlier in the week and has requested that a complete status update be provided in writing to Mayor and Council on the status.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Energy Savings Proposal for Municipal Buildings

Mayor Mironov stated that a memo was received from the Director of Public Works regarding a program he investigated in order to provide for more energy efficient lightbulbs which will provide a greater degree of lighting at a lessor cost. She stated the Director of Public Works has an avenue to get all of the bulbs paid for and made suggestions for the installation in that memo indicating that although there is no cost to this project it is a major change to all the municipal buildings he wanted to provide the information to see if there were any questions on the change out or if Mayor and Council is in support of it.

Council Member Zoller questioned if the existing ballasts had to be removed for the new bulbs to be installed. Township Manager, Jim Brady replied that the old ballasts will not be used and that adds to the cost efficiency as they were often replaced periodically. He further stated he will inquire and provide further clarification as to whether the old ballasts will be removed or not and did again note that they will not be used as part of the new energy efficient bulb installation. Council Member Zoller further commented that if the old ballasts are hardwired, the removal should be done by a trained licensed electrician.

Mayor Mironov further stated the bulbs have since been installed as a trial in the Senior Center building and requested Kelly Roman to provide feedback and clarification on comfort level and performance of the new bulbs.

It was MOVED by Zoller, SECONDED by Yeager to support and approve the project with the condition that it be done safely.

There being seven (7) ayes, and no (0) nays, the project is approved with the two clarifications as requested.

2. Open Space Acquisition Proposed Projects: Status and Required Actions

Mayor Mironov indicated that there is a concern that the first two properties are not moving forward at a pace that is acceptable to bring them to completion. She stated there is a deadline to use the money and Department of Environmental Protection has already extended the deadline as a courtesy.

- A. Bennett Property: 641 Etra Road, Block 32, Lot 13.01 (11.328 acres)
- **B.** Riggenbach Property: 949 Windsor-Perrineville Road, Block 31, Lot 21 (15.70 acres)
- C. Estenes Property: 104 Disbrow Hill Road, Block 32, Lot 5 (3.64 acres)
- **D.** Ward Property: 820 Windsor-Perrineville Road, Block 35, Lots 4 and 4.01 (31.22 acres)
- E. Other Recommended Properties

Mayor Mironov stated the Bennett and Riggenbach properties are under contract and set to move forward. She stated the Estenes Property was held up for 5 weeks—approval and appraisal was done in Mid-December and there was a disconnect with the owner. She continued by stating that the appraisal has finally just moved forward.

Mayor Mironov commented that although the Ward Property will not move forward there are questions that need to be answered to make a determination. She noted that Mercer County has made inquiries and would be willing to participate with us.

Township Manager, Jim Brady, commented that the he is in agreement that the first three properties need to move forward and he will address concerns and report back to Mayor and Council. Mayor Mironov requested that the first two properties be added to the next meeting agenda inclusive of any and all actions items needed to be taken by Mayor and Council to move it forward.

3. New Jersey Urban Community Forestry Stewardship Grant

Mayor Mironov stated that there is a memo in folder from Business Ombudsman Robert Goodman regarding the grant. She stated a meeting will be held tomorrow regarding more detailed information that he will be attending. Mayor Mironov questioned the amount of the required match.

Mayor Mironov stated that the Township was awarded \$30,000 to plant at least 100 trees. This provides an opportunity to provide a street tree program and the homeowner accepts the responsibility of the shade trees.

Several Council Members commented on the consideration of what trees will be most suitable based off the size, kind, location etc. They further stated the trees need to be disease resistant and appropriate for a long future without impacting any immediate surroundings.

Mayor Mironov stated more information addressing concerns will be forthcoming following the meeting tomorrow.

4. Anker Park Improvements- Mercer at Play Grant Program – Status Report

Mayor Mironov acknowledged that the Director of Public Work has been out of office and she has requested a status report with timeline upon his return on this program. The Township Manager, Jim Brady, indicated that the Director of Public Works returned this morning and is currently working on the request.

5. 2020 Municipal Budget Review Schedule

Mayor Mironov stated the budget review schedule dates are scheduled for February 19 at 5:30 p.m. and Tuesday, February 25 at 5:30 p.m.

No one from the public spoke.

There being no further business Mayor Mironov declared the meeting adjourned at 9:07 p.m.
