An Ordinance to Exceed the Municipal Budget Appropriation Limits to Establish a Cap Bank

TOWNSHIP OF EAST WINDSOR MERCER COUNTY, NEW JERSEY

ORDINANCE NO. 2020-02

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Council of the Township of East Windsor in the County of Mercer finds it advisable to permit an increase of its CY 2020 budget by up to 3.5%, if necessary, over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

**WHEREAS**, the Township Council hereby determines that a an increase of up to 1.0 % increase in the budget for said year, amounting to \$187,203.89 in excess of the increase in final

appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

**WHEREAS**, the Township Council hereby determines that any amount authorized herein that is not appropriated as part of the final CY 2020 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

Ι

- 1. In the CY 2020 budget year, the final appropriations of the Township of East Windsor shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$655,213.62 and that the CY 2020 municipal budget for the Township of East Windsor be approved and adopted in accordance with this ordinance; and,
- Any amount authorized herein that is not appropriated as part of the final CY
   2020 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.
- 3. A certified copy of this ordinance as introduced shall be filed with the Director of the Division of Local Government Services within 5 days of introduction.
- 4. A certified copy of this ordinance upon adoption, with the recorded vote included thereon, shall be filed with said Director within 5 days after such adoption.

#### II

## **REPEAL**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

#### III

## **SEVERABILITY**

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

## IV

#### **EFFECTIVE DATE**

This ordinance shall take effect twenty (20) days after the final passage and publication as required by law.

Mayor Mironov stated Ordinance 2020-02 is an Ordinance to establish a cap bank. She stated the Ordinance is done annually and is not a spending Ordinance but is an authorization to bank the increase we are not spending up to 3.5%.

Award of Contract for Leaf Disposal with Mendies Farm LLC for the Public Works Department

# RESOLUTION R2020-041 EAST WINDSOR TOWNSHIP MERCER COUNTY

**WHEREAS**, there is a need for a site for leaf disposal for the fall/winter 2020 season; and

**WHEREAS,** a Notice to Bidders was issued and posted/advertised on January 7, 2020 and two bids were received for the disposal of leaves by the Municipal Clerk's Office on February 12, 2020; and

**WHEREAS**, the lowest bid received was from Mendies Farm LLC, at \$3.00 per cubic yard; and

**WHEREAS**, the Township Council has reviewed the recommendation of the Director of Public Works on the bids; and

**WHEREAS,** the Chief Financial Officer has determined that sufficient funds are available in the Budget line item appropriation account specified as 0-30-32-305-300-237, pending adoption of the 2020 budget, entitled "Disposal Fees," in the amount of \$45,000, as evidenced by the Chief Financial Officer's Certification No. G2020-02.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The contract for the disposal of leaves collected by East Windsor Township is awarded to Mendies Farm LLC, 65 North Rochdale Avenue, Roosevelt, New Jersey 08555, at \$3.00 per cubic yard, in an amount not to exceed \$45,000, upon receipt of a fully executed contract and all other required documents.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the contract for same.

**Resolution R2020-042** Authorizing Purchase of 20' Water Tight Sea Storage Container from Jake Containers for Department of Public Works

Mayor Mironov stated Resolution R2020-042 was held at the previous Council meeting awaiting further clarification. She stated a follow-up memo was provided by the Director of Public Works clarifying that the storage containers will be placed at the Public Works Garage. Mayor Mironov requested to continue to hold the Resolution in order to take a look at the Public Works yard and the location of the current storage containers. Mayor and Council agreed to hold Resolution R2020-042 until the next regularly scheduled Council meeting.

# **Resolution R2020-051** Introduction of the 2020 Municipal Budget

Mayor Mironov stated the Township Manager provided Mayor and Council with a memo, dated March 18, listing the adjustments that were made in follow-up with the workshop sessions that were conducted. She further stated those adjustments are included in Resolution R2020-051 which is up for introduction. Mayor Mironov continued by saying the budget proposes appropriations for 2020 of \$22,521,600, which is an increase of \$84,426 or .37% over the 2019 budget. She stated the 2020 budget maintains the same municipal tax rate as 2019 at .4329% per \$100 of assessed valuation and has done so for eight consecutive years with no tax increase. She stated the average current residential assessment for 2020 municipal tax is \$1120, which is identical to the 2019 budget. Mayor Mironov stated the Municipal Budget contains additional funds allocated for the health department and other extra expenses associated with the current CoVID-19 circumstances. She further stated that the Township 2020 tax base has increased by over \$5 million dollars, generating new revenue with the addition of several new stores and additional pharmaceutical space. She continued by stating that East Windsor's municipal component of the total local property tax bill remains at less than 15%, and is among the lowest amounts in the entire region and well below the statewide average. Mayor Mironov stated that the 2020 municipal budget is the result of continued cost savings and revenue generating measures, as well as reflecting that East Windsor has been highly pro-active and successful in supporting and expanding existing businesses and attracting new commercial ratables. She stated, East Windsor has worked hard to keep our spending levels tight and continually seek out additional efficiencies, cooperative purchasing avenues and service sharing opportunities, and maintained a very low debt level. She continued stating that the positive outcome results from the pro-active efforts of the Township carefully planning and closely monitoring the expenditures and revenues throughout the year.

It was MOVED by Lippman, SECONDED by Rosenberg to approve Resolution R2020-051 and set the date of the municipal budget public hearing for April 21, 2020.

Mayor Mironov states this accompanies the budget document with no increase. She also stated a memo was provided to Mayor and Council from the Township Manager, dated March 12, 2020, clarifying questions that arose from the budget workshop.

It was MOVED by Yeager, SECONDED by Rosenberg to approve Resolution R2020-052 and set the date of the Garbage District 1 budget public hearing for April 21, 2020.

Government Services Budget Self Examination Program and Requesting Review of 2020 Municipal Budget by New Jersey Division of Local

Government Services

Mayor Mironov questioned if the 2020 budget process is the same as in previous years due to employees down at the state working remotely due to the pandemic. The Township Manager stated that the Finance Director reached out to the state and they stated that the review process will take longer than usual this year due to the unfortunate circumstances that has arisen and the state employees working remotely. Mayor Mironov stated unlike in prior years, she is inclined to have East Windsor do a self-examination of the budget so that there is no delay in adopting the East Windsor budget on April 21, 2020.

Mayor and Council unanimously decided to support and participate in the self-examination program for 2020.

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures

- c. Cash deficit of preceding year
- d. Reserve for uncollected taxes
- e. Other reserves and non-disbursement items
- f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met (complies with the "CAP" law.)
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated;
  - b. Items of appropriation are properly set forth;
  - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced, publicly advertised, and in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.
- 7. A copy of this Resolution be forwarded to the Director of the Division of Local Government Services.

Mayor Mironov stated she wants to ensure whatever contracts are signed that we will be able to get out of the contract without any penalty or cost to the Township. Mayor Mironov stated, based on Council comments, she would like staff to move forward in scheduling the four bands as well as a possible family night. Mayor Mironov requested that staff get a full calendar together and she would help raise fund for the costs.

# 2. AARP Community Challenge 2020 Grant

Mayor Mironov stated the grant agreement was extended and she expressed interest to apply for the grant for the possibility of outdoor furniture for the senior center expansion. She further stated the application needs to be reworked but thinks it is a great idea and would like to move forward with the process.
