#### TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

#### ORDINANCE NO. 2020-05

#### AN ORDINANCE TO AUTHORIZE ACQUISITION FOR OPEN SPACE OF AN APPROXIMATELY 3.64 ACRE SITE, LOCATED AT 104 DISBROW HILL ROAD, AND DESIGNATED ON THE EAST WINDSOR TOWNSHIP TAX MAP AS BLOCK 32, LOT 5

**WHEREAS,** the Township Council of the Township of East Windsor has determined that it is in the best interests of the Township to acquire an approximately 3.64 acre parcel of land located at 104 Disbrow Hill Road, and designated on the East Windsor Township Tax Map as Block 32, Lot 5 (the "Property"), for use as open space; and

**WHEREAS**, the Property is presently owned by Henry S. Estenes (the "Owners"), residing at 21 Rockdale Avenue, Roosevelt, NJ 08555; and

**WHEREAS**, an Agreement of Sale, between East Windsor Township and the Owners, has been negotiated with a purchase price of \$84,000.00 for the Property; and

**WHEREAS**, the Township has been awarded New Jersey Green Acres Program grants and Mercer County Open Space grants to fund the purchase of the 3.64 acre Property.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey, as follows:

#### I

The Mayor, Municipal Clerk, Township Manager, Township Engineer and Township Attorney be and are hereby authorized to take all necessary actions to acquire an approximately 3.64 acre parcel of land located at 104 Disbrow Hill Road, and designated on the East Windsor Township Tax Map as Block 32, Lot 5, for use as open space, pursuant to the Agreement of Sale between the Owners and the Township of East Windsor. This authorization includes, but is not limited to, the execution of an Agreement of Sale with a purchase price of \$84,000.00, payment of the contract purchase price, and the acceptance and recording of a Deed to the Property.

#### II REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

#### III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

#### IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated the Township came to terms to purchase the property for \$84,000 and are awaiting the signed contracts. She stated in the contract it allows the seller to farm for up to five additional years at a \$1.00 per year. She stated the assessment needs to move forward but the survey will be held for now until the Township receives the assessment report back.

It was MOVED by Yeager, SECONDED by Rosenberg to approve Ordinance 2020-05 on introduction, authorize publication as required by law and set public hearing for May 19, 2020.

Resolution R2020-051 Adoption of the 2020 Municipal Budget

Mayor Mironov stated the budget was introduced at the March 24 Council meeting and the public hearing was set for tonight. She stated the Township decided to do a self-examination of the budget this year and the Finance Director has approved the budget for adoption. Mayor Mironov declared the public hearing open on Resolution R2020-051. With no comment from the public being made, Mayor Mironov declared the public hearing closed.

It was MOVED by Yeager, SECONDED by Shapiro to adopt Resolution R2020-051 and authorize publication as required by law.

There being six (6) ayes, and no (0) nays, Resolution R2020-051 was adopted and authorized publication as required by law.

Mayor Mironov stated that the adopted 2020 East Windsor Municipal Budget again contains no tax increase. She stated the 2020 municipal tax rate component remains the same for eight consecutive years, at the rate of 43 cents per \$100 of assessed valuation for the years 2013 through 2020. She stated for the average current residential assessment of \$258,747, the 2020 municipal tax is \$1,120. Mayor Mironov stated the Municipal Budget contains additional funds allocated for the Health Department and other extra expenses associated with the current COVID-19 circumstances. She stated it is a fiscally conservative budget document which well serves the community and retains all existing service levels. She further

stated East Windsor has worked hard to keep spending levels tight and continues to seek out additional efficiencies, cooperative purchasing avenues and service sharing opportunities, all while maintaining a very low debt level. She continued stating the positive outcome results from the pro-active efforts of the Township to carefully plan and to closely monitor expenditures and revenues throughout the year.

**Resolution R2020-052** Adoption of the 2020 Garbage District No. 1 Budget

Mayor Mironov stated the budget was introduced at the March 24 Council meeting and public hearing was set for tonight. Mayor Mironov declared the public hearing open on Resolution R2020-052. With no comment from the public being made, Mayor Mironov declared the public hearing closed.

**WHEREAS,** the Mandatory Source Separation and Recycling Act, P.L. 1987, c.102, has established a recycling fund from which a tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

**WHEREAS,** it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and

**WHEREAS**, the New Jersey Department of Environmental Protection has promulgated recycling regulations to Implement the Mandatory Source Separation and Recycling Act; and

**WHEREAS**, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and to indicate the assent of East Windsor Township to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling requirements; and

**WHEREAS,** such a resolution should designate the individual authorized to ensure the certification to comply with requirements in N.J.A.C. 7:26A-11 is properly completed and timely filed.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. East Windsor Township hereby endorses the submission of the 2019 recycling tonnage grant certification to comply with the requirements in N.J.A.C. 7:26A-11 and New Jersey Department of Environmental Protection and designates certified Recycling Coordinator, Richard Brand to ensure that the requirements are properly filed.
- 2. The monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.

**Resolution R2020-074** Approval of Installation of New Water Line for Fire Suppression System for Municipal Building by Waters & Bugbee

## RESOLUTION R2020-074 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, an emergency has arisen regarding the immediate need for the installation of a new water line for the fire suppression system serving the Municipal Building following an unexpected water line break; and

WHEREAS, an emergency contract pursuant to N.JS.A. 40A:11-6, may be awarded without public advertisement for bids and bidding as the lack of a water supply for the municipal building fire suppression system created an emergency affecting the public health and safety requiring the immediate reactivation of the fire suppression system; and

**WHEREAS**, pursuant to the New Jersey Local Public Contracts Law, specifically N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1, the Township Manager has transmitted and certified the existence of an emergency purchasing need including actual emergency, the need for purchase could not have been reasonably foreseen, and the contract is limited to meet the immediate needs of the emergency, which is attached and incorporated in this Resolution; and

WHEREAS, three (3) quotes were obtained to perform this emergency work; and

**WHEREAS**, Waters & Bugbee, Inc. is the overall lowest quote that includes licensed contractors who certify the new system and is the most responsible work plan; and

WHEREAS, the Township Council has reviewed the Township Manager's recommendation which declares this to be an emergency procurement under the New Jersey Local Public Contracts Law N.J.S.A.40A:11-6 et. seq., and finding that the contract award may be made without public bidding; and

WHEREAS, the maximum amount of the purchase \$58,890.00 and funds are available in Capital Fund Account No. C-04-55-953-914-504 entitled Ordinance 2013-09 "Building Repairs" in the amount of \$3,016.96, in Capital Fund Account No. C-04-55-970-915-430 entitled Ordinance 2014-08 "General Building Improvements" in the amount of \$14,501.00, in Capital Fund Account No. C-04-55-980-919-400 entitled Ordinance 2016-08 "General Building Improvements", in the amount of \$40,660.00, and in 2020 Current Fund Account No. 0-01-26-310-408-253 entitled "Other Contractual Services-Municipal Building" in the amount of \$712.04, as evidenced by the Chief Financial Officer's Certification No.C2020-010.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Manager and Chief Finance Officer are hereby authorized and directed to approve and forward a purchase order to Waters & Bugbee, Inc., 75 South Gold Drive, Hamilton, NJ 08691, for the purchase and installation of a new fire suppression system in an amount of \$56,950.00 plus adding the alternate Butterfly Control Valve in the amount of \$1,940.00, for a total amount not to exceed \$58,890.00, all in accordance with the attached quote.

Mayor Mironov stated a 2020 Current Bill list, 2019 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov requested information on the East Windsor Volunteer Fire Company No 1 truck additional purchases. She also stated that all bills that require a capital purchase, a memo must be provided to Mayor and Council prior to the purchase.

It was MOVED by Shapiro, SECONDED by Rosenberg to approve the Bill Lists with the clarifications and holds.

There being six (6) ayes, and no (0) nays, the various presented Bill Lists were approved with the clarifications and holds.

# **MATTERS BY COUNCIL:**

Mayor Mironov reported the following was received and copies were provided to Mayor and Council: a tax collectors report regarding receipts and disbursements for a period ending March 31, 2020; a revenue report, from the Finance Director, for period ending March 31, 2020; a memo, dated April 2, from the Executive Director of the Municipal Utilities Authority regarding notice procedures for hydrant flushing, which needs to be provided for the April 24 Enews; a memo from T & M Associates, dated April 2, updating the 2020 infrastructure fund; a memo from the Township Manager, dated April 8, regarding bill list questions from the April 7 Council meeting; correspondence was received from New Jersey Department of Transportation, dated April 13, regarding upcoming grant opportunities with a July 1 deadline. Mayor Mironov requested that staff work on draft applications for the grants and the Resolutions are to be added to the next regularly scheduled Council meeting agenda. She further reported a memo from the Director of Recreation was provided to Mayor and Council regarding concerts and events for 2020. She required that no dates are to be scheduled until the agreement that the Township Attorney and the Township Manager will be providing to the Mayor for review. Mayor Mironov requested that the terms for the 2020 Independence Day celebration are reviewed to ensure flexibility to cancel if need be. Mayor Mironov stated a memo, dated March 5, 2020, was provided from the Principal Engineering Aid of PSE&G for work that will be done on Old York Road. She stated that she requested they notify all the residents and the residents have signed off on the work that is being done. Mayor Mironov reported that PSE&G previously did digging on Brooktree Road and she wants to ensure the work is done up to the Township's standards. Mayor Mironov stated that during the 2020 budget process a memo was provided from the Director of Code Enforcement recommending an Ordinance to change Construction fees and she requested an Ordinance on an upcoming council agenda. Mayor Mironov reminded all Council Members to file their Financial Disclosure statement by April 30, 2020. Mayor Mironov stated a committee was appointed for Emergency Medical Services which will review the proposals and provide the Clerk with the signed review document. Mayor Mironov stated the Clerk provided to Mayor and Council the Executive Order extending the Liquor License renewals from June 30 to September 30, 2020. She further stated the Comcast Franchise renewal is expiring soon and she is looking for additional information on from the Township Attorney and Township Manager on this

subject. Mayor Mironov stated all meetings for the Township Board and Committees are canceled through April 20 due to the health emergency but suggested that meetings should begin on one of the various online platforms with Mayor and Clerk approval. Mayor Mironov stated she spoke with the Clerk's office and the Chairperson of the Community Gardens and she is trying to determine if the Community Gardens should be operating for 2020. She further stated she will make a decision after review of the documents provided by the Community Garden Chairperson.

# DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. 2020 National Night Out

Mayor Mironov stated a notice was provided from the police department stating all 2020 National Night Out celebrations are extended till October 6 due to the health emergency. Mayor and Council all agreed to the date change due to currents health conditions.

2. New Jersey Division of Highway Traffic Safety Grant Program

Mayor Mironov stated a memo was provided to Mayor and Council, dated April 10, from the Chief of Police with recommendations on the grant programs the Township should apply for. Mayor and Council suggested that all four grant program applications be filed and submitted for funding. Mayor Mironov suggested applying for the applications in the following order: solar power school zone flashers, mobile message board, child safety seat then the traffic counting device. Mayor and Council agreed to the application order for filing.

Open Space Acquisitions: Status
 A. 641 Etra Road (Block 32, Lot 13.01)

Mayor Mironov stated the Assistant Manager left a message today stating that the final assessment report was received for 641 Etra Road and the report will be sent out to Green Acres this week for review. She further stated that the notice to proceed on the survey and title work needs to be sent out by staff.

B. 929 Windsor Perrineville Road (Block 31, Lot 21)

Mayor Mironov stated the Assistant Manager left a message today stating that the final assessment report has been received for 929 Windsor Perrineville Road and the report will be sent out to Green Acres this week for review. She further stated that the notice to proceed on the survey and title work needs to be sent out by staff.

C. 605 Etra Road (Block 32, Lots 11 and 12)

Mayor Mironov stated the owners originally stated they would be willing to give the Township the property, but after further review of their records there are some complications. The Assistant Manager will be providing further information once he receives information back from the property owners.

D. Other Potential Properties

Mayor Mironov stated a memo, dated April 15, was provided to Mayor and Council from the Assistant Manager but was a rerun of the previous memo that was provided by him. She further stated that the Township Manager provided a memo, dated February 11, with four additional properties on Ward Street. She requested follow-up on the four potential Ward Street properties and she is still looking for that additional information. Mayor Mironov stated there is an additional property located on Old York Road, which is land locked, adjacent to the Union Transportation Trail that could be of some interest to the town. She further stated that in the Thompson letter, a property was referenced that is located at the intersection of Route 33 and Airport Road, known as Block 50.03, Lot 17 (7.36 acres) which backs up to the Union Transportation Trail and she would like more information on that property on how it could benefit the town. She stated additional information, without owner contact, needs to be provided on all the properties with maps. Mayor Mironov requested that a couple serious recommendations need to be made and the properties to be listed on the next regularly scheduled agenda.

## 4. 2020 Municipal Capital Program

Mayor Mironov stated a packet of material including a memo, dated April 13, 2020, from the Township Manager was provided regarding the department and agencies capital budget recommendations. Mayor Mironov requested information on the road programs and a breakdown of existing projects and expected roadway needs. She further stated that the memo that was provided from the Director of Public Works was disjointed and provided no basis for the capital requests. She requested staff do a serious review of the Dutch Neck Morrison project, Exeter Roads Project and Shagbark and Charred Oak Lane projects for further consideration. Mayor Mironov requested the balance for park improvements in the capital accounts. Mayor Mironov requested further clarification on the chipper to purchase versus repairing the vehicle. She further requested more review on the Chassis truck and what the truck is used for. Mayor Mironov requested more information regarding the police vehicles and if they should be included in the current budget or the next Capital Ordinance. Council Member Yeager suggested that since the Township is in need of computers he suggested maybe looking into systems that are more remote or portable due to the current health emergency. Mayor Mironov requested that the Mercer at Play grant be taken into consideration and she stated she did not see it in the last few Ordinances. She further stated the amount of the Mercer at Play grant is \$950,000 and she asked how the funding for the addition to the senior center is going to be addressed. She asked if the addition to the senior center should be added here in the budget or if a separate Ordinance should be done. Mayor Mironov stated that two open space projects have been included but questioned if the Estenes property should also be included now. She continued by stating that all the open space purchases use the Green Acre funds and all the prior grants have been accounted for in some fashion in order to complete the purchases within the next few months. Mayor Mironov questioned if the Urban Forestry grant in the amount of \$30,000 will be included in the budget and asked for more information as to what would be involved in completing a tree survey and if it would be beneficial to the Township.

Mr. Yeager stated that for Fire Company No. 2, item number one, he would want to make sure they have a clear expectation as to the Township's involvement in the purchase. Mayor Mironov stated that she believes they do, as they have had a few meetings in the last year and they have been very cooperative

and understanding of the Township's concerns and funds. She stated that was a good and fair question and Council would be receiving a memo on that later this week.

Mayor Mironov asked Council Members for any other questions or comments. No other questions or comments were raised. The Township Manager stated he will provide Mayor and Council with a memo addressing all issues discussed.
