CALL TO ORDER:

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 5:30 p.m. on Tuesday, February 23, 2021.

Black History Month – February 2021 Remarks By: Assemblywoman Verlina Reynolds-Jackson

Mayor Janice Mironov proclaimed February as Black History Month to recognize and celebrate the many valuable contributions of Black Americans to the history and culture of our Nation, our State and our Township, which enrich us all and strengthen our community. Assemblywoman Verlina Reynolds-Jackson spoke about the importance and significance of Black History Month, noting that February was chosen as Black History Month because Frederick Douglass, Abraham Lincoln, and George Washington celebrated birthdays during the month. She stated that Black History Month was created to teach African-American youth in elementary and secondary schools about their true history. It was officially recognized in 1976 by Gerald Ford, and by every President thereafter, who called on the public to seize the opportunity to honor too often neglected accomplishments of African-Americans in every area of endeavor throughout our history. Assemblywoman Reynolds-Jackson acknowledged the accomplishments of many specific leaders, noting that she is tremendously thankful for all who came before her and opened up so many doors.

ORDINANCE NO. 2021-01 TOWNSHIP OF EAST WINDSOR MERCER COUNTY NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER V,
"GENERAL POLICE REGULATIONS," SECTION 5-9, "USE OF RECREATION
AREAS AND PARK FACILITIES," TO ADD SECTION 5-9.4, "SMOKING
PROHIBITED IN RECREATION AREAS AND PARK FACILITIES," OF THE
REVISED GENERAL ORDINANCES OF THE
TOWNSHIP OF EAST WINDSOR

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR in the County of Mercer, State of New Jersey, that Chapter V, "General Police Regulations," Section, 5-9, "Use of Recreation Areas and Park Facilities," of the Revised General Ordinances of the Township of East Windsor is amended and supplemented as follows:

SECTION 1. Chapter V, "General Police Regulations," Section 5-9, "Use of Recreation Areas and Park Facilities," is amended and supplemented by the addition of new Section 5-9.4, "Smoking Prohibited in Recreation Areas and Park Facilities," as follows:

5-9.4.1 Definitions. As used in this Section:

- a. *Recreation Areas and Park Facilities* shall include any Township lands and facilities owned by or operated by the Township upon which the public is invited or upon which the public is permitted and where individuals gather for recreational activities
- b. *Smoking* shall mean the burning of, inhaling from, exhaling the smoke from, or the possession of a lighted cigar, cigarette, pipe or any other matter or substance which contains tobacco or any other matter that can be smoked, or inhaling or exhaling of smoke or vapor from an electronic smoking device.
- 5-9.4.2 Smoking Prohibited in Public Places. Smoking shall be prohibited in all recreation areas and park facilities which have been designated with no-smoking signs. Areas

designated as smoke-free recreation areas and park facilities shall include: Anker Park, Bear Brook Pathway, Disbrow Hill Fields, Disbrow Hill Trail, Dreyfus Park, East Windsor Police Athletic League Complex, Etra Lake Park, Etra Lake Pathway, Rocky Brook Pathway, Turnpike Park, Turnpike Park Pathway, Veterans Park, Westfield Road Park, Wiltshire Park, Woods Road Community Park, and all other Township lands and facilities.

5-9.4.3 Signage Required. No-smoking signs or the international no-smoking symbol (consisting of a pictorial representation of a burning cigarette enclosed in a circle with a diagonal line through its cross section) shall be clearly, sufficiently and conspicuously posted at the entrance to every public place where smoking is prohibited by this article. The signs shall be clearly visible to the public and shall contain letters or a symbol which contrast in color with the sign, indicating that smoking is prohibited therein. The sign shall also indicate that violators are subject to a fine.

5-9.4.4 *Enforcement*. The Township Manager, police officer, health officer or other public employee engaged in the execution or enforcement of this Section, or any other citizen, may enforce and sign a complaint against any individual for violation of the provisions of this Section.

5-9.4.5 *Violations and Penalties*. For a violation of the provisions of this Section, the penalty upon conviction shall be a fine of up to \$100 for the first offense, up to \$250 for the second offense, and up to \$500 for each subsequent offense.

5-9.4.6 *Construal of Provisions*. No provision in this Section shall be construed or interpreted to allow smoking where it is otherwise restricted by other laws.

SECTION 2. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. This Ordinance shall take effect 20 days after final passage and publication according to law.

ORDINANCE NO. 2021-02 TOWNSHIP OF EAST WINDSOR MERCER COUNTY NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XX, "ZONING," SECTION 20-4.0000 "GENERAL PROVISIONS," SUBSECTION 20-4.0200, "CLASSES OF USES," TO AMEND AND CLARIFY PARAGRAPH 20-4.0201 "PERMITTED USES," OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR, COUNTY OF MERCER, STATE OF NEW JERSEY

WHEREAS, East Windsor Township ("Township"), pursuant to the Revised General Ordinances of the Township of East Windsor, Chapter XX, "Zoning", Section 20-4.000 "General Provisions," Subsection 20-4.0200, "Classes of Uses," Paragraph 20-4.0201, "Permitted Uses", has outlined appropriate uses within zoning districts of the Township; and

WHEREAS, pursuant to Paragraph 20-4.0201, the Township has determined that any use of land, buildings and/or structures which are not specifically designated as a use for a zoning district are therefore prohibited, including, but not limited to smoke and vape shops; and

WHEREAS, recent increased interest in zoning districts throughout the Township to initiate commercial uses related to smoke and vape shops has precipitated the need to clarify the longstanding prohibition of this use in any zoning district within the Township; and

WHEREAS, this amendment to the Township Ordinances is to expressly and specifically reaffirm that smoking shops and vaping shops have always been intended by the Township as prohibited, and continue to be so, in all zoning districts.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR, in the County of Mercer and the State of New Jersey, that Chapter XX, "Zoning", Section 20-4.000 "General Provisions," Subsection 20-4.0200, "Classes of Uses," Paragraph 20-4.0201, "Permitted Uses", of the Revised General Ordinances of the Township of East Windsor is hereby amended and supplemented as follows:

SECTION 1. Paragraph 20-4.0201(b), under "Permitted Uses", is amended and supplemented as follows:

- b. Conversely, any uses of land, buildings and/or structures which are not specifically designated as a "principal use" or as an "accessory use" or as a "conditional use" for a subject zoning district are prohibited including but not limited to smoking shops and vaping shops. Notwithstanding any other section of this Chapter to the contrary, for the following are exceptions:
- 1) The use of land and/or buildings by the Township of East Windsor is permitted in all zoning districts;
- 2) Fire and rescue facilities authorized by the Township of East Windsor are permitted in all zoning districts; and
- In accordance with N.J.A.C. 40:55D-66.1 of the Municipal Land Use Law, community residences for the developmentally disabled, community shelters for victims of domestic violence, community residences for the terminally ill and community residences for persons with head injuries shall be permitted uses in the "R-A," "R-E," "R-M," "R-1," "R-2," "R-3," "S-L" and "PUD" residential zoning districts within East Windsor Township, in accordance with the applicable requirements of the subject zoning district for non-clustered single-family detached dwelling units, and in accordance with the definitions of these uses at N.J.A.C. 40:55D-66.2 of the Municipal Land Use Law.

SECTION 2. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. This Ordinance shall take effect 20 days after final passage and publication according to law.

Approval of Environmental Green Purchasing Policy for East Windsor Township

RESOLUTION 2021-041 EAST WINDSOR TOWNSHIP MERCER COUNTY

A RESOLUTION SUPPORTING GREEN PURCHASING

WHEREAS, the Township Council of the Township of East Windsor recognizes the need to strive to enhance standards of environmental stewardship and the environmental characteristics of our municipal operations; and

WHEREAS, the "Greening" of public purchasing is a tangible and practical step which local government can take by instituting more sustainable practices and improve environmental performance; and

WHEREAS, on August 7, 2018, by Resolution R2018-139, the Township Council incorporated "Green Purchasing" where feasible and fiscally prudent; and

WHEREAS, purchasing "Green" or environmentally preferable products sends a clear signal to the market that there is a preference for green, clean and safe products, resulting in the availability of an increasing number of environmentally preferable alternative products in the marketplace, which then also likely will become more available to our residents; and

WHEREAS, the Township of East Windsor, in furthering the use of Green products, will use as the definition and purpose of Environmentally Preferable Purchasing (EPP) or "Green Purchasing," the purchase of goods and services that minimizes environmental impacts. It includes the purchase of products with post consumer recycled content, that have a lesser or reduced effect on human health and the environment when compared with competing products that serve the same purpose; and

WHEREAS, the Township Council does hereby request that Township staff to continue to include environmental considerations in purchasing decisions by using the following criteria to encourage purchase of Green products, as available and practicable:

- distance of transport/ localness of production
- quality and performance standards of the product
- packaging or distribution method of the product
- price and performance of the product
- the raw materials, including energy and water and post consumer recyclable content, used in the manufacture of the product; and

WHEREAS, the Township Council continues to set forth the goals and objectives of the Green Purchasing Program as follows:

- 1. to establish the Township's clear commitment to conducting its functions in an environmentally responsible manner
- 2. to improve the Township's environmental performance and make it more sustainable
- 3. to raise awareness of environmental issues among the staff

NOW, THEREFORE BE IT RESOLVED, that the Township Council of the Township of East Windsor does support and encourage the purchasing of Green and Environmental Performance Products as a meaningful, long-term objective that has value both for the employees and for the community.
