Mayor Mironov stated a 2021 Current Bill list, 2020 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided with the holds and clarifications.

Mayor Mironov requested to hold with clarification on the funding source for the laptop bill under the Trust Fund Account.

Mayor Mironov requested additional information on the Greater TMA Route 130 Connector Bus schedule. She also requested additional information regarding the redevelopment project on Bank Street from Hightstown. Mayor Mironov requested information from the Municipal Clerk on The Woods maintenance bond. She also requested follow-up on the Shagbark questions that were asked at the prior Council meeting.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. 2020 Kelly Bill Reimbursements

A memorandum was provided by the Public Works Department with spreadsheets for 2020 and 2019 and a couple sample agreements. Mayor Mironov stated the agreements are discussed by Council and should be sent out in January and then once they come back, they are scheduled for an upcoming agenda. Mayor and Council directed Public Works to send out to the Kelly Bills and to provide confirmation when that is done.

2. Township Gun Lock Safety Program

Mayor and Council Members were unanimous to move forward with the event for March.

3. Smoking in Township Recreation and Park Facilities

Mayor Mironov stated Council Members received information on this proposed Ordinance that will prohibit smoking in recreation areas or parks, including information on state regulations and what other municipalities are doing on this subject. Mayor and Council requested the Ordinance be listed on the next Council agenda.

4. Open Space Properties on Woods Road

Mayor and Council Members discussed several properties as potential open space acquisition targets. Council unanimously agreed upon and requested staff to provide further information to move forward on the purchase of 139 Woods Road, 140 Woods Road, 117 Woods Road, 110 Wood Road and Old York Road (Rear) for the Township Open Space inventory. Council Members also agreed that 699 Route 33 was not a property of interest.

5. Abandoned Foreclosed Property Program Administration

Mayor Mironov stated that the Township Manager, Municipal Clerk and Finance Officer need to meet and discuss the shortfall in revenue for 2020.

**RESOLUTION AUTHORIZING THE EAST WINDSOR TOWNSHIP
PLANNING BOARD TO CONDUCT A PRELIMINARY
INVESTIGATION**

**TO ESTABLISH A NON-CONDEMNATION REDEVELOPMENT AREA
WITHIN
THE TOWNSHIP OF EAST WINDSOR**

WHEREAS, N.J.S.A. 40A:12A-6, authorizes the governing body of any municipality, by Resolution, to have its Planning Board conduct a preliminary investigation to determine whether any area of the municipality is a redevelopment area; and

WHEREAS, N.J.S.A. 40A:12A-4(b)(2) authorizes the planning board of any municipality to prepare a redevelopment plan for a proposed redevelopment area; and

WHEREAS, the Mayor and Council of the Township of East Windsor consider it to be in the best interest of the Township to have the Township Planning Board conduct such an investigation regarding those parcel of land known as 200 Etra Road and designated on the official Tax Map of the Township as Block 22.02, Lots 2.02, 8.01, 11.01 (the "Property"); and

WHEREAS, a non-condemnation redevelopment area determination shall authorize the Township to use all those powers provided by the Legislature for use in a redevelopment area but for the use of eminent domain (hereinafter referred to as a "Non- Condemnation Redevelopment Area"); and

WHEREAS, the present buildings and improvements at the Property, by reason of obsolescence and/or general deterioration and/or design and obsolete layout, may be detrimental to the safety and welfare of the community, thereby requiring redevelopment to better serve the Township;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The East Windsor Township Planning Board is hereby directed to conduct a preliminary investigation to determine whether the Property is a Non- Condemnation Redevelopment Area according to the criterion in N.J.S.A. 40A:12A-1 et seq.;
2. The East Windsor Township Planning Board is hereby directed to prepare a report of its findings and once completed, is hereby directed to transmit the report to the Mayor and Township Council for their review and approval in accordance with the provisions of the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1.
