An Ordinance Accepting Donation of Real Property Located off of Old York Road and Designated as Block 42, Lot 13 on the East Windsor Township Tax Map

AN ORDINANCE ACCEPTING DONATION OF REAL PROPERTY LOCATED OFF OF OLD YORK ROAD, AND DESIGNATED AS BLOCK 42, LOT 13 ON THE EAST WINDSOR TOWNSHIP TAX MAP

WHEREAS, David Saltman is the owner of the property located off of Old York Road and designated as Block 42, Lot 13 on the East Windsor Township Tax Map, consisting of 2.6 acres, and has signed a Quit Claim Deed transferring all of his interest in this property to East Windsor Township; and

WHEREAS, the Township Council has determined that it is in the best interests of the Township of East Windsor to accept the donation of Block 42, Lot 13.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer, State of New Jersey, as follows:

SECTION 1. AUTHORIZATION.

- A. The Township hereby accepts the donation of the property located off of Old York Road and designated as Block, 42, Lot 13 on the East Windsor Township Tax Map, consisting of 2.6 acres.
- B. The Mayor, Municipal Clerk, and Township Attorney are hereby authorized to take all necessary actions to acquire the property located off of Old York Road and designated as Block, 42, Lot 13 on the East Windsor Township Tax Map, consisting of 2.6 acres.

SECTION 2. REPEAL. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. SEVERABILITY. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. EFFECTIVE DATE. This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov declared the public hearing open on Ordinance 2020-11. With no comment from the public being made, Mayor Mironov declared the public hearing closed.

WHEREAS, the Township Council has determined that it is in the best interest of the Township to accept the donation of the Property and to discharge the municipal tax lien evidenced by certificate number 01-41.

Resolution R2021-045 Approving Amendments to 2021 Temporary Budget Appropriations

RESOLUTION R2021-045 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, by Resolution R2021-008, adopted on January 5, 2021, the Township Council established a Temporary Budget for 2021, in the amount of \$4,790,450.00 for current fund plus \$565,000.00 for Garbage District No. 1 for a total amount of \$5,355,450.00; and

WHEREAS, an emergent condition has arisen with respect to municipal operating expenses until the official budget is adopted and no adequate provision has been made in the 2020 temporary appropriations for the aforesaid purpose, and N.J.S.A. 40A:4-20 provides for emergency temporary appropriations for this purpose; and

WHEREAS, this appropriation increases the 2021 Temporary Budget for Current Fund by \$4,235,336.00 plus \$250,000.00 for Garbage District No. 1 totaling \$4,235,336.00 resulting in emergency temporary Resolutions adopted in 2021, pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A:4-20) including this Resolution, for a total amount of \$9,840,786.00.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, that in accordance with the provisions of N.J.S.A. 40A:4-20:

- 1. The attached additional Emergency Temporary Appropriations are hereby made in the total amount of \$4,235,336.00 plus \$250,000 for Garbage District No. 1 totaling \$4,485,336.00, resulting in a total amount of \$9,840,786.00.
- 2. These emergency temporary appropriations have been provided for in the 2021 budget.
- 3. One certified copy of this Resolution shall be filed with the Director of Local Government Services.

Resolution R2021-047

Approving Establishment of Updated Township "Complete Streets" Policy

RESOLUTION R2021-047 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, East Windsor Township is committed to creating a pedestrian and bikeway system to the extent feasible, by creating street corridors that safely accommodate all road users of all ages, abilities and disabilities; and

WHEREAS, the New Jersey Department of Transportation Complete Streets policy states "A Complete Street is defined as means to provide safe access for all users by designing and operating a comprehensive, integrated, connected multi-modal network of transportation options."; and

WHEREAS, as part of this policy, the New Jersey Department of Transportation strongly encourages the adoption of similar policies by regional and local jurisdictions who apply for funding through Local Aid programs; and

WHEREAS, the benefits of complete streets include: improving safety for pedestrians, bicyclists, children, older citizens, non-drivers and the mobility challenged as bicycling and walking trip generators such as employment, education, residential, recreation, retail centers and public facilities; promoting healthy lifestyles; creating more livable communities; reducing traffic congestion and reliance on carbon fuels thereby reducing greenhouse gas emissions; and saving money by incorporating sidewalks, bike lanes, safe crossings and transit amenities into the initial design of a project, thus sparing the expense of retrofits later; and

WHEREAS, complete streets have the potential for improving physical and mental health either directly or indirectly in the following ways:

- a) Incorporating physical activity into our daily lives by increasing pedestrian activity and bicycle use.
- b) Reducing rates of several chronic diseases related to increases in physical activity from walking and bicycling. Key impacted diseases include diabetes, heart disease, depression, and some cancers.
- c) Reducing rates of injury and death from decreased traffic crashes and improved road safety for all users.
- d) Reducing rates of asthma and other respiratory issues due to improved air quality through emissions reductions and vegetative air filtration.
- e) Multiplying health and wellness benefits resulting from improved access to necessary amenities for vulnerable populations.
- f) Reducing the risk of illnesses related to water-borne pathogens resulting from improved stormwater infiltration.
- g) Increasing the sense of social connectivity and sense of community belonging.
- h) Improving aesthetics through decorative and functional vegetation.

WHEREAS, the East Windsor Township Council supports, to the extent practicable, the application of an East Windsor Township "Complete Streets" policy that will apply to all road, bridge, and building projects undertaken by East Windsor.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. All public street projects, both new construction and reconstruction undertaken by the Township of East Windsor shall be designed and constructed as "Complete Streets" whenever feasible to do so, and subject to municipal considerations including scarcity of population and travel, outweighed by detrimental environmental or social impacts, disproportionate costs generated, and project timing, in order to safely accommodate travel by pedestrians, bicyclists, public transit and motorized

vehicles and their passengers with special priority given to pedestrian safety.

- 2. All initial planning and design studies of complete street infrastructure projects shall consider opportunities to improve public health
- 3. Pedestrian and bicycle facilities and other alternate forms of transportation shall not be required where they are prohibited by law.
- 4. Public transit facilities shall not be required on streets not serving as transit routes and the desirability of transit facilities will be determined on a project specific basis.

REPORTS BY COUNCIL AND STAFF:

Ms. Daniels stated the Health Advisory Board met on March 11 and discussed moving forward on several projects including Yoga in the Park and a possible farmer's market event, and that proposals were coming in soon.

Mr. Zoller stated the Environmental Commission met on March 17 and discussed the Arbor Day Seedling Giveaway at the PAL Fields. The Environmental Commission is seeking Council's approval to have the event on May 1 with a rain date of May 8. Mr. Zoller added that

Commission Members are continuing online training with the Community Forestry Program through Rutgers. The Environmental Commission also discussed the Etra Park Arboretum project and have identified a vendor to provide signage for each specimen tree and a potential supplier for the larger entrance sign. Mr. Zoller stated the Commission is also looking for the Township's assistance in purchasing and installing 4x4 posts for each of the thirty specimen trees in the Arboretum. He added the Environmental Commission also discussed electrical vehicles so the Township is prepared for the eventuality. Mayor Mironov asked Mr. Brady to reach out to PAL to make sure they are okay with the proposed dates for the seedling giveaway. She further requested flyer/promotional information with details regarding the event.

Mr. Yeager stated the Recreation Commission met on March 10 and discussed sponsorships of Township events and possible options for virtual after school programs and events. Mr. Yeager stated they also discussed Summer Events at Etra Park and they are hoping to reach a final decision on possible next steps for the summer camp programs in April.

She also appointed Adam Palant as an Auxiliary Member of the Environmental Commission, Emmaleigh Hauck as an Auxiliary Member of the Health Advisory Board and Raph Copeland as an Auxiliary Member of the Clean Communities Committee for unexpired terms ending December 31, 2021.

APPROVAL OF BILLS:

Mayor Mironov stated a 2021 Current Bill list, 2020 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided with the holds and clarifications.

Mayor Mironov questioned, page 5 of the Current 2021 bill list, the CAFR item and requested clarification on what that is. She further questioned why the drunk driving enforcement money is still existing from 2019 and inquired on how much is remaining

in the account. Council Member Zoller questioned the towing services on page 6 of the Current 2021 bill list and on page 13 of the Current 2021 bill list the Medicare Part B 2019. Mayor Mironov requested to hold the items for further clarification. The Township Manager stated he will get the information and get back to Mayor and Council will the clarifications requested.

It was MOVED by Zoller, SECONDED by Shapiro to approve the Bill Lists with the hold and clarifications.

MATTERS BY COUNCIL:

Mayor Mironov requested to add a Change Order Resolution to the April 6, 2021 Council agenda for the East Windsor Volunteer Fire Company #2 fire truck. Mayor Mironov requested staff to look into the municipal aid rescue plan to see how much funding the Township can get, when it can be received and what the money can be used for. She requested a status update from the Township Attorney on Magnolia Ridge. Mayor Mironov also requested a status update on the Shoppes of East Windsor project. Mayor Mironov requested that the Municipal Clerk provide Mayor and Council with the process of the maintenance bonds and ensure that all written communications are to be provided to the Mayor and Township Manager. She also requested that the Municipal Clerk follow-up on the maintenance bond email from Hovione. Mayor Mironov requested staff to look into additional stripping for One Mile Road and Route 133 for pedestrian safety. She also requested that the Township Attorney reach out to Comcast for an extension of time regarding the renewal of the Comcast Application. Mayor Mironov stated a Comcast Committee needs to be formed with no more than five people. Council Member Zoller volunteered to be on the Committee. Mayor Mironov also stated that the permanent financing bills need to be addressed by staff.

5. Municipal Budget Review

Mayor Mironov requested an addition to expenditures to increase the reserve in the amount of \$5,000 for uncollected taxes to a total amount of \$955,000. She also anticipated an addition to the revenue receipts of uncollected taxes of \$513,000 then the additional \$100,000 can come from fund balance accounts. She requested that the Township Manager provide Mayor and Council with the budgets for the four volunteer agencies. She further stated that the average residential home pricing should be the same rate as 2020. Mayor Mironov stated that the introduction of the budget will be on the April 6 Council Meeting agenda and a summary with the final changes needs to be provided to Mayor and Council prior to that meeting.
