CALL TO ORDER:

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 5:30 p.m. on Tuesday, May 18, 2021.

VERIFICATION:

Municipal Clerk Kelly Lettera certified that the meeting was noticed on January 11, 2021 in the annual meeting notice. On May 14, 2021, notices were sent to the Trenton Times, filed in the office of the Municipal Clerk and posted in the East Windsor Municipal Building. All requirements of the open public meeting act have been satisfied.

FLAG SALUTE: Led by Chief of Police James Geary.

PRESENTATIONS & PROCLAMATIONS:

Mental Health Awareness Month – May 2021

Mayor Mironov proclaimed May as Mental Health Awareness Month and spoke to the importance of mental health and reducing the stigma and discrimination often associated with mental illness or seeking treatment for mental illness. Mayor Mironov introduced Julia Dare, the Director of Development for NAMI Mercer County, and stated NAMI is a great resource in the local region that provides support services and promotes public education to increase the understanding of mental health. Ms. Dare thanked Mayor Mironov for the recognition and spoke about the upcoming NAMI Walk fundraising event to be held on May 22 and introduced local resident Rob Dolnick, a NAMI Mercer volunteer and NAMI Walk Committee Member, to discuss the event further. Mr. Dolnick spoke to his personal experience with mental health and how residents could get involved with the NAMI Walk event to support their organization. Mayor Mironov thanked Ms. Dare and Mr. Dolnick for sharing their experiences and for the work of NAMI Mercer.

PUBLIC FORUM:

Matt Kohut, 995 Windsor Perrineville Road, commented on Ordinance 2021-04 and expressed his support for allowing cannabis businesses in the Township. Mayor Mironov thanked Mr. Kohut for his comment and stated the Ordinance would be discussed in further detail at a later point in the meeting. Mayor Mironov stated the State took some time to pass legislation concerning legalized marijuana and they have yet to formulate the rule and regulations. The current legislation imposes all classes of use, including sales, growing and distribution, in all commercial zones within the municipality for a period of five years unless the municipality adopts an Ordinance prohibiting those uses. Mayor Mironov stated it is an odd approach and it is encouraging towns to opt out so this is not imposed on the municipality without any opportunity to review the subject and determine what the Township and its residents might be interested in for the future. Mayor Mironov stated the Ordinance as introduced tonight will allow for a thoughtful planning process, and is not a decision regarding marijuana use but as to the businesses themselves.

There being no other members of the public who wished to speak, Mayor Mironov closed the public forum.

"Cannabis Businesses Prohibited", of the Revised General Ordinances of the Township of East Windsor, County of Mercer, State of New Jersey

ORDINANCE NO. 2021-04 TOWNSHIP OF EAST WINDSOR MERCER COUNTY NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XX, "ZONING," SECTION 20-4.0000 "GENERAL PROVISIONS," SUBSECTION 20-4.0200, "CLASSES OF USES," ADDING NEW PARAGRAPH 20-4.0201.c. "CANNABIS BUSINESSES PROHIBITED", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR, COUNTY OF MERCER, STATE OF NEW JERSEY

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from one licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for
 consumer purchases that are fulfilled by a licensed cannabis retailer in order to
 make deliveries of the purchased items to a consumer, and which service would
 include the ability of a consumer to make a purchase directly through the cannabis
 delivery service which would be presented by the delivery service for fulfillment
 by a retailer and then delivered to a consumer

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times of operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (*i.e.*, by August 22, 2021); and

WHEREAS, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Council of the East Windsor Township ("Township") has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of Township residents and members of the public who visit, travel, or conduct business in the Township, to amend the Township's zoning regulations to prohibit all manner of marijuana-related land use and development within the Township; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

NOW THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR, in the County of Mercer and the State of New Jersey, as follows:

<u>SECTION 1.</u> Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere

in the Township, except for the delivery of cannabis items and related supplies by a delivery service located outside of the Township.

SECTION 2. Section 20-4.000, "General Provisions", Subsection 20-4.200, Classes of Uses", is hereby amended and supplemented by the addition of new Paragraph 20-4.0201.c., "Cannabis Businesses Prohibited", as follows:

c. "Cannabis Businesses Prohibited". All classes of cannabis businesses, all classes of cannabis establishments or cannabis distributors or cannabis delivery services as these defined in section 3 of P.L. 2021, c. 16 are prohibited except for the delivery of cannabis items and related supplies by a delivery service located outside of the Township.

SECTION 3. REPEALER. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. SEVERABILITY. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

SECTION 5. EFFECTIVE DATE. This ordinance shall take effect 20 days after final passage and publication according to law and filing with the Mercer County Planning Board, and as otherwise provided for by law.

Mayor Mironov stated Ordinance 2021-04 had been introduced at the Council meeting on May 4, 2021 and public hearing was scheduled for this evening. Mayor Mironov opened the meeting to the public and asked for any comments, acknowledging that Mr. Kohut offered his comments earlier in the meeting. As no other members from the public asked to speak, Mayor Mironov closed the public forum.

Mayor Mironov asked for a motion to refer Ordinance 2021-04 to the Planning Board pursuant to the Municipal Land Use Law for their review and comment and to carry the public hearing on Ordinance 2021-04 to June 8, 2021.

It was MOVED by Yeager, SECONDED by Lippman to refer Ordinance 2021-04 to the Planning Board pursuant to the Municipal Land Use Law and carry the public hearing on Ordinance 2021-04 to June 8, 2021.

WHEREAS, the Township's current contract for the collection of comingled recyclables (glass, aluminum and ferrous cans, plastics, newspaper, mixed paper and cardboard) in the East Windsor Township Garbage District will expire on May 31, 2021; and

WHEREAS, there is a need to secure a new contract for the collection of comingled recyclables in the East Windsor Township Garbage District; and

WHEREAS, an invitation to bid for the collection of comingled recyclables in the East Windsor Township Garbage District was issued and posted/advertised on March 3, 2021, seeking alternative pricing for a one year contract (with and without options), a three year contract (with and without options) and a five year contract; and

WHEREAS, one bid was received by the East Windsor Municipal Clerk's Office on May 4, 2021 from the Township's current vendor, Central Jersey Waste & Recycling, Inc.; and

WHEREAS, the Township Council has reviewed the recommendations made by the Director of Public Works; and

WHEREAS, the total cost of the three year contract is \$726,385.74 with each year broken down as follows: Year 1: \$235,008.00; Year 2: \$242,058.25; Year 3: \$249,319.49; with the following options: Year 4: \$256,799.08; Year 5: \$264,503.06 and sufficient funds are available in the Municipal Solid Waste Collection District Budget Account No. 1-30-32-305-300-236 entitled "Contractual Services" in the amount of \$141,200.64; sufficient funds will be available for Year 2 in the Municipal Solid Waste Collection District Budget Account No. 2-30-26-305-300-236

entitled "Contractual Services" in the amount of \$239,120.64; sufficient funds will be available for Year 3 in the Municipal Solid Waste Collection District Budget Account No. 3-30-26-305-300-236 entitled "Contractual Services" in the amount of \$246,293.97; sufficient funds will be available for Year 4 in the Municipal Solid Waste Collection District Budget Account No. 4-30-26-305-300-236 entitled "Contractual Services" in the amount of \$103,883.12, contingent upon the adoption of the 2022, 2023 and 2024 Municipal Solid Waste Collection District Budget, as evidenced by the Chief Finance Officer's Certification No. G2021-002.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, County of Mercer, State of New Jersey, as follows:

- 1. A three year contract with two one year options for the collection of comingled recyclables in the East Windsor Township Garbage District is hereby awarded to Central Jersey Waste & Recycling, Inc, 432 Stokes Avenue, Ewing, NJ 08638, for the period beginning June 1, 2021 and ending May 31, 2024, at the following annual costs: Year 1: \$235,008.00; Year 2: \$242,058.25; Year 3: \$249,319.49; with the two one year options as: Year 4: \$256,799.08; Year 5: \$264,503.06, for a total three year term not to exceed \$\$726,385.74.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the contract.
- 3. The Municipal Clerk is hereby authorized and directed to return the certified check or bid bond of the successful bidder upon the receipt of a fully executed contract.

Mayor Mironov stated a recommendation on this award had been received from the Public Works Director. She stated this is a significant award with a pricing increase from previous years. Mayor Mironov stated the contract operates on a per unit basis, so while it does have the potential of providing for an increased recycling tonnage grant award, it does not save the Township any money. The contract is for a three-year term with an option to renew for two years. Mayor Mironov asked if the contract allows for two separate one-year renewals, or just one two-year renewal, and if the renewals are at the option and discretion of the Township. Mr. Orron stated the contract allows for two one-year renewal options and does not require the consent of the vendor to renew.

Mr. Zoller stated that he is concerned that Central Jersey Waste and Recycling was the only bidder on this contract, and according to Mr. Askenstedt's memo, there is no expectation that there will be bidders for future recycling contracts. Mr. Askenstedt stated that all municipalities in the County have experienced this issue, as there has been a loss of markets overseas that no longer accept American recycling or residential recycling. Mayor Mironov asked what prospects or opportunities the Township may have for the future. Mr. Askenstedt stated he did not know if the situation would improve in the future nationally, but recommended locking in the contract at the current pricing for three years and exercising the renewal options. Mr. Zoller asked that reach out to other municipalities in Mercer County to get their suggestions to create a policy to protect the Township.

WHEREAS, the Township Council believes that the purposes of recreation and conservation for open space will be advanced through the lease of a portion of the property for farming purposes, as identified on attached *Schedule A*; and

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. East Windsor Senior Center Expansion Project

Mayor Mironov requested that Council proceed to Discussion Item Number 1 regarding the Senior Center, as Charlene Kim from Settembrino Architects was present to discuss the matter. Council agreed to move forward to Discussion Item Number 1.

Mayor Mironov stated there are two topics that are pending right now for the project. The first is the site work proposals and recommendation, which Kevin Settembrino is working on, but she noted for the record that no information on the subject had yet been received by the Governing Body. Mayor Mironov stated the second topic pertains to design elements including materials and colors, and Council discussed the subject at a previous meeting with Ms. Kim. Ms. Kim has followed up and provided additional information to address questions raised during the last discussion. Mayor Mironov asked Ms. Kim to review the art room wall paint color, the multipurpose room flooring and the gym flooring.

Ms. Kim stated she provided four more color options in the yellow/blue/green spectrum for the art room based on the feedback that the original color was too bold. Mayor Mironov stated photographs of the color swatches had been distributed, and the shades were named Bora Bora Shore, Tame Teal, Bluebell and Lemon Chiffon. Ms. Daniels stated she likes Bora Bora Shore and Tame Teal. Mayor Mironov asked how these shades compare to the original shade that was too bold. Ms. Kim stated the original shade was called Surfing, and was darker than all four of the new options presented tonight. Mr. Lippman stated he did not like Bluebell. Mayor Mironov stated she did not prefer Lemon Chiffon. Mr. Shapiro stated he liked Bora Bora Shore. Mayor Mironov asked for any further input. Mayor and Council unanimously agreed that while they are leaning toward Bora Bora Shore, Mayor Mironov and Ms. Daniels would follow up for input from the Commission on Aging.

Mayor Mironov asked Ms. Kim to review the multi-purpose room flooring. Ms. Kim stated that she spoke with many flooring manufactures and representatives and they concluded that because it is not known what equipment will be used in this room, the rubber tiled material is the best option for the space given its versatility of use. Mayor Mironov stated, based on the sample that was provided, she is concerned about the material and how it will look. She asked if the tiles are larger or smaller in size. Ms. Kim confirmed that this type of flooring would be tiles that interconnect with one another like a puzzle, but the specific size of the tiles would be between the contractor and the architect as that relates to installation. She stated the floor is a black material with tan colored specks. Mayor Mironov asked if the seams could cause a tripping hazard. Ms. Kim stated that was taken into consideration and the seams would not present any tripping hazard. Mayor Mironov asked if that stipulation could be put into writing. She also asked for more information as to how the flooring will be attached to the existing floor, how the tiles will interconnect, and the integrity of the linking pieces. Mr. Lippman stated he thinks these are significant questions that need to be answered before Council can agree to the material. Mr. Zoller asked if there were any other municipalities in the area that have used similar flooring that can share their thoughts and experiences. Mayor Mironov agreed with Mr. Zoller's suggestion and asked that be included with the other requested information pertaining to the flooring.

Ms. Kim moved on to discuss the laminate vinyl flooring to be installed in the multi-purpose room. Ms. Kim stated the specifications are for a wood grain laminate vinyl flooring. She presented a visual exhibit with different flooring color swatches. She stated the Council had previously indicated a preference for a medium wood tone, and she would make that recommendation because this will be a high traffic area. Ms. Daniels stated she preferred the color swatches as presented by Ms. Kim, as the distributed color swatches appeared more orange

in tone, whereas tonight's presentation shows true brown tones. Mr. Yeager and Mr. Shapiro agreed with Ms. Daniels. Mr. Zoller expressed that he would prefer a neutral tile floor instead of a wood grain floor, as it looks more traditional to the existing flooring in the Senior Center.

Mayor Mironov thanked Ms. Kim and stated that Council would provide further feedback and any additional requests for information in order to finalize the material choices.

APPLICATIONS:

REPORTS BY COUNCIL AND STAFF:

Mr. Shapiro reported the Planning Board met on May 17 and discussed a rooftop solar array for Home Depot and a pharmaceutical tenant proposing to occupy the last building in the SciPark development.

Mr. Yeager stated the Recreation Commission met on May 12 and discussed summer camp and other programs.

Ms. Daniels reported the Health Advisory Board met on May 13 and discussed upcoming events including a blood drive, the opening of the Community Garden, Yoga in the Park and some other possibilities for future programming.

Mr. Zoller stated the Economic Development Committee met on May 6 and discussed the Township Gateway signs and that renderings had been provided to Council. The Committee also discussed the Route 130 entrance art project and signage on the Public Works garage building fronting the Turnpike.

APPROVAL OF BILLS:

Mayor Mironov stated a 2021 Current Bill list, 2020 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mr. Zoller asked for more information on the step compressor replacement invoice on page two of the Current bills list. Mr. Zoller also asked for more information for the invoice to True Green Lawn Service on page 8 of the Current bills list, including what work and period of time the invoice covers.

It was MOVED by Lippman, SECONDED by Yeager to approve the Bill Lists.

ROLL CALL: Ayes – Daniels, Lippman, Rosenberg, Shapiro, Yeager, Zoller, Mironov Nays – None There being seven (7) ayes and no (0) nays, the various presented Bill Lists were approved.

MATTERS BY COUNCIL:

Mayor Mironov stated the following correspondence had been received: a memo from the Department of Public Works dated April 20 regarding the bridge repair; a memo from the Chief of Police dated May 5 regarding desktop computer acquisition; a copy of a letter that was sent to the Housing and Community Development Director of Mercer County regarding the HOME program; a letter from T&M Associates dated April 16 regarding an update to the infrastructure improvement fund; a letter from Mercer County dated May 11 regarding truck sign and pedestrian improvements along Route 571, and a communication from Mercer County that resurfacing of Princeton Hightstown Road between Route 130 and One Mile Road will commence on or about May 20.

Mayor Mironov stated at a previous Planning Board meeting, the Board approved and memorialized a Resolution for OTR, a residential development along Old Trenton Road in the area of Windsor Center Drive. The development will consist of 186 units, and the developer applied to Mercer County for County Planning Board approval after receiving approval from the Township. Mercer County has imposed a condition on the developer, requiring they provide a vehicular cross easement with a project directly adjacent to the subject site in West Windsor. Mayor Mironov stated this was done without any communication of consultation with the Township. The developers have appealed the condition to the Board of County Commissioners. Mayor Mironov stated that at the Planning Board meeting on May 17, the Board approved a Resolution with the condition that no such easement is allowable unless it receives the express approval of the Planning Board. There was a motion and a unanimous vote by the Planning Board to authorize the Municipality's position that the Township supports the Developer's appeal and finds this to be an inappropriate condition. Mayor Mironov indicated she would like to write a letter to the County Commissioners and to speak briefly at their next meeting regarding the Township's position. She asked for input and comments from the other Council members. Mr. Yeager stated that he thinks Mayor Mironov has suggested an appropriate course of action and he would support it.

It was MOVED by Yeager, SECONDED by Rosenberg to support the appeal by OTR of this condition as imposed by the Mercer County Planning Board.

2. Redevelopment of 19 Probasco Road (Block 15, Lots 1.02 and 12)

Mayor Mironov stated that the tax map and property card for the site had been distributed to Council members. She stated this is a very visible property that is located close to Twin Rivers, and the current developers are in support of a redevelopment process. Mr. Zoller asked if the property is still an active truck terminal or if the property will be razed. Mayor Mironov stated she was not sure about the current status of the truck terminal, but stated that at some point the truck terminal will likely no longer be located on the property.

Approving Investigation of 19 Probasco Road (Block 15, Lots 1.02 and 12) for Designation as Area in Need of Redevelopment

RESOLUTION R2021-093 EAST WINDSOR TOWNSHIP MERCER COUNTY

RESOLUTION AUTHORIZING THE EAST WINDSOR TOWNSHIP PLANNING BOARD TO CONDUCT A PRELIMINARY INVESTIGATION TO ESTABLISH A NON-CONDEMNATION REDEVELOPMENT AREA WITHIN THE TOWNSHIP OF EAST WINDSOR

WHEREAS, N.J.S.A. 40A:12A-6, authorizes the governing body of any municipality, by Resolution, to have its Planning Board conduct a preliminary investigation to determine whether any area of the municipality is a redevelopment area; and

WHEREAS, N.J.S.A. 40A:12A-4(b)(2) authorizes the planning board of any municipality to prepare a redevelopment plan for a proposed redevelopment area; and

WHEREAS, the Mayor and Council of the Township of East Windsor consider it to be in the best interest of the Township to have the Township Planning Board conduct such an investigation regarding those parcel of land known as 19 Probasco Road and designated on the official Tax Map of the Township as Block 15, Lot 1.02 and 12 (the "Property"); and

WHEREAS, a non-condemnation redevelopment area determination shall authorize the Township to use all those powers provided by the Legislature for use in a redevelopment area but

for the use of eminent domain (hereinafter referred to as a "Non-Condemnation Redevelopment Area"); and

WHEREAS, the present buildings and improvements at the Property, by reason of obsolescence and/or general deterioration and/or design and obsolete layout, may be detrimental to the safety and welfare of the community, thereby requiring redevelopment to better serve the Township;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- The East Windsor Township Planning Board is hereby directed to conduct a
 preliminary investigation to determine whether the Property is a NonCondemnation Redevelopment Area according to the criterion in N.J.S.A.
 40A:12A-1 et seq.;
- 2. The East Windsor Township Planning Board is hereby directed to prepare a report of its findings and once completed, is hereby directed to transmit the report to the Mayor and Township Council for their review and approval in accordance with the provisions of the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A.

It was MOVED by Zoller, SECONDED by Lippman to approve Resolution R2021-093.

7. New Jersey Department of Community Affairs Local Recreation Improvement (LRIG) 2021 Grant Program

Mayor Mironov stated this matter was discussed at the last Council meeting, and Council had previously expressed interest in Anker Park. She stated a draft grant application and possible equipment options had been distributed, and the application deadline is May 24. Mayor Mironov stated she reviewed the equipment options and was not a fan of the sun shades, as they have the potential for extra maintenance issues. She asked for information on what programs the

Township currently has in place for regular maintenance of playground equipment. Mayor Mironov added that she would prefer to prioritize new playground equipment and the walking trail for Anker Park over some of the other suggest improvements, such as another pavilion. Mr. Zoller stated he agreed with Mayor Mironov. He asked about the condition of the existing pavilion at Anker Park and if it needs replacement. He added that while he appreciates the sun shades for UV protection, he would be concerned that they would get damaged or lost during a storm. Mayor Mironov stated that as for the pavilion, it is used frequently and could use some sprucing up but the Director of Public Works would have to advise further as to the condition of the pavilion. Mr. Yeager stated the pavilion is popular with families in the area, and while he would be in favor of fixing it up, he agreed with Mayor Mironov that the focus of this grant application should be for playground equipment. Mr. Brady stated the pavilion is well used and in good condition, and the project proposal was for a second pavilion, not the replacement of the first one. Mr. Lippman stated he agreed with Mr. Zoller's concerns regarding the sun shades. Mr. Brady stated the sun shades would be removed from the application.

Approval of Filing of Application for the 2021 New Jersey Department of Community Affairs Local Recreation Improvement Grant (LRIG)

RESOLUTION R2021-094 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, The New Jersey Department of Community Affairs, Division of Local Government Services, is soliciting grant applications under the 2021 Local Recreation Improvement Grant (LRIG) to support the funding for improvements and repairs of public recreation facilities including local parks, municipal recreation centers and local stadiums; and

WHEREAS, the LRIG funds cover one-time costs associated with updating community centers, playgrounds, pools, fields, walking or bicycle trails, rail trails, multi-sport courts, and recreational facilities; and

WHEREAS, East Windsor Township desires to submit an application for financial assistance to improve East Windsor Township's Anker Park located at 200 Hickory Corner Road.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, that:

The Mayor is hereby authorized and directed to submit an electronic application identified as "Anker Park Improvements" to fund improvements to Anker Park for new playground equipment, a new rubberized playground surface, drainage remediation and an asphalt pathway on behalf of East Windsor Township to New Jersey Department of Community Affairs, Division of Local Government Services, 2021 Local Recreation Improvement Grant (LRIG).

2. The Mayor is hereby authorized to sign the grant agreement on behalf of East Windsor Township and her signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.

Mr. Zoller stated that of the suggested dates, he would advocate for July 11 to allow for more time to solicit sponsors and make a final decision regarding COVID protocols. Ms. Daniels agreed with Mr. Zoller. Mayor Mironov stated she is also in support of July 11.
