### **CALL TO ORDER:**

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 5:30 p.m. on Tuesday, June 8, 2021.

### **VERIFICATION:**

Municipal Clerk Kelly Lettera certified that the meeting was noticed on January 11, 2021 in the annual meeting notice. On June 4, 2021, notices were sent to the Trenton Times, filed in the office of the Municipal Clerk and posted in the East Windsor Municipal Building. All requirements of the open public meeting act have been satisfied.

### **MINUTES:**

### March 10, 2020

It was MOVED by Lippman, SECONDED by Daniels to approve the March 10, 2020 minutes.

An Ordinance Amending and Supplementing Chapter XX, "Zoning," Section 20-4.0000 "General Provisions," Subsection 20-4.0200, "Classes of Uses," Adding New Paragraph 20-4.0201.c. "Cannabis Businesses Prohibited", of the Revised General Ordinances of the Township of East Windsor, County of Mercer, State of New Jersey

ORDINANCE NO. 2021-04 TOWNSHIP OF EAST WINDSOR MERCER COUNTY NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XX, "ZONING," SECTION 20-4.0000 "GENERAL PROVISIONS," SUBSECTION 20-4.0200, "CLASSES OF USES," ADDING NEW PARAGRAPH 20-4.0201.c. "CANNABIS BUSINESSES PROHIBITED", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR, COUNTY OF MERCER, STATE OF NEW JERSEY

**WHEREAS**, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from one licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer
  purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of
  the purchased items to a consumer, and which service would include the ability of a
  consumer to make a purchase directly through the cannabis delivery service which would
  be presented by the delivery service for fulfillment by a retailer and then delivered to a
  consumer

**WHEREAS**, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times of operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

**WHEREAS**, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

**WHEREAS**, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (*i.e.*, by August 22, 2021); and

**WHEREAS**, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis

items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

**WHEREAS**, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Council of the East Windsor Township ("Township") has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of Township residents and members of the public who visit, travel, or conduct business in the Township, to amend the Township's zoning regulations to prohibit all manner of marijuana-related land use and development within the Township; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

NOW THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR, in the County of Mercer and the State of New Jersey, as follows:

**SECTION 1.** Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Township, except for the delivery of cannabis items and related supplies by a delivery service located outside of the Township.

**SECTION 2.** Section 20-4.000, "General Provisions", Subsection 20-4.200, Classes of Uses", is hereby amended and supplemented by the addition of new Paragraph 20-4.0201.c., "Cannabis Businesses Prohibited", as follows:

**c.** "Cannabis Businesses Prohibited". All classes of cannabis businesses, all classes of cannabis establishments or cannabis distributors or cannabis delivery services as these defined in section 3 of P.L. 2021, c. 16 are prohibited except for the delivery of cannabis items and related supplies by a delivery service located outside of the Township.

**SECTION 3. REPEALER.** All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4. SEVERABILITY.** If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

**SECTION 5. EFFECTIVE DATE.** This ordinance shall take effect 20 days after final passage and publication according to law and filing with the Mercer County Planning Board, and as otherwise provided for by law.

Mayor Mironov stated Ordinance 2021-04 had been introduced on May 4 and the Public Hearing, which had been originally scheduled for May 18, had been held until this evening. Mayor Mironov declared the public hearing open. As no one from the public spoke, Mayor Mironov declared the public hearing closed. She noted the Ordinance was discussed at the Planning Board meeting on June 7 and the Board had a unanimous vote that the Ordinance was not inconsistent with the Master Plan and should be adopted.

It was MOVED by Yeager, SECONDED by Rosenberg to adopt Ordinance 2021-04 and authorize publication as required by law.

Mr. Zoller stated the Economic Development Committee mt on June 3 and discussed the Township gateway signs and possible concepts for an art display at the Town entrance at the intersection of Route 130 and Route 33.

Mayor Mironov requested an updated from the Township Attorney regarding Magnolia Ridge. She also requested an update from the Township Manager as to the outstanding invoices relating to the permanent financing process the Township underwent, the no smoking signs in the local parks, and the Rescue Plan funds.

### DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. New Jersey Department of Environmental Protection Urban Parks 2021 Grant Program

Mayor Mironov stated that this is a public hearing on the State of New Jersey Department of Environmental Protection Urban Parks 2021 Grant Program application. She asked the Municipal Clerk to verify the required 15 day public notice was published. The Municipal Clerk verified the public hearing was noticed in the Trenton Times on May 18, 2021. Mayor Mironov stated that this is a formal process pursuant to the requirements of the grant that the municipality noticed the public hearing fifteen days in advance of the matter being heard. Mayor Mironov stated that notice indicated that this public hearing would be conducted by electronic means, via Zoom, and the public hearing is regarding the submission of a grant application for funding through the State of New Jersey Department of Environmental Protection Urban Parks initiative and Green Acres programs for the Wiltshire Park Improvements project, located at 23 Wiltshire Drive, Block 85, Lot 41. She stated that a draft application was included with Resolution R2021-101 in Council Member packets and was available for public inspection pursuant to this process. Mayor Mironov stated that there are a few items that need to be discussed, but generally the Urban Parks Initiative program provides the opportunity to submit a grant application for a maximum of \$500,000. This grant application is for Improvements to Wiltshire Park, including the resurfacing of the existing basketball court, the replacement of the existing playground equipment, the installation of rubber play surface for the playground, as well as potentially replacement of

walking paths, sidewalks, and the walking bridge over Bear Brook that connects Wiltshire Park to Hickory Corner Road.

Mayor Mironov opened the meeting up to the public for comments on the proposed application. With no public comment being made, Mayor Mironov declared the public hearing closed.

Mayor Mironov stated that Council still had some decisions to make regarding the application and she indicated she received an email today that the application deadline had been extended to June 30, 2021. Assistant Manager, Christopher Jackson verified the application deadline has been extended by the state until June 30, 2021. Mayor Mironov stated that Council was provided the draft application and felt under the rules of the program, the application should adhere to the maximum \$500,000 and a few items would need to be removed. She stated one item that is still included that she thought Council had previously discussed removing were the shade structures over the playground equipment. Mayor and Council agreed to include the playground equipment, basketball courts and play surface but some trimming needs to be done on the walking bridge or scale back the sidewalk work. Mayor Mironov indicated the draft application is currently \$41,717 over the \$500,000 threshold. Council Member Yeager asked if there were any structural issues with the existing bridge. Mayor Mironov stated she also asked the question before the meeting because that would be the basis for including it in the application, and the answer is that at some point it should be addressed. Mayor Mironov stated the cost for the bridge replacement is \$65,000. Council Member Daniels asked if the pathways need to be repaved in response to a safety issue. She further stated that if safety does not come into play with the sidewalks, there are alternative ways to repair the area without totally repaying the path, and suggested adjusting the playground equipment if the pathways are a safety concern. Mayor Mironov stated alternatively Council will be discussing the Capital budget later this evening and that may address her question. Mayor Mironov stated she would not be inclined to change the playground equipment for this grant application, as it would seem to do best to leave the playground equipment, the basketball courts, and the play surface material and make a decision on the walking paths, sidewalks and bridge, and address any remaining issues regarding a different funding source.

Mayor Mironov stated that her feeling is to remove the bridge, keep the walking paths and the sidewalks, and maybe add an additional \$10,000 to playground equipment or additional pathways. Council Member Yeager agreed with Mayor Mironov, stating that if the bridge is structurally sound, he would rather see the walking paths be done in whole. Mayor Mironov asked Council Members for any other questions or input. Mr. Zoller questioned the safety of the bridge. Mayor Mironov stated that matter would need to be followed up on at a later time.

Mayor Mironov stated the removal of the shade structures will need to be changed from the narrative of the grant application. She asked if there was anything else that needed to be addressed at this point there was no other comments made by Council Members. Mayor Mironov stated Resolution R2021-101 and Resolution R2021-102 would enable the Township to be qualified under both grant programs. She further stated that both Resolutions need to remove the shade structures and include the new project costs. In addition, she requested that after the Resolution have been revised copies of the revised Resolution and sample Resolutions from the grant application need to be provided to her for review.

Mayor Mironov stated Resolution R2021-101 and Resolution R2021-102 will be voted on as a block.

Mayor and Council requested the Township Manager and the Director of Public Works move forward on Cranbury Manor and provide an updated project timeline. Staff should also begin to prepare to go out to bid for roads near Brooktree Road, including Lynnfield, Maple Stream, Edwards and Poplar.

### 4. 2021 Municipal Capital Program

Mayor and Council directed staff to provide the following information: final numbers and current balance for the Annual Road Program; an inventory of the park equipment, including age, condition, and any past upgrades; additional information on the Foreman house and its cost; information on active DPW vehicles; additional information on the telephone system for the municipal building, police/court building, and the Senior Center; current balance of the Drunk Driving Enforcement Fund; current balance of the Capital Improvement fund, and what grants will be included in the capital program. Mayor Mironov and Council Members agreed this matter would be relisted once new information is available.

### 5. "No Engine Breaking" Ordinance

Mayor Mironov stated this item would be held until the next Council meeting.

### 6. Union Transportation Trail

**Resolution R2021-XXX** Amending Resolution R2018-033 Awarding Contract for Engineering Services for Union Transportation Trail with Hopewell Valley Engineering, PC

Mayor Mironov stated this item would be held until the next Council meeting. She asked staff to pin down the required match amount.

### 7. East Windsor Senior Center Expansion Project

Mayor Mironov stated this item would be held until the next Council meeting, and that project architect Kevin Settembrino would provide more information on change order options and procedures.

8. Township Summer Programs

Mayor and Council agreed to host the Independence Day celebration on July 4, with a rain date the following weekend. Staff should provide information on themed bands, patriotic music, food trucks, entertainment, and a Family Night in the park.

9. East Windsor Health Department Covid 19 Vaccination Plan, Information, Outreach, Clinics

Mayor and Council requested additional information and a detailed plan from the Health Department.
