ORDINANCE NO. 2021-05 TOWNSHIP OF EAST WINDSOR MERCER COUNTY NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER V, "GENERAL POLICE REGULATIONS," SECTION 5-2 "NOISE DISTURBANCES," SUBSECTION 5-2.3, "PROHIBITED ACTS," SUBSECTION 5-2.3.2 "SPECIFIC PROHIBITIONS," TO ADD NEW SUBSECTION 5-2.3.2.13, "ENGINE BRAKING," AND SUBSECTION 5-2.5.3. "GENERAL EXCLUSIONS" TO ADD NEW PARAGRAPH 5-2.5.3(h) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR, COUNTY OF MERCER, STATE OF NEW JERSEY

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR** in the County of Mercer, State of New Jersey, that Chapter V, "General Police Regulations," Subsection, 5-2, "Noise Disturbances," of the Revised General Ordinances of the Township of East Windsor is amended and supplemented as follows:

**SECTION 1.** Chapter V, "General Police Regulations," Section 5-2, "Noise Disturbances," Subsection 5-2.3, "Prohibited Acts," Subsection 5-2.3.2 "Specific Prohibitions," is amended and supplemented by the addition of new Subsection 5-3.2.3.2.13, "Engine Braking," and Subsection 5-2.5.3, "General Exclusions" by the addition of new Paragraph 5-2.5.3(h) as follows:

#### 5-2.3.2.13. Engine Braking Prohibited.

No person shall use or operate a mechanical exhaust device designed to aid in the braking, decompression, or deceleration of any motor vehicle that results in excessive, loud, unusual, or explosive noise from such vehicle. Engine Braking shall be prohibited in all of East Windsor Township by the driver of any motor vehicle, at any time and on any road, with any mechanical exhaust or decompression device.

**5-2.5.3(h).** Noise created by applying engine compression brakes, otherwise known as "engine braking", which is effectively muffled or if the application is necessary for the health, safety, and

welfare of the community, is exempt from the provisions of this section. Sounds created by emergency equipment for emergency purposes are also exempt. The provisions of this subsection, shall not apply to the application of unmuffled compression brakes where necessary for the protection of persons and/or property that cannot be avoided by application of an alternative braking system.

**SECTION 2.** All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

**SECTION 4.** This Ordinance shall take effect 20 days after final passage and publication according to law

Mayor Mironov stated Ordinance No. 2021-05 was introduced at the June 22, 2021 Council meeting and the public hearing was scheduled for this evening. Mayor Mironov declared the public hearing open. No public commented and Mayor Mironov declared the public hearing closed.

Mayor Mironov asked staff to provide a list of locations for "no engine braking" signage along One Mile Road and the Route 133 area.

**WHEREAS,** on May 22, 2018, by Resolution R2018-096, the Township Council approved the Grant Agreement with the Delaware Valley Regional Planning Commission for Regional Trails Phase V program grant funding of \$95,000 for the Union Transportation Trail Concept Development and Preliminary Engineering Plan as "Project No. 15-44-357, Union Transportation Trail"; and

**WHEREAS,** on April 6, 2021, by Resolution R2021-060, the Township Council approved Change Order #1, in the amount of \$8,250.00, for the final trail alignment control surveying and aerial photographs of the UTT Extension project; and

WHEREAS, this Supplemental Agreement with Delaware Valley Regional Planning Commission would modify the Union Transportation Trail Project No. 15-44-357 Agreement, to include the \$8,250 for the final trail alignment, control surveying and aerial photographs, incorporate the additional \$40,000 for \$135,000 total project amount in grant funds and provide a project completion date of December 31, 2021.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Council of the Township of East Windsor, County of Mercer, State of New Jersey, as follows:

- 1. The Council hereby approves the attached Supplemental Agreement No. 15-44-357A, Union Transportation Trail, Additional Scope and Funding to modify the June 1, 2021 Project No. 15-44-357 Agreement.

**WHEREAS**, the Township Council has reviewed the recommendations made by the Township Manager on this bid.

She directed the Committee to provide Mayor and Council with a plan with any thoughts, desires, or questions regarding the draft agreement provided by Comcast.

Mayor Mironov made the following appointments to the East Windsor Cannabis Business Committee: Council Member Denise Daniels; Council Member Marc Lippman; Skip Berman, and Walt Schmidlin. She directed the committee to explore what other local communities are doing in terms of cannabis businesses and what, if any, benefits there may be for East Windsor.

Mayor Mironov noted the following correspondence had been received: a report from the Tax Collector for the period ending June 30; a memo from the Director of Public Works dated July 7 regarding the new vehicle; a memo from the Manager dated July 8 addressing questions on the bills list from the June 8 meeting; a letter from NJDOT regarding a grant award of \$495,000, and a letter from NJDOT dated May 25 regarding the Safe Routes to Schools program.

Mayor Mironov requested Council Members Alan Rosenberg and John Zoller review the color options for the new doors and select a color as close to the existing doors as possible. Mayor Mironov noted that there are still outstanding issues with the current project schedule and there has been no further communication received from the project architect, Kevin Settembrino.
