Mr. Zoller reported the Environmental Commission met on July 21 and discussed the Community Forestry Management Plan and the Township's Sustainable Jersey certification. He also reported that they are reviewing the signage for the Etra Park Arboretum and the signage options would be shared with Council before being finalized.

Mr. Rosenberg reported the Clean Communities Committee met n July 22 and discussed the Litter Free Business award, the upcoming Recycling day event and their participation at National Night Out.

CORRESPONDENCE:

Mayor Mironov stated she would review correspondence during Matters by Council.

APPROVAL OF BILLS:

Mayor Mironov stated a 2021 Current Bill list, 2020 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided with the holds and clarifications.

It was MOVED by Zoller, SECONDED by Rosenberg to approve the Bill Lists.

There being seven (7) ayes and no (0) nays, the various Bills lists were approved.

MATTERS BY COUNCIL:

Mayor Mironov stated the following correspondence had been received: a memo from the Township Manager dated July 13 regarding questions raised at the July 12 Council meeting; a memo from the Police Department dated July 15 regarding uniforms; a letter from Mercer County Department of Transportation dated July 22 regarding a milling and resurfacing project on Stockton Street; an undated letter from the Mercer County Executive's office, received on July 20, regarding pedestrian markings on Route 571 and no trucks signage on North Main Street; and the updated tax rate pie chart provided by the Tax Collector.

Mayor Mironov stated Council had previously discussed the possibility of a fireworks event at the end of September, and asked staff to provide information on what options there might be. Mr. Lippman expressed his concerns about Covid safety during the event. Mr. Zoller, Mr. Rosenberg, Mr. Yeager, Mr. Shapiro and Ms. Daniels all agreed with Mr. Lippman's comments. Mayor Mironov agreed with Mr. Lippman and stated the Township would not host a fireworks event in September.

Mayor Mironov requested the Police Chief provide potential locations for "no engine braking" signage. Mr. Zoller stated a pedestrian crossing sign has fallen down near the Route 133 exit ramp along One Mile Road and needs to be fixed.

Mayor Mironov stated a request for payment from the contractor for Shagbark Lane and Charred Oak Lane and directed staff to review the current procedures for releasing payments and to provide information on any outstanding items to be addressed by the contractor.

Mayor Mironov requested an update on Magnolia Ridge from Township Attorney David Orron. Mr. Orron stated ACT Engineers has confirmed the street work was completed last week and he is reviewing the bond release request from the developer.

Mayor Mironov and Council discussed possible dates for the September 11 memorial. It was agreed to host the event on September 11, 2021, in honor of the 20th anniversary. Mayor Mironov request staff begin to prepare the program details and provide for review.

Mayor Mironov requested staff provide additional ideas for future Eagle Scout projects.

Mayor Mironov indicated a memo on this matter had been received from the Township Manager. She indicated the memo left several questions open as to how the Township wants to accept the money and what deadlines there are to accept the funds. Mayor Mironov requested additional information from staff, including information on the process, any deadlines, what options the Township may have to split the money amongst different categories, and how this will tie into the overall state of the 2021 budget and how that may drive the any use of the funds. She requested this information in advance of the reporting deadline of August 31, 2021.
