Ordinance No. 2023-03 An Ordinance to Exceed the Municipal Budget Appropriation Limits to Establish a Cap Bank

AN ORDINANCE TO EXCEED THE MUNICIPAL
BUDGET APPROPRIATION LIMITS AND TO

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Council of the Township of East Windsor in the County of Mercer finds it advisable to permit an increase of its CY 2023 budget by up to 3.5%, if necessary, over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Council hereby determines that an increase of up to 1 % increase in the budget for said year, amounting to \$182,765.17 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final CY 2023 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

- 1. In the CY 2023 budget year, the final appropriations of the Township of East Windsor shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$657,178.10 and that the CY 2023 municipal budget for the Township of East Windsor be approved and adopted in accordance with this ordinance; and,
- 2. Any amount authorized herein that is not appropriated as part of the final CY 2023 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.
- 3. A certified copy of this ordinance as introduced shall be filed with the Director of the Division of Local Government Services within 5 days of introduction.
- 4. A certified copy of this ordinance upon adoption, with the recorded vote included thereon, shall be filed with said Director within 5 days after such adoption.

II REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

IV EFFECTIVE DATE

This ordinance shall take effect twenty (20) days after the final passage and publication as required by law.

RESOLUTION R2023-062 EAST WINDSOR TOWNSHIP MERCER COUNTY **WHEREAS,** the Mandatory Source Separation and Recycling Act, P.L. 1987, c.102, has established a recycling fund from which a tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection has promulgated recycling regulations to Implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and to indicate the assent of East Windsor Township to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling requirements; and

WHEREAS, such a resolution should designate the individual authorized to ensure the certification to comply with requirements in N.J.A.C. 7:26A-11 is properly completed and timely filed.

REPORTS BY COUNCIL AND STAFF:

Mr. Zoller reported the Planning Board met on April 24. The Planning Board heard some initial testimony regarding the refurbishment of 89 Twin Rivers Drive for a pharmaceutical company and issued a conditional approval for 261 Etra Road for a health supplement company. Mr. Zoller also reported the Environmental Commission met on April 19 and discussed the Sustainable Jersey certification application, the Arboretum at Etra Park and the health of the trees that were planted last year. The Commission also reviewed several Planning Board projects and issued reports that were forwarded to the Planning Board.

Mayor Mironov reported that she attended the Senior Center Volunteer Appreciation Luncheon on April 24. She also reported that the Township just had a recycling/shredding event, and asked the Director of Public Works to look into revisit the vendor for the event and the event layout. Mayor Mironov also reported that the Community Garden held a kick-off event on April 15, and the Operation Medicine Cabinet event was also held on April 15.

CORRESPONDENCE:

Mayor Mironov stated she would review correspondence during Matters by Council.

APPOINTMENTS:

There were no appointments.

APPROVAL OF BILLS:

Mayor Mironov stated a 2022 Current Bill list, 2023 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

It was MOVED by Yeager, SECONDED by Russell to approve the various presented Bill Lists.

MATTERS BY COUNCIL:

Mayor Mironov reported the following correspondence had been received: a memo dated April 4 from the Chief of Police regarding the engine braking Ordinance; a report of receipts and disbursements from the Tax Collector dated April 15; a letter from Mercer County dated March 28 regarding farmland preservation; a letter dated April 26 from the Friends of the Hickory Corner Library thanking the Township for the generous donation of Barnes and Noble gift cards; a letter from the Arbor Day Foundation indicating the Township has been named a 2022 Tree City; a letter from the New Jersey Department of Transportation regarding a roadway maintenance contract that was forwarded to the Manager and Chief of Police for further information as to what roads this would affect.

Mayor Mironov asked the Township Manager if the most recent invoice from Hopewell Valley Engineering was issued in error or if it was received late. Mr. Brady confirmed it was correct and that he was processing the invoice. Mayor Mironov indicated the Economic Development Committee had reached out reading the Township Map project, and asked the Township Attorney, Manager and Clerk look into the initial steps of the project and initiate contact with the vendor. Mayor Mironov stated that Council Member Daniels would be following up with the Township Manager regarding the proposed Handy Helpers program for the Commission on Aging. Mayor Mironov stated the Department of Community Affairs issued Local Finance Notice 2023-07 with new guidelines, and asked the Finance Director to look into the matter and advise Council if there was anything they needed to be aware of. Mr. Yeager reported that a resident approached him regarding speeding on Dutch Neck Road. Mayor Mironov indicated the resident also reached out to her and that the Police Department had already begun special patrols in the area.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. New Jersey Division of Highway Traffic Safety Grants

Mayor Mironov stated Chief Hart provided a memo dated April 4 with four recommended applications. She pointed out they are the same recommendations as last year, and in the past we have not received funding for these applications, except for the Child Safety Seat program. She asked that Chief Hart reevaluate these recommendations for the future and reach out to other municipalities who have received similar grant awards for suggestions or guidance.

2. Comcast Application for Renewal of Municipal Consent

ORDINANCE – INTRODUCTION:

Comcast of Central New Jersey, L.P. to Construct, Connect,

Operate and Maintain a Cable Television and

Communications System in the Township of East Windsor,

Mayor Mironov indicated a subcommittee led by Mr. Zoller had several discussions with Comcast regarding this Ordinance. Support for community events is not reflected in the agreement, but Mayor Mironov indicated they did provide support with the purchase of computers for the Senior Center. The subcommittee had requested \$100,000 in Education Support, and Comcast countered with \$75,000 as reflected in Section 15. Mr. Zoller stated the liability insurance amount had been increased to \$5 million as a request of the subcommittee.

Mayor Mironov stated that after visiting Comcast's website, she noticed that Comcast has no direct way for customers to contact their physical store locations to check inventory, and there was no dedicated phone number for customers to contact the company. She requested a letter be drafted to Robert Clifton of Comcast on the matter.

It was MOVED by Zoller, SECONDED by Yeager to approve Ordinance 2023-09 on introduction, authorized publication by law and public hearing for May 23.

There being four (4) ayes and no (0) nays Ordinance 2023-09 was approved on introduction, authorized publication by law and public hearing set for May 23.

3. Municipal Roadway Projects Status (Lynnfield Drive, Edwards Drive, Poplar Run)

Mayor Mironov requested a status update and a projected schedule to go out to bid on this project. She also asked staff to review any grant applications submitted by the Township, as two applications were submitted for 2022 but there was no further communication, which is unusual. She indicated this was a high priority item.

- 4. Township Park Improvements
 - A. Anker Park Walking Pathway
 - B. Westfield Park

Mayor Mironov indicated the Township has applied for various different funding opportunities for these projects, so staff should be ready to move forward on these projects. She also indicated the Department of Public Works was soliciting quotes for equipment at Westfield Park.

5. State Electric Vehicle Planning Grant: Status and Required Actions

Mayor Mironov stated the Manager's Office received an email on this with an agreement for signature and a listing of possible consultants for this project from Sustainable Jersey.

6. 2023 Municipal Budget Review

Mayor Mironov stated the Township Manager and Finance Director should be inishing up the budget review books soon. She asked for information as to any differences between the 2022 and 2023 budgets. She also requested additional details on pensions, health insurance, any higher spending needs and the American Rescue Plan Funds.
