Mayor Mironov reported the following correspondence had been received: a memo from the Manager dated June 28 regarding bills list questions from the June 27 meeting; a tax collector report for the period ending June 30; a memo from DPW dated June 26 regarding the repair of Garbage Truck S-09; a letter from NJDOT regarding the Township's grant award from Greenbrook Drive; a memo from the Tax Collector dated July 18 regarding the delay in tax bills and grace period extension; two NJDOT pre-construction meeting notices for two projects (Route 130 from Westfield to Main Street and Maintenance Roadway Contract C217); a letter dated July

20 from the New Jersey Health Insurance Fund regarding health insurance fund option, and energy tax receipts certification from the state.

Mayor Mironov announced National Night out would be taking place August 1, the Latino Festival would be taking place on September 3, and the September 11 memorial would take place on September 11 this year.

Mayor Mironov and Council reviewed the dates of the next several Council meetings and decided to cancel August 8, and meet on September 12 and 26, October 10 and 24, and Wednesday, November 8.

Mayor Mironov asked for an update on the Township map from the EDC. She stated the 2021 UCF Stewardship Grant needs to be closed out by the September 3 deadline. She asked for an update on closing out the other roadway projects, what the opioid settlement funds could be used for, if the NJAG spotted lanternfly program is viable, and if the 2024 Fitness Grant program is viable.

 Resolution R2023-126 Action on East Windsor Senior Center Air Conditioning

RESOLUTION R2023-126 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, there is an immediate need to replace five air conditioning condenser units at the Senior Center; and

WHEREAS, the Township Council has reviewed the Township Manager's Statement of Need for Emergency Purchase, dated July 18, 2023, attached and incorporated herein, which declares this to be an emergency procurement under the New Jersey Local Public Contracts Law N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1 finding that the purchase may be made without public bidding; and

WHEREAS, an emergency contract pursuant to N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1, may be awarded without public advertisement for bids and bidding as the lack of adequate air conditioning for the Senior Center constitutes an emergency affecting the public health and safety, requiring the immediate purchase and installation of five replacement air conditioning condenser units for the Senior Center; and

WHEREAS, pursuant to the New Jersey Local Public Contracts Law, specifically N.J.S.A. 40A:11-6 and N.J.A.C. 5:34-6.1, the Township Manager's Statement of Need for Emergency Purchase, dated July 18, 2023, a copy of which memorandum is attached and incorporated in this Resolution, certifies that the need for the five replacement air conditioning condensing units has arisen notwithstanding a good faith effort on the part of the Township to plan for this purchase through the advertisement for bids and through a search for applicable State contracts; that no bids were received and no State contracts are available for this purchase; that there was not adequate time to rebid and to have the units installed during the current summer season; that a properly functioning air conditioning system in the Senior Center is vital to the health and safety of the staff and citizens working in and utilizing the Senior Center; and that the contract is limited to meet the immediate needs of the emergency; and

WHEREAS, a cost proposal for the emergency work was submitted by SG Heating and Air Conditioning, LLC; and

WHEREAS, the maximum amount of the purchase is \$98,874.00 and funds are available in Capital Fund Account No. C-04-55-980-925-950 entitled Ordinance 2020-09 "Senior Center Expansion Project" in the amount of \$98,874.00, as evidenced by the Chief Financial Officer's Certification No. C2023-016.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Manager and Chief Finance Officer are hereby authorized and directed to approve and forward a purchase order to SG Heating and Air Conditioning, 50 Cunningham Avenue, Hamilton NJ 08610, for the purchase and installation of five replacement air conditioning condenser units and the conversion of freon, for a total amount not to exceed \$98,874.00, all in accordance with the attached quote.

It was MOVED by Katawick, SECONDED by Lippman to approve Resolution R2023-126, on the condition the work will be done this summer and confirmation of the funding source.

ORDINANCE – INTRODUCTION:

Ordinance No. 2023-10

An Ordinance Amending and Supplementing Chapter VI, "Licensing," Section 6-2 "Itinerant Sales Person," and Adding a New Subsection 6-2.11, "Do Not Solicit List," of the Revised General Ordinances of the Township of East Windsor

ORDINANCE NO. 2023-10 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VI, "LICENSING," SECTION 6-2 "ITINERANT SALES PERSON," AND ADDING A NEW SUBSECTION 6-2.11, "DO NOT SOLICIT LIST," OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR

WHEREAS, the existing licensing regulations of the Township of East Windsor as pertains to itinerant sales people are set forth in Chapter VI, entitled "Licensing," of the Revised General Ordinances of the Township of East Windsor; and

WHEREAS, the Mayor and Council desire to make certain revisions thereto relating to a resident's right to privacy and quiet as pertains to itinerant sales people.

NOW THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR, in the County of Mercer and the State of New Jersey, Chapter VI, "Licensing," Section 6-2 "Itinerant Sales Person," is amended and supplemented, as follows:

SECTION 1. Subsection 6-2.11, "Do Not Solicit List," is added as follows:

6-2.11 Do Not Solicit List

- A. All residents of the Township of East Windsor may register their name and address with the Municipal Clerk together with a request to be placed on the "Do Not Solicit" list to be maintained by the Township. This list shall register residents who do not wish to be approached at their residence or within the perimeter of their property by any itinerant sales person without exception.
- B. All residents who have registered on the "Do Not Solicit" list may obtain from the Municipal Clerk at no charge a sticker for display on their property warning that the property is on the "Do Not Solicit" list. Display of a sticker is not required for enforcement of the "Do Not Solicit" ban.
- C. It shall be unlawful for an itinerant sales person to approach or seek personal contact with the occupant of the residence either at the residence or within the perimeter of the property if the residence is registered on applicable "Do Not Solicit" list. All nonprofit, religious, or political groups canvasing exclusively door-to-door shall be exempt from the prohibitions of this section.
- D. All itinerant sales people shall be required to obtain the most current applicable "Do Not Solicit" list from the Municipal Clerk when acquiring their license to operate.
- E. Violation of this Ordinance shall be a \$100 fine and revocation of the license to operate in the Township. Revocation of the license shall be applicable to the company to which the license is issued and includes all employees working for the company.
- F. Residents shall remain on the "Do Not Solicit" list until resident requests to be removed or resident moves from the registered address.
- G. The Municipal Clerk shall maintain the "Do Not Solicit" list and provide a current copy to all who receive a license as an itinerant sales person. The Municipal Clerk shall thereafter provide these individuals with updated copies of the lists upon request.
- H. This Ordinance shall not be applicable to nonprofit and/or political groups.
- I. The Police Department shall be responsible for the enforcement of this Ordinance and the Municipal Clerk shall forward copies of the lists and list updates to the Chief of Police for enforcement purposes.

SECTION 2. Repealer. All ordinances or resolutions or parts thereof inconsistent with this ordinance are repealed to the extent of such inconsistency.

SECTION 3. Severability. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. Effective Date. This Ordinance shall take effect upon final adoption, publication as required by law.

It was MOVED by Russell, SECONDED by Lippman to approve Ordinance 2023-10 on introduction, authorize publication as required by law, and set public hearing for August 8, 2023.

Finance provided a full accounting of funds for the Senior Center expansion. Mayor Mironov asked what funds were appropriated but not expended and if all grant monies were received.
