ORDINANCE NO. 2023-10 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VI, "LICENSING," SECTION 6-2 "ITINERANT SALES PERSON," AND ADDING A NEW SUBSECTION 6-2.11, "DO NOT SOLICIT LIST," OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR

WHEREAS, the existing licensing regulations of the Township of East Windsor as pertains to itinerant sales people are set forth in Chapter VI, entitled "Licensing," of the Revised General Ordinances of the Township of East Windsor; and

WHEREAS, the Mayor and Council desire to make certain revisions thereto relating to a resident's right to privacy and quiet as pertains to itinerant sales people.

NOW THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR, in the County of Mercer and the State of New Jersey, Chapter VI, "Licensing," Section 6-2 "Itinerant Sales Person," is amended and supplemented, as follows:

SECTION 1. Subsection 6-2.11, "Do Not Solicit List," is added as follows:

- 6-2.11 Do Not Solicit List
- A. All residents of the Township of East Windsor may register their name and address with the Municipal Clerk together with a request to be placed on the "Do Not Solicit" list to be maintained by the Township. This list shall register residents who do not wish to be approached at their residence or within the perimeter of their property by any itinerant sales person without exception.
- B. All residents who have registered on the "Do Not Solicit" list may obtain from the Municipal Clerk at no charge a sticker for display on their property warning that the property is on the "Do Not Solicit" list. Display of a sticker is not required for enforcement of the "Do Not Solicit" ban.
- C. It shall be unlawful for an itinerant sales person to approach or seek personal contact with the occupant of the residence either at the residence or within the perimeter of the property if the residence is registered on applicable "Do Not Solicit" list. All nonprofit, religious, or political groups canvasing exclusively door-to-door shall be exempt from the prohibitions of this section.
- D. All itinerant sales people shall be required to obtain the most current applicable "Do Not Solicit" list from the Municipal Clerk when acquiring their license to operate.
- E. Violation of this Ordinance shall be a \$100 fine and revocation of the license to operate in the Township. Revocation of the license shall be applicable to the company to which the license is issued and includes all employees working for the company.
- F. Residents shall remain on the "Do Not Solicit" list until resident requests to be removed or resident moves from the registered address.
- G. The Municipal Clerk shall maintain the "Do Not Solicit" list and provide a current copy to all who receive a license as an itinerant sales person. The Municipal Clerk shall thereafter provide these individuals with updated copies of the lists upon request.
- H. This Ordinance shall not be applicable to nonprofit and/or political groups.
- I. The Police Department shall be responsible for the enforcement of this Ordinance and the Municipal Clerk shall forward copies of the lists and list updates to the Chief of Police for enforcement purposes.

SECTION 2. Repealer. All ordinances or resolutions or parts thereof inconsistent with this ordinance are repealed to the extent of such inconsistency.

SECTION 3. Severability. If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

<u>SECTION 4.</u> Effective Date. This Ordinance shall take effect upon final adoption, publication as required by law.

Mayor Mironov stated Ordinance 2023-10 was introduced on July 25 and the public hearing was set for this evening. She opened the public hearing on Ordinance 2023-10. There being no comment by the public, Mayor Mironov declared the public hearing closed.

WHEREAS, Community Investment Strategies, Inc. the developers of East Windsor Township owned property located at 300-C Princeton Hightstown Road, East Windsor, New Jersey, Block 5, Lot 2.02 as shown on the official tax map of the Township of East Windsor, by Resolution No. 2019-12, adopted on April 15, 2019 by the Township Planning Board, received Preliminary and Final Major Site Plan approval for a 100% affordable 56 unit residential development called The Place at East Windsor; and

WHEREAS, Community Investment Strategies, Inc., has applied to the East Windsor Municipal Utilities Authority for the necessary approvals for this project, and as part of that approvals process, the developer must apply for a Treatment Works Approval Permit from the New Jersey Department of Environmental Protection; and

WHEREAS, the permit application forms require review and signature by the Township as the property owner.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Treatment Works Approval Application Form as required by the New Jersey Department of Environmental Protection.

Mayor Mironov requested the Resolution be revised to include information regarding the Planning Board approval for the project, as well as previous Council action.

It was MOVED by Zoller, SECONDED by Katawick to approve Resolution R2023-135 with revisions.

APPLICATIONS:

There were no applications.

REPORTS BY COUNCIL AND STAFF:

Mr. Zoller reported the Planning Board met on August 7 and swore in new Class II Member Michael Trivisonno and Class IV Member Joseph Miczak. The Board heard testimony on a proposed project by QTS Data Centers for the facility on Princeton-Hightstown Road. Mr. Zoller also reported the Environmental Commission participated in National Night Out on August 1 and gave away 200 Township reusable shopping bags and flyers regarding recycling programs and volunteer opportunities.

Mayor Mironov reported National Night Out was held on August 1 and thanked Public Works, the Police Department, and all volunteers and businesses who participated in the event.

CORRESPONDENCE:

Mayor Mironov stated she would review correspondence during Matters by Council.

APPOINTMENTS:

Mayor Mironov requested the Clerk's Office provide a listing of any individuals who were interviewed for volunteer positions that were not yet appointed to a board or committee.

APPROVAL OF BILLS:

Mayor Mironov stated a 2023 Current Bill list, 2022 Current Bill list, a Capital Bill List and other miscellaneous bill lists and trust accounts were provided.

Mayor Mironov asked if the invoices on the Current 2023 bills list under Data Processing were additional payments. Mr. Brady stated they were, and he would be following up for insurance reimbursement on these invoices. She also asked for information on the invoices on page seven under Other Contractual Services – Police Building.

It was MOVED by Daniels, SECONDED by Zoller to approve the Bill lists with the requested clarifications.

There being six (6) ayes, no (0) nays, and one (1) abstention, the various presented Bill lists were approved with the requested clarifications.

MATTERS BY COUNCIL:

Mayor Mironov reported the following correspondence had been received: a memo from Engineering regarding a road closure for 330 Wyckoff Mills Road; a report of disbursements and receipts from the Court; a memo dated June 29 regarding the closing of Dutch Neck Road for the East Windsor Municipal Utilities Authority; a memo from the Tax Collector regarding the status of the tax bills, as the Township is still waiting for Mercer County to adopt their budget and certify their tax rate; a memo from the Recreation Department dated July 26 regarding an open mic night event.

Mayor Mironov stated the September 11 memorial service would be held on Monday, September 11 at 5 PM and requested an update on the program from the Police Chief. She also stated a Passport Service Day with the County Clerk would be upcoming and a date would be determined shortly.

Mayor Mironov requested information regarding interfund transfers and if any grants are remaining. Mayor Mironov asked for an update on the Stockton Street paving and curbing project and the issue that was previously raised about parking on Stockton Street. She requested staff evaluate any deadlines and provide a proposed budget for the \$74,000 in American Rescue Plan funds incoming from Mercer County. She also stated she returned memos to Finance regarding several Chapter 159 requests for the capital budget and tonnage grants.

Mayor Mironov stated the Request for Proposals for Engineering Services for both Beechcroft Drive and Greenbrook Drive had been posted. She requested the awarding Resolutions be listed on the September 12 agenda.

Mayor Mironov stated she has continued to be in contact with JCP&L regarding the ongoing outage issues in town.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Township Senior Center Air Conditioning Status and Funding Update

Mayor Mironov requested an update on the status of the equipment and funding. Mr. Brady stated the contractor is working on getting the units in order to complete the installation. The contractor has also been in contact with JCP&L to get the project qualified for funding.

- 2. Township Park and Recreation Improvements
 - a. Anker Park
 - i. New Playground Equipment Installation Status/Date/Funding
 - ii. Walking Pathway Restoration Status
 - iii. Rubber Play Surface
 - **Resolution R2023-XXX** Action on Purchase of Play Surface for Anker Park

Mr. Brady stated the new play equipment had arrived, but due to the recent rainy conditions, the ground is too wet to complete the installation at this time. Once the weather has been clear for three days, the installation will take place. Public Works has continued to work on the pathway restoration project, and should be completed by the end of next week.

Mayor and Council discussed the possible rubberized play surface for Anker Park after reviewing the additional information provided by Public Works. Mr. Lippman asked for more information as to how the surface is installed. Ms. Daniels asked if this product has any issues with color fading, and if certain color options have a better longevity than others. Mayor Mironov requested staff reach out to other municipalities who have this rubberized play surface and get their input on their experience with the product. Mr. Zoller stated that quote from the vendor mentions some issues in high temperatures and asked for more information.

- b. Westfield Park

Mr. Brady stated that he is awaiting an updated quote for the repair of the tennis courts in Westfield Park. Mayor Mironov stated the bridge in Wiltshire Park is closed for repairs and asked for a status update, as that should be repaired as soon as possible.

> New Jersey Unclaimed Property Resolution R2023-136 Authorizing Acceptance of Unclaimed Property from State of New Jersey Unclaimed Property Administration

RESOLUTION R2023-136 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, the State of New Jersey Unclaimed Property Administration (UPA) is in possession of eleven pieces of unclaimed property belonging to the Township of East Windsor; and

WHEREAS, Mayor and Council desire to reclaim these unclaimed properties from the UPA for the benefit of the Township and its residents; and

WHEREAS, the UPA does not disclose the nature or characteristics of unclaimed property prior to unclaimed property release authorization, but only identifies the unclaimed properties with the following property identification numbers: 32741317, 20617975, 22181302, 22181310, 28202664, 19791677, 19846710, 22309574, 20756384, 31982964, 16856907; and

WHEREAS, the UPA will only authorize release of the unclaimed properties to the Township if Mayor and Council pass a Resolution naming and authorizing a Township employee to act on the Township's behalf to reclaim these properties, the authorized individual submits an electronic claim for each of the properties on UPA's website, and the authorized employee provides identification and the Resolution to the UPA upon request to confirm identity and authorization.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, hereby authorizes Omar Buckingham, an employee of the Township of East Windsor, to submit electronic claims for each of the eleven unclaimed properties identified above and currently in the UPA's care for the purpose of reclaiming and returning these properties to the Township of East Windsor.

Mr. Lippman asked for more information as to what these properties are. Mayor Mironov stated that until Council authorizes and employee as the designee by Resolution to reclaim the properties, specific information as to what they are isn't available, but generally they may be unclaimed funds.

Mayor Mironov requested the Resolution be revised to reflect the Assistant Township Manager Omar Buckingham as the Township's designee.

It was MOVED by Russell, SECONDED by Katawick to approve Resolution R2023-136 with revisions.

There being six (6) ayes, no (0) nays, and one (1) abstentions, Resolution R2023-136 was approved with revisions.

4. 2022/2023 Municipal Capital Budget

Mayor and Council reviewed the information provided by the Township Manager as to the proposed Capital Budget for 2022 and 2023. Mayor Mironov requested an account run for the Annual Road Program to see the amounts allocated for the Greenbrook Drive project. She also requested Public Works provide more information on the proposed water treatment system for the Police/Court building as to how this will avoid further costs and if the system was examined for any other issues.

Under Public Works, information was requested for the basis of the cost of the proposed seven cubic yard dump truck and mechanic service truck.

Under Police Department, information regarding the Animal Control Officer's vehicle be provided including lead time, current vehicle issues, and how this may factor in shared service agreements for animal control services. Regarding the body worn cameras, Mayor Mironov stated that these were mandated by the State and therefor the State should pay for this equipment. She requested a thorough search for any grants and communications with the State, the League of Municipalities, and other towns for funding options before expending these funds. Regarding the traffic survey device, additional information was requested regarding the usage of the equipment and justification for the proposed purchase.

Under General Administration, information was requested regarding the original cost for the Mitchell Humphries program used by the Construction Department, and how transitioning between the two systems will work, what is the life of the system and will there by any regular annual budget costs added for the new system. For the email migration project, Mayor and Council requested the actual cost that was expended. For the replacement copiers, it was requested to use Health grant funding if possible, and what is the breakdown of costs between the two machines. Several grants need to be added to the Capital Budget, including a \$950,000 award for Beechcroft Drive, the Airport Road Bikeway Connector grant, and the \$1.5 million dollar grant award for park improvements.

Mayor Mironov requested the Ordinance be listed for introduction on the September 12 agenda.

5. New Jersey Board of Public Utilities Community Energy Planning Grant

Mayor Mironov requested this item be listed on the next agenda, and asked for information as to how the Township receives the funds, what can the funds be used for, and what are the reporting requirements.

6. East Windsor Police Athletic League Executive Director, Status

Mr. Brady stated he would provide an update on this subject.

MATTERS BY PUBLIC:

Craig Pollins, 3 Lexington Court, spoke on the ongoing JCP&L outages. Jim Williams, 45 Moorsgate Circle, also spoke on the JCP&L outages.

Linda Caffrey, 60 One Mile Road, thanked Council for addressing the parks. She raised the issue of parking along Stockton Street.

James Cole, 357 Bolton Road, spoke regarding the air conditioning and wi-fi in the Senior Center.
