SPECIAL ZOOM MEETING

CALL TO ORDER:

The Special Meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 5:30 p.m. on Tuesday, July 16, 2024.

VERIFICATION:

Deputy Municipal Clerk Niven Raghieb certified that the Special Meeting was noticed on June 20, 2024. Notices were sent to the Trenton Times, filed in the office of the Municipal Clerk and posted in the East Windsor Municipal Building. All requirements of the open public meeting act have been satisfied.

Present were Council Members Denise Daniels, Anthony Katawick, Marc Lippman, David Russell, Johnnie Whittington, John Zoller and Mayor Janice Mironov. Also present were Township Attorney David Orron, Township Manager Joy Tozzi and Deputy Municipal Clerk Niven Raghieb.

RESOLUTIONS:

Resolution R2024-078 Adoption of the 2024 Municipal Budget
