Resolution R2025-154 Approval of Professional Services Agreement for Medical Director with Stephen Vetrano, DO

RESOLUTION R2025-154 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, as per N.J.S.A. 8:52-4.1, the Township is in need of a Medical Director to oversee the Township's Health Department COVID-19 clinics; and

WHEREAS, pursuant to N.J.A.C. 8:52-4.1, the Township is in need of a Medical Director to oversee the Township Health Department childhood vaccination program; and

WHEREAS, Stephen J. Vetrano as a qualified physician for nearly 25 years and is Board Certified in Emergency Medicine working for numerous municipalities as Medical Director including East Windsor Rescue Squad District I and St. Francis Medical Center; and

WHEREAS, Dr. Vetrano is willing to provide Medical Director services to oversee the Township's Health Department childhood vaccination program and COVID-19 clinics for \$500 per year each, bringing the total contract amount to \$1,000 per year; and

WHEREAS, a contract for this professional service may be awarded without public advertising for bids as the contract is for "Professional Services" pursuant to N.J.S.A. 40A:11-5(1)(a)(i); and

WHEREAS, the maximum amount of the contract is \$1,000 and funds are available in the Grant Account No. G-02-40-950-979-299 as evidenced by the Chief Financial Officer's Certification No. B2025-07.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. Stephen J. Vetrano is hereby appointed as the Medical Director for the Township of East Windsor.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Agreement with Stephen J. Vetrano, DO of Physicians Practice Enhancement LLC Emergency Medicine, 601 Hamilton Avenue, Trenton, NJ 08629, in an amount not to exceed \$1000, for the term of October 1, 2025 through September 30, 2026.
- 3. This Contract is awarded without competitive bidding in accordance with N.J.S.A. 40A:11-5 (1)(a) of the Local Public Contracts Law because the contract is for service performed by persons authorized by law to practice a recognized profession that is required by law.
- 4. The Municipal Clerk shall cause to be printed once, in the Trenton Times, a brief notice stating the nature, duration, service and amount of this contract, and that the resolution and contract are on file and available for public inspection in the office of the Municipal Clerk.

RESOLUTION R2025-155 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, there is a need to purchase four portable radios for the Fire Prevention Bureau and the Construction Department; and

WHEREAS, three written quotes were solicited and obtained for this purchase, and the lowest cost proposal was submitted by WEJConsulting, LLC; and

WHEREAS, the Township Council has reviewed the Township Director of Inspection's recommendation on this purchase; and

WHEREAS, since the purchase is under \$17,500, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500; and

WHEREAS, the maximum amount of the purchase is \$17,499 and funds are available in Trust Account T-13-56-857-812, entitled "Uniform Fire Safety Act 212 Penalty," in the amount of \$13,875 and in Trust Account T-13-56-857-813, entitled "Uniform Fire Safety Act 212A Penalty," in the amount of \$3,624, as evidenced by the Chief Financial Officer's Certification No. T2025-004.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to WEJConsulting, LLC, 675 Columbus Circle, Perth Amboy, NJ 08861, for the purchase of four Motorola APX 8000HXE Portable Radios in the amount of \$4,374.75 each, for a total amount not to exceed \$17,499, as per the attached quote.

WHEREAS, since the purchase is under \$17,500, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500; and

WHEREAS, the maximum amount of the purchase is \$4,825.90 and funds are available in Capital Account C-04-55-980-927-400, entitled "General Building Repairs," as evidenced by the Chief Financial Officer's Certification No. C2025-024.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Manager and Chief Financial Officer are hereby authorized and directed to approve and forward a purchase requisition to Assa Abloy Entrance Systems US, Inc., 2522 Pearl Buck Road, Bristol, PA 19007, for the repair of the sliding glass doors at the Municipal Building, for a total amount not to exceed \$4,825.90p, as per the attached quote.

Mayor Mironov stated the memo from Public Works on this subject was missing information, and would suggest only acting on this Resolution conditionally based upon receiving the following information: how was this vendor chosen; is this a reasonable cost; what occurred that caused the need for a repair?

Resolution R2025-158 Approval of Assignment of Developer's Agreement to Bank of America for 417 Route 130 (Block 56, Lot 25)

RESOLUTION R2025-158 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, by Resolution R2023-161, adopted on October 17, 2023, the Township Council authorized the execution of a Developer's Agreement between the Township and East Windsor Construction LLC, the owner of property located at 417 Route 130, East Windsor, New Jersey, designated on the official tax map of the Township as Block 56, Lot 25 ("the Property"); and

WHEREAS, East Windsor Construction, LLC has contracted to sell the Property to 417 Route 130 Owner, LLC and wishes to assign the Developer's Agreement to the buyer; and

WHEREAS, under the terms of paragraph 25 of the Developer's Agreement, the assignment requires the written consent of the Township.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The Township hereby consents to the assignment of the Developer's Agreement for the Property at 417 Route 130 (Block 56, Lot 25) from East Windsor Construction, LLC, with offices at 22 Lake Shore Drive, Sparta, NJ 07871, to 417 Route 130 Owner, LLC, with offices at 349 East 149th Street, Bronx, NY 10451.
- 2. The Mayor and Municipal Clerk are authorized and directed to execute the attached Assignment of Developer's Agreement.

REPORTS BY COUNCIL AND STAFF

Mr. Zoller reported the Planning Board met on August 25 and approved Kimco's application for a Sprouts Market in the former Kohl's in the Target shopping center. He also reported he attended a meeting of the Mercer County Electric Vehicle Readiness Committee, where they reviewed proposed objectives and introductory information.

Mr. Miczak reported the Health Advisory Board met on August 21 and discussed the community garden and 2025 meeting dates. Mayor Mironov asked to see goals and projects the Health Advisory Board is working on.

Mr. Whittington reported the Recreation Commission has received great feedback on the summer camp programs this year and Family Night in the Park and the summer concert series was well received. He announced Acoustic Night sign ups start September 18.

CORRESPONDENCE:

Mayor Mironov stated she would review correspondence during Matters by Council.

APPOINTMENTS:

There were no appointments.

APPROVAL OF BILLS:

Mayor Mironov stated a 2024 Current Bill list, 2025 Current Bill list, a Capital Bill List and other miscellaneous bill lists, and trust accounts were provided.

Mayor Mironov raised the annual invoice for dues for the New Jersey Conference of Mayors, and asked that always be taken care of as soon as the invoice is received each year.

Mr. Zoller questioned the amount of the electric bill for the Rescue II building and asked the Manager's Office to look into the matter. He also asked why playground equipment

is listed on the capital bills list if being paid through the grant. Mr. Frueh stated the grant funds were incorporated as part of a capital Ordinance.

It was MOVED by Zoller, SECONDED by Katawick to approve the various Bills lists with the requested clarifications.

Mayor Mironov reported the receipt of the following correspondence: a memo from Public Works regarding the heavy duty pickup truck purchase; a memo from Public Works regarding Hickory Corner Road sidewalk repairs; a memo from the Assistant Township Manager regarding the status of the New Jersey Transit grants; a letter from Hightstown regarding the release of escrow funds for the Stockton Street sidewalk and curbing project; a letter from RISE saying thank you for support, and a flyer from RISE for the opening of their new food pantry/

RESOLUTION R2025-161 EAST WINDSOR TOWNSHIP MERCER COUNTY RESOLUTION AUTHORIZING THE ISSUANCE OF A REQUEST FOR PROPOSALS FOR THE ISSUANCE OF ONE CLASS 5 RETAIL CANNABIS LICENSE

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor as follows:

- 2. The Mayor and Municipal Clerk are hereby authorized and directed to issue the attached Request for Proposals for the issuance of one Class 5 retail cannabis license in accordance with its terms.
- 3. Proposals shall be submitted by 12 noon, prevailing time, on Thursday, October 23, 2025, to be considered as provided in the attached Request for Proposals.
