EAST WINDSOR TOWNSHIP COUNCIL

Tuesday, July 9, 2024 5:30 p.m. MINUTES

CALL TO ORDER:

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 5:40 p.m. on Tuesday, July 9, 2024, at the East Windsor Municipal Building.

VERIFICATION:

Deputy Municipal Clerk Niven Raghib certified that the meeting was noticed on July 3, 2024. Notices were sent to the Trenton Times, filed in the office of the Municipal Clerk and posted in the East Windsor Municipal Building. All requirements of the Open Public Meeting Act have been satisfied.

FLAG SALUTE: Led by Council Member Johnnie Whittington.

ROLL CALL:

Present were Council Members Denise Daniels, Marc Lippman, David Russell, Johnnie Whittington, John Zoller and Mayor Janice S. Mironov. Council Member Anthony Katawick was absent. Also present were Township Attorney Orron, Township Manager Joy Tozzi and Deputy Municipal Clerk Niven Raghib.

PRESENTATIONS & PROCLAMATIONS

National Night Out (August 6, 2024)

Mayor Mironov announced that East Windsor Township again will join with communities throughout the United States and Canada to participate in "National Night Out". The Township event, sponsored by Mayor Mironov and Council Members in conjunction with Chief of Police Hart and the East Windsor Police Department, will take place on Tuesday, August 6th from 5:30 P.M. to 8:30 P.M. at the East Windsor P.A.L. Facility at 30 Airport Road.

Mayor Mironov stated, "East Windsor Township is committed to strengthening neighborhood unity and police and community partnerships to help deter crime and to enhance our local quality of life. The Township has participated in hosting 'National Night Out' for many years, during which thousands of citizens have been provided with information on crime prevention and community partnerships."

This year's East Windsor Township National Night Out event, which has much to interest adults and children, will feature activities including police vehicle tours, demonstrations by canines trained in detecting illegal drugs, child car safety seat inspections, fire and EMS equipment

displays, a climbing obstacle course, DJ provided music and entertainment, and many other activities. Refreshments will also be available at the event.

Mayor Mironov further stated, "we are pleased to be a part of this national effort which provides an opportunity to enhance positive relationships between our citizens and local government. I encourage all East Windsor residents to stop by and join with us in this fun and positive evening of fellowship and activities."

ORDINANCE – PUBLIC HEARING:

Ordinance No. 2024-08

An Ordinance Amending Chapter XX, 'Zoning," for the Addition of New Conditional Use in the TC Turnpike Commercial District to Permit a Self-Storage Facility use of the Revised General Ordinances of the Township of East Windsor

ORDINANCE NO. 2024-08 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AMENDING CHAPTER XX, "ZONING", SECTION 20-17, "TC TURNPIKE COMMERCIAL", SUBSECTION 20-17.3, "CONDITIONAL USES", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR BY THE ADDITION OF A NEW CONDITIONAL USE WITH CRITERIA IN THE TC TURNPIKE COMMERCIAL ZONE TO CONDITIONALLY PERMIT SELF-STORAGE FACILITIES IN THE TC TURNPIKE COMMERCIAL ZONE.

WHEREAS, the Township Council has reviewed the purpose of the TC Turnpike Commercial Zone and has evaluated the Township's Land Use Plan; and

WHEREAS, the Township Council, in consideration of the TC Turnpike Commercial Zone's proximity to the regional roadway corridors, finds that this area represents a unique location where specific types of commercial storage facilities, with appropriate setbacks, coverage and buffer requirements, would present an appropriate use compatible in size and scale with the surroundings and other permitted uses in that zone;

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey as follows:

<u>Section 1.</u> Chapter XX, "Zoning", Section 20-17, "TC Turnpike Commercial", subsection 20-17.3, "Conditional Uses", is amended by adding a new subparagraph (c.) as follows:

- c. Self-storage facilities in accordance with the following specific zoning conditions and standards.
 - 1. Self-storage facilities shall be on a lot of minimally 65,000 square feet.
 - 2. The maximum height of a self-storage facility shall be 35 feet for a flat-roof building and 40 feet for a pitched roof building.
 - 3. The minimum frontage requirement shall be 200 feet.
 - 4. Storage facilities shall be contained within a single principal building.
 - 5. The only activities permitted in individual storage units shall be the rental of the unit and the pickup and deposit of goods and/or property in dead storage. Storage units shall not be used for the following activities:
 - (a) Residences, offices, workshops, studios, or hobby or rehearsal areas.
 - (b) Manufacturing, fabrication, or processing of goods; service or repair of vehicles, engines, appliances, or other electrical equipment; or any other similar

- activities. Storage of internal combustion engines or motor vehicles.
- (c) Conducting retail sales of any kind, including garage or estate sales or auctions, or any other commercial activity; provided that the operator of the self-storage unit may conduct a sale or otherwise liquidate the contents of any storage unit to satisfy and settle an account of unpaid rent or other charges, through public or private sales, in a manner provided by law.
- (d) Storage of flammable, perishable, or hazardous materials or the keeping of animals.
- (e) The rental of trucks, trailers, or moving equipment, as well as the installation of trailer hitches.
- 6. Self-storage facilities shall not operate or allow tenant access between the hours of 12:00 midnight and 6:00 a.m.
- 7. Electrical service to storage units shall be for lighting and climate control only. No electrical outlets are permitted inside individual storage units. Lighting fixtures and switches shall be of a secure design that will not allow tapping such fixtures for other purposes.
- 8. Sale of boxes or packing materials shall be permitted, but only if accessory to the self-storage facility.
- 9. All goods and property in a self-storage facility shall be stored in an enclosed building. No outdoor storage of any kind, including but not limited to storage of boats, RVs, vehicles, trailers or similar vehicles, or storage in outdoor storage pods or shipping containers, shall be permitted.
- 10. All storage units above grade and all storage units visible from residential areas shall gain access from the interior of the building(s) only; no unit doors, loading bays, or docks may face or be visible from any adjacent residential areas. No windows shall be provided on the sides of the buildings facing residential uses. All building facades shall have building materials and design consistent with the front building façade.

<u>Section 2.</u> Chapter XX, "Zoning", Section 20-3, "Definitions", is hereby amended by adding the following definition:

SELF-STORAGE FACILITY: A building in single ownership containing separate spaces or compartments for dead storage of goods, wares, and equipment and leased or rented on an individual basis.

<u>Section 3.</u> <u>Repealer.</u> All ordinances and resolutions or parts thereof inconsistent with this ordinance are repealed.

<u>Section 4. Severability.</u> If any paragraph, section, subsection, sentence, sentence clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court or administrative agency of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision of such holding shall not affect the validity of the remaining paragraphs or sections hereof.

<u>Section 5.</u> Effective Date. This Ordinance shall take effect upon its passage, publication, and filing with the Mercer County Planning Board, and as provided for by law.

Mayor Mironov stated the Ordinance was introduced at the June 18, 2024, meeting and the Public Hearing was set for tonight. Mayor Mironov declared the public hearing open on Ordinance 2024-08.

Hopkins, 28 Woodside Avenue, concerned about setbacks.

Mayor Mironov declared the public hearing closed.

It was MOVED by Lippman, SECONDED by Zoller to adopt Ordinance 2024-08 and authorize publication as required by law.

An Ordinance Amending and Supplementing Chapter VI, "Licensing," Section 6-8 "Hotels, Motels Boarding Houses and Rooming Houses," by Adding a New Subsection 6-8.7, "Duration of Stay," to the Revised General Ordinances of the Township of East Windsor

ORDINANCE NO. 2024-09 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VI, "LICENSING," SECTION 6-8 "HOTELS, MOTELS BOARDING HOUSES AND ROOMING HOUSES" BY ADDING A NEW SUBSECTION 6-8.7 "DURATION OF STAY" TO THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR

WHEREAS, the Township Council finds and determines that it is necessary to limit the duration of stays at hotels and motels, in order to control vice, public disturbances, narcotics offenses, to protect the general public and to maintain public health, safety and good order in the Township; and

WHEREAS, pursuant to N.J.S.A. 40:52-1(d), the Township is authorized to make, amend, repeal and enforce ordinances to license and regulate hotels and motels; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Township is authorized to enact such ordinances as deemed necessary and proper for the good government, order and protection of persons and property, and for the preservation of the public health, safety and welfare of the Township and its inhabitants;

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey as follows:

I

1. Chapter VI, Section 6-8 of the Revised General Ordinances of the Township of East Windsor is amended by adding a new subsection 6-8.7 to read as follows:

6-8.7 Duration of Stay.

- a. With the exception of the owner and any staff, who are permitted to reside at the premises, no person may occupy a hotel or motel for longer than fourteen (14) days, and such person may not extend this time period by moving to another unit within the same establishment.
- b. No room within a hotel or motel shall be offered for occupancy for less than one full day.

II REPEAL

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

Mayor Mironov stated the Ordinance was introduced at the June 18, 2024, meeting and the Public Hearing was set for tonight. Mayor Mironov declared the public hearing open on Ordinance 2024-09.

David Crantz Cors, 7418 Paxton Road, Virginia, Regional Manager, objects to the Ordinance and will try to help the community. He noted that the property is not an apartment building and there are a lot of short-term housing contracts in the area. This Ordinance will create a big financial impact to the property.

Desai, 460 Route 33, Manager of the Windsor Hotel, spoke on concerns with the Ordinance.

Gloria Szymanski, 33 Woodside Avenue, indicated that the neighborhood is invaded by people staying at the Windsor Hotel and that a fence should be installed. There are drug addicts coming from the hotel making the neighborhood dangerous and that the children in the area need to be protected. Ms. Domanski noted that the Windsor Hotel needs to ensure the neighborhood is protected.

Jackson, (Windsor Hotel Guest), noted that everyone who is staying at the Windsor Hotel should not be judged. It's very hard to find housing staff and apologies for others staying at the Hotel.

Krakowski, 400 Monmouth Street, indicated that there should be rules on who can and can't stay at the hotel. People at the front desk do not call the police when there are issues. There are really good people staying at the hotel and a few bad people make it bad for others.

Hopkins, 25 Woodside Avenue, noted that there should be limits on the length of stay. This is the first time she has experienced this type of situation and is in favor of the Ordinance.

Kevin Franklin, (*Windsor Hotel Guest*), stays at the hotel and is concerned about the people who are living there. The proposed Ordinance is not fair for people struggling and good people

are impacted by those who are bad. The hotel is a good place to make someone get a fresh start.

Mayor Mironov declared the public hearing closed.

It was MOVED by Lippman, SECONDED by Whittington to adopt Ordinance 2024-09 and authorize publication as required by law.

WHEREAS, the "We Check for 21" Program is an excellent vehicle to bring together municipal government leaders, young people, parents, key community and school leaders, policy makers and local businesses toward a common positive community effort.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, does hereby require that as a

condition of the issuance or renewal of any Township Alcoholic Beverage Control Licenses the Licensee must sign the "We Check for 21" Pledge to prevent underage drinking.

RESOLUTION R2024-110 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, a Notice to Bidders was issued and posted/advertised on June 28, 2024 for Public Transportation Services and on July 9, 2024, two bids were received; and

WHEREAS, the lowest priced responsible bid was received from The Arc Mercer, 180 Ewingville Road, Ewing, NJ 08638, in the amount of \$9,034.58 per month for a total of \$99,380.38 for the first contract term and \$332,743.66 for the total contract price; and

WHEREAS, the Township Council has reviewed the recommendations made by the Assistant Township Manager on the bid; and

WHEREAS, the total cost of the bid for the first eleven month term of the contract, August 1, 2024 through June 30, 2025, is \$9,034.58 per month for a total price of \$99,380.38 for the first eleven months, with the option for the Township to renew the contract at its sole discretion for each of the two additional option years, and funds are available for the first term of the contract in the Grant Fund Account No. G-02-40-732-955-299 entitled "2024/2025 NJ Transit Grant" in the amount of \$99,380.38, contingent upon the approval of the FY2024 grant agreement and receipt of funds from NJ Transit, as evidenced by the Chief Financial Officer's Certification No. G2024-006.
